The Railroad Survey. From the Coast Mail. Orders have been sent out to the surveying party in the field for the Great Central Railway for the setting of permanent stakes between Myrtle Point and Roseburg. H. D. Jerritt, the assistant general engineer of the party, is in charge of operations. The work is progressing at a satisfactory pace, and it is stated that the setting of stakes will proceed without interruption through the mountains until a surveying party for the Salt Lake end of the line is met.

A gang of surveyors left here Friday for Myrtle Point to join those already in the field. They will work on the projected Great Central railroad survey between Roseburg and Myrtle Point, beginning at the latter place and making permanent surveys and staking the roadbed until they meet with a gang of surveyors from the East end.

Denials have been sent out that the Chicago, Milwaukee & St. Paul road intends to buy a road to the Pacific Coast. The directors held their annual meeting Saturday, and by their action put a quietus on talk that the C. M. & St. P. wanted the Clark road.

The Railroad Assured. From the Roseburg Review. Late this afternoon an option was closed on the Bushey farm adjoining this city for depot grounds for the Salt Lake and Coos Bay railroad. Definite announcements as to the beginning of operations are expected soon. This is deemed as largely deciding the matter as to the road being built to Roseburg.

Important News Notes

TUESDAY SEPT 30 The coal strike has brought the price of coal up to \$21 a ton in New York. President Roosevelt is trying to end the strike.

A train of twelve loaded cars went through a bridge at Newton, Iowa, into Skunk river. Three tramps were killed.

Two men were drowned at Astoria in descending from the British ship Anastasia. The crew of the Norwegian bark Bothnia were rescued in an exhausted condition after 17 days work at the pumps. The vessel was sinking.

The corner in wheat has raised the price to 95 cents at Chicago and the shorts in the gambling game are getting fleeced.

The rebels of Acre, South America, have proclaimed their independence and declared war against Bolivia.

WEDNESDAY Oct 1 The number of persons killed by the tidal wave in Japan two days ago was estimated too high. Only 200 were drowned. New York Democrats nominated Bird S. Coler for governor.

A negro named Walter Sullivan was lynched at Pine Bluff Arkansas for shooting a white man in the back. General Miles sailed from San Francisco for the Philippines.

Oregon Apples are to be marketed in Europe. The town of Delta Idaho, has become a thing of the past. The site has been purchased by a mining company, and the houses torn down, burned or removed to prosecute mining.

The famous Lost Cabin mine has been discovered on Murders creek 40 miles from Canyon City, but its wealth is not so great as was supposed before discovery.

THURSDAY Oct 2 F. W. Ames, a former chief of police of Minneapolis got six years in the state prison for taking a bribe.

The stringency in the American money market has caused a higher bank discount in England.

The St. Louis bribery case has brought out the information that one man was offered a hundred thousand dollars for his vote.

The war over grazing land in Wyoming has produced three murders in a month. The better class of Filipinos are said to be clamoring for military rule again.

Equipment of Warships for the coming year is estimated at about \$2,500,000. Paul Underwood of Seattle was found guilty of murder in the second degree for the murder of his child.

A \$10,000 fire occurred at Mount, Tabor Portland. The Good Roads convention convenes in Portland October 11, and continues two days.

FRIDAY Oct 3 The strike conference brought about by President Roosevelt has had no perceptible result.

Massachusetts Republicans have declared for Roosevelt for another term. Another attempt is being made to create a plow trust.

Sir Thomas Lepton is said to have a challenge on the way to New York for another trial to win the American yacht cup.

A Chicago judge has decided that Japanese cannot become naturalized citizens. The car famine is hurting stockmen in the Rocky mountain region by preventing the moving of stock to places where feed can be had.

Pierpont Morgan is trying to buy a British railroad. President Roosevelt can do nothing more to end the strike unless the state of Pennsylvania becomes unable to cope with it, in which case the Federal power would act.

The strikers expect public support and the operators argue that they should not be expected to treat with irresponsibles.

100,000 tons of coal ready to come in from Canada. Rev. Henry Varley of London says that Providence directed the hand that blew up the Maine in order that Spain might be punished on account of slavery in Cuba.

Two trains collided in Montana. Two people were killed and many injured. Turkey is excited over the passing of the Bosphorus by Russian Grand Duke Nicholas in a warship.

The Macedonians want to have disputes with Turkey arbitrated. MONDAY Oct 6 Eight elephants went on a rampage in a circus in Nijal Novgorod, Russia, yesterday, and killed 2 persons and seriously injured 63 others.

Gervais, Oregon, a thriving little city was nearly destroyed by fire. Loss is over \$100,000. An earthquake at Guam did about \$50,000 damage to public buildings.
