A Man With A Gun.

From the Port Orford Tribune. Last Wednesday a riot occurred in our town that came very near proving serious to some of our quiet, orderly citizens who were in no wise implicated. Lee Cox and Dade Higgins got into a heated argument in the saloon when Cox struck Higgins with a small piece of iron, cutting an ugly gash over Higgins' left ear.

Higgins drew a revolver and Cox retreated out of the saloon and ran across the street and was just entering the door of the P. F. & L. Co.'s store when Higgins shot at him. The bullet passed through the glass of the sash door and passing the entire length of the building embedded itself in the wall just above the office window. Cox retreated through the store and up the stairs in the rear of the room. Higgins followed him into the store, but failed to find him. When the bullet passed through the glass of the sash door Fay Jones was walking past the door and broken particles of glass struck his face. C. V. Woodruff was standing inside the store between the door and office window and the bullet must have passed within a very few inches of his head. The bullet entered the glass in the door about five feet from the floor and ranged slightly upward as it traversed the length of the store and struck the wall a little more than six feet from the floor. On complaint of Cox, Higgins was arrested and he asked for time in which to procure counsel. The time for examination was fixed for Monday at 10 a. m. Higgins then swore out a warrant for Cox, who was arrested and demanded an immediate examination.

Higgins was arrested charged with assault with attempt to kill. The complaint against Cox was assault with a dangerous weapon.

All of a sudden the two principals in the affair forgot their animosity toward each other and agreed to compromise, which they did, each one withdrawing his complaint. They divided the costs, each one paying half and went their way rejoicing. Just as though the peace and dignity of our town had never been disturbed, and the lives of several of our quiet and orderly citizens jeopardized.

There is an old maxim that all is well that ends well. Perhaps all is well and perhaps the above affair ended well. We leave our readers to draw their own conclusions.

TUESDAY May 19
William P. Peabody shot and killed his uncle, Alexander S. Kerr, at Independence, Oregon.

200 sheet iron workers went on a strike at Cincinnati.

National Bank Examiner Perkins ordered the Southport National bank in Connecticut, closed. Cashier defalcated.

President Roosevelt was in Nevada today.

A reservoir at Panamint, Utah, broke, doing much damage. No lives lost.

A big fire at Milwaukee, Wisconsin, did \$50,000 damage.

Burglars robbed a safe at Tenino, Wash., after binding and gagging the postmaster. They got \$400.
