London, April 30.—The long siege of preparation for war by land in the far east has been rudely ended by a great battle. Reports received here show that the Japanese army, which for many weeks has been concentrating and training for the onslaught, has crossed the turbid Yalu and hurled itself boldly against the Russian forces. If the reports of the battle are true the fortifications so hastily prepared by the czar's forces proved inadequate and the Russians met defeat. The battle took place Thursday morning, a semi-surprise being effected by the Japanese notwithstanding the extreme vigilance of the Russian outposts. Early in the morning the full force of the augmented division of Japanese troops, including cavalry, infantry and artillery, were put in motion and swept down on the Russian sentinels. The latter numbering nearly 30,000, behind fortifications of remarkable strength, considering the short time of their construction, resisted desperately, but were fairly overwhelmed by the mobility of the Japanese attack. The reports received here indicate that the victory rests with the Japanese, although the battle is apparently continuing. Reinforcements are said to have been hurried forward to the Japanese from three sides, until the army will shortly outnumber the Russians. The Japanese sharpshooters are reported to have played a prominent part in the long range fighting picking off Russian officers with deadly accuracy. All London awaits further reports from correspondents and private dispatches received on the stock exchange, there has been no official confirmation of the battle. The Russian ambassador as well as Japanese Minister Kayashit state that no official notice of the battle has been had. At the Russian embassy the story is discredited, notwithstanding the general belief that an engagement is on and the secretary says that the latest news from Russian capital is that containing General Kouropatkin's report to the czar that all was quiet along the Yalu yesterday. London, May 2.—The Central News Seoul correspondent wires that the Japanese victory on the Yalu Sunday was most complete, the Russian lines being thrown into confusion and retreating in a disorderly manner. London May 2.—Japanese Minister Hayashi this morning issued a later report, by General Kuraki, regarding the rain fight. It is dated Kinohing Ching, Manchuria, Northwest of Antung, and reads: "We advanced on May 1st along three roads driving the enemy before us. At 8 p. m. we captured the line from Antung Sien to Lushenko. The Imperial guards surrounded the enemy on three sides, and after severe fighting, we captured the guns, besides the horses and carriages; the General Reserve corps, advancing along the Liaon Pang road, saw the enemy fleeing towards Fenghuang Ching. The booty captured includes a large quantity of arms and ammunitions. A captured officer says the commanders of both army divisions were mounted." London May 2.—The Japanese minister today issued a report from the captain of the gunboat Maya, which acted in conjunction with the forces of the Japanese in Sunday's attack on the Russian line on the Yalu river. It confirmed in a degree that the Russians had burned Antung. "A detachment comprising Maya, Uji and some torpedo boats ascended the Yalu and bombarded the enemy, silencing the enemy's artillery fire after thirty minutes severe engagement. All return to Yong Ampho. No casualties. "Our armed launches reached Antung the same morning and repulsed enemy's infantry artillery after thirty minutes of sharp fighting. Fire was seen rising from the town, and a native said the enemy fled after setting the place on fire."

London, April 30.—The long siege of preparation for war by land in the far east has been rudely ended by a great battle. Reports received here show that the Japanese army, which for many weeks has been concentrating and training for the onslaught, has crossed the turbid Yalu and hurled itself boldly against the Russian forces. If the reports of the battle are true the fortifications so hastily prepared by the czar's forces proved inadequate and the Russians met defeat. The battle took place Thursday morning, a semi-surprise being effected by the Japanese notwithstanding the extreme vigilance of the Russian outposts. Early in the morning the full force of the augmented division of Japanese troops, including cavalry, infantry and artillery, were put in motion and swept down on the Russian sentinels. The latter numbering nearly 30,000, behind fortifications of remarkable strength, considering the short time of their construction, resisted desperately, but were fairly overwhelmed by the mobility of the Japanese attack. The reports received here indicate that the victory rests with the Japanese, although the battle is apparently continuing. Reinforcements are said to have been hurried forward to the Japanese from three sides, until the army will shortly outnumber the Russians. The Japanese sharpshooters are reported to have played a prominent part in the long range fighting picking off Russian officers with deadly accuracy. All London awaits further reports from correspondents and private dispatches received on the stock exchange, there has been no official confirmation of the battle. The Russian ambassador as well as Japanese Minister Kayashit state that no official notice of the battle has been had. At the Russian embassy the story is discredited, notwithstanding the general belief that an engagement is on and the secretary says that the latest news from Russian capital is that containing General Kouropatkin's report to the czar that all was quiet along the Yalu yesterday. London, May 2.—The Central News Seoul correspondent wires that the Japanese victory on the Yalu Sunday was most complete, the Russian lines being thrown into confusion and retreating in a disorderly manner. London May 2.—Japanese Minister Hayashi this morning issued a later report, by General Kuraki, regarding the rain fight. It is dated Kinohing Ching, Manchuria, Northwest of Antung, and reads: "We advanced on May 1st along three roads driving the enemy before us. At 8 p. m. we captured the line from Antung Sien to Lushenko. The Imperial guards surrounded the enemy on three sides, and after severe fighting, we captured the guns, besides the horses and carriages; the General Reserve corps, advancing along the Liaon Pang road, saw the enemy fleeing towards Fenghuang Ching. The booty captured includes a large quantity of arms and ammunitions. A captured officer says the commanders of both army divisions were mounted." London May 2.—The Japanese minister today issued a report from the captain of the gunboat Maya, which acted in conjunction with the forces of the Japanese in Sunday's attack on the Russian line on the Yalu river. It confirmed in a degree that the Russians had burned Antung. "A detachment comprising Maya, Uji and some torpedo boats ascended the Yalu and bombarded the enemy, silencing the enemy's artillery fire after thirty minutes severe engagement. All return to Yong Ampho. No casualties. "Our armed launches reached Antung the same morning and repulsed enemy's infantry artillery after thirty minutes of sharp fighting. Fire was seen rising from the town, and a native said the enemy fled after setting the place on fire."

A four-year-old boy wandered from home and was found dead two days later, near Nelson, B. C. The British bombarded the town of Hing, in Somaliland. The Mississippi river is rising an inch an hour at St. Louis, and there is fear entertained that the dike may break. The Philadelphia negro who had his heart stitched together, some time ago, has entirely recovered. The Catholic school-house, a large stone building, near Pawlaska, O. T., was wrecked by a cyclone. A New York brewery has gone into the hands of a receiver. Liabilities \$400,000. Twenty seven persons were injured in a rear end railroad collision in New Jersey. WEDNESDAY, April 27. The Japanese tried at several points to cross the Yalu river, but only succeeded at one point. The Russians claim that one body of Japs were severely repulsed. Robbers tried to rob the Woodburn, Ore. postoffice, but were discovered and scared away. One dropped a revolver in his flight. Two men were buried beneath a falling wall at a fire in New York. Jerry T. Whitestone, of Spokane, had his wife and four children and his furniture stolen by a persistent friend from Iowa, who followed him to Oregon. A negro was shot to death in San Francisco while resisting arrest. He was an ex-soldier. Three men were fatally injured and three others severely hurt by a locomotive explosion at Pittsburg, Pa. The image of the Virgin Mary is to be taken to Port Arthur in the hopes that it will change the Russian prospects for victory. THURSDAY, April 27. Russian torpedo boats sunk the Japanese transport Kinshin Maru. Seventeen officers (twenty soldiers, 65 of the crew, and 85 coolies) are reported; the balance went down with the vessel. The new armored cruiser Columbia, was launched from the Union Iron Works shipyard at San Francisco. The second session of the 58th Congress adjourned today. A Japanese gunboat accompanied by several torpedo boats ascended the Yalu river and fought a series of engagements with the Russian forces causing them to flee. An attempt was made to assassinate the independent candidate, on the Labor ticket, for Mayor of Jeffersonville, Ind. James D. Moore, of Ashland, is appointed a midshipman at the Annapolis Naval academy. FRIDAY, April 29. Nine-tenths of the town of Fernie, B. C., was destroyed by fire. Loss \$200,000. A brand, near Payatall, shot and killed a tramp and wounded a boy who asked shelter. He also shot and wounded Sheriff J. A. Denholm who went to arrest him. The hermit is reported to be crazy. A mouse caused a panic in a Philadelphia theatre by causing a woman to scream, whereupon one she shouted "Fire." The panic subsided before much damage was done, only three or four children being hurt, and none seriously. A gold dredging machine on Fraser river is lifting \$2000 of gold out of that stream daily. A wild man was killed in Northern Mexico who is believed to be Dunham, the San Jose murderer. The Nebraska Supreme Court decided that brewers cannot take out saloon licenses except in their own name. SATURDAY, April 30. 16,000 Japs attack 30,000 Russians, are repulsed, and gain a complete victory. The Louisiana Purchase Exposition was opened at St. Louis amid a vast throng of people. A train wreck occurred near Kinrossick, Mo., in which three persons were killed and eleven others were injured. Fleming Froman, of Alabama, killed his wife and then cut his own throat. Lane County Superintendent of Schools assaulted the Superintendent of the Eugene City Schools on public street corner. General Lambert is looking up localities in Montana for the purpose of colonization by Boers. A Pendleton woman is trying to clear her title to her second husband by getting a divorce from him, after which she will secure from her first husband who had a wife when she married him, then, after six months, she will marry No. 2 again.
