LOCAL NEWS.

Levi Gant of Myrtle Point died March 25th, aged 78 years. Mr. Gant was one of the early pioneers to the Pacific Coast, and has long been a resident of Coos County. W. W. Smith came up from his ranch in Northern Curry and took his wife home Sunday, she having recovered from her recent sickness and operation sufficiently to return home. William H. Batton and S. E. Wright came up from the oil well at Dairyville, Saturday and remained over Sunday. Mr. Batton thinks that he will finish drilling within the next fortnight. A talk by telephone with one of the boys who went to Rogue River to fish for R. D. Hume, gave us the news that the boys arrived there Tuesday evening, and that all was well and that they would go to work yesterday morning. The fishing season there will last until the 15th of August. The office at the Woolen Mill is in course of construction, and the floor is being laid in the drying room in the attic. The labor of preparation has been nearly completed, and the mill will soon be in operation. The mill will soon show signs of activity, and the busy hum of industry revive the drooping appearance that has held sway for some time. Already the management has been obliged to refuse large orders for goods.

The steamers Elizabeth and Chico are both due to arrive from San Francisco tomorrow. C. Crowley and James Haft of Port Orford, were in Bandon the latter part of last week. Dr. Prentiss goes to Langlois, Monday, April 17th. Have your teeth put in good order before he goes. George Fowler has been suffering from an attack of grippe and a siege of tonsillitis. He is getting better. J. A. Counts was doing business in Bandon last Monday, and took a load of freight back with him next day. March passed out without showing much of the lion policy, and April is here making a very delightful showing. J. M. Upton, of Marshfield, greeted old acquaintances here, Tuesday, having been called this way on legal business. M. Rowan, of Coquille, has moved to Bandon and is opening up a harness shop, on First Street, alongside Mancini's confectionery. The Margarita Fischer Company have gone to Crescent City to fill a two weeks' engagement, after which they will again come to Coos Co. Carl E. Tilton came over from Beaver Hill, last Monday, having so far recovered the use of his leg again, as to be able to walk without crutches. Mrs. Ed Ruckliff, of Langlois, was in town Thursday on her way home from Myrtle Point, having attended the funeral of her sister, Mrs. W. E. Lewellen. Mr. Lewellen accompanied her thus far on her way home. P. C. Stephenson and Levi C. Gibson are at work on the counter for the Bandon Bank, and will soon have it completed. The labor of re-arranging the building to suit it for banking purposes will soon be completed. Mrs. M. A. McLeod, of Marshfield, Stenographer, was in Bandon over Tuesday, having been called here as referee in an action between R. H. Ross and Zach Boice, pending in Circuit Court. Attorney J. M. Upton, of Marshfield, was here in Mr. Ross's interest, while Attorney A. J. Sherwood, of Coquille, was looking after the interests of Mr. Boice. An adjournment was made until April 11th, when the balance of the evidence in the case is to be taken. J. Sydnam and wife were in town this week having arrived from the East. Mrs. Sydnam is a sister to Ed. Good, of Northern Curry, and went East last fall. Since leaving here, she and her husband have visited a good many localities, having gone East by the Southern Pacific route and returned by the Northern Pacific. Mr. Sydnam said that during his absence from Oregon he had not seen any green grass growing, the first on his journey showing up at Portland on his return. He and his wife will buy a lot in Bandon and make this place their home. They have gone on a visit to relatives in Curry for a few days.

Mrs. W. C. Sanderson is slightly improved, but still very sick. Mrs. A. M. Sumner went to Marshfield yesterday to visit her son Milo and family, and Frank. There was a shelling out of men from the Coquille, Monday morning, for Wedderburn, on Rogue river, to fish for R. D. Hume. Those going from Bandon were Frank A. Holman, Bert Patterson, Charles Loreux and Lawrence Stitt; Seth Lanegan of Randolph, and Peter Hansen, John Pederson and Jack Winkler, of Prosper, completed the number that set off on this occasion. Clay Garoutte took a four-horse rig and five of the crowd. This makes the first lot from here, and another party is expecting to follow in a few days. L. T. Langdon Suicided. The following is from the Humboldt Daily Standard. Mr. Langdon was well known in Coos and Curry counties, having acted as mail carrier along the coast for several years. Hanging by the neck from a brace in a box stall at the livery stable of A. W. Torrey, Second and H streets, the dead body of L. T. Langdon, an old man about town, was found yesterday morning shortly after 5 o'clock by John Ragon, an employe. Upon the brace across the stall were the old man's hat, a tin cup, and an empty bottle, bearing the label, Extract of Lemon. He was hanging on the side of the stall by a small hay rope doubled, in easy reach of the top and the brace upon which was placed the hat, cup and bottle. Apparently he had committed suicide, and the coroner's jury, empaneled last evening, found that he had met death at his own hands. At the inquest the circumstances of the finding were related as follows: John Ragon, an employe at the stable, went to work shortly after 5 o'clock yesterday morning, and entered the box stall to get a fork full of hay. When leaving he glanced over his shoulder and saw the suspended body of Langdon. He quickly notified a fellow stableman and they in turn notified Deputy Coroner Skinner. From appearances, Langdon had climbed upon the stall, tied the hay rope about his neck and slipped off. His coat had been removed and was laid to one side upon a bunch of hay. Two letters were found upon his person by the coroner, one attempting to give reasons for his rash act, and one to Dr. Charles Falk. In the first he expressed disappointment in not receiving employment as a stableman from John Hinch, and concluded "Life is not worth living." The second letter found is as follows: "Freshwater Corners, Humboldt Co., Calif., March 7, 1905. "M. D., Chas. Falk, Eureka, Cal. "I may die shortly, if so, I will leave my body to be examined by you for the benefit of the medical profession. You will find it a study if a thorough examination is made. You will find something wrong in the stomach, also the heart and the lungs; a rattling in the chest and an expectorate of a mucous matter at all times, and in a severe cold a bloody mucous matter, at times almost pure blood. Have had typhoid pneumonia fever many times. I think my time is short. L. T. LANGDON." Mr. Hinch testified that the deceased had spoken to him about employment a short time ago, and that he had told him that his stableman was thinking of leaving, and in that case Langdon would be given the job. Mr. Hinch's stableman did not quit, however, and consequently Langdon was not given the desired employment. A postal card from a Trinidad liveryman, stating that there was no need of a stage driver at the time of writing, was also found on the person of the deceased. The old man was not well known in Eureka. He had been in the county for several years, and two years ago worked at Torrey's stables. Since then he occasionally slept at the barn in the hay, and upon such occasions was sorely noticed by the stableman. He went to the barn Friday night about 11:30 o'clock, and engaged in a short conversation with John Wesley Dillon, the night man. The two men passed a few casual remarks and Langdon went to bed. The trials of Marshall Cook, Paul Martin and Chester Langlois, came off in Port Orford, Monday, before Justice Zimwald, and resulted in the conviction of Marshall Cook and Paul Martin on a plea of guilty, and the Justice imposed a fine of fifty dollars upon each of them. Mr. Langlois employed Atty Madden and pled not guilty. A jury was quickly impaneled and the prosecution failing to establish sufficient evidence against him, the case was dismissed. E. W. Jensen appeared for the state, and as there are two convictions out of three cases, the prosecution has not been in vain; and that it will be a salutary lesson to thoughtless law breakers, we don't doubt. Important News Notes. THURSDAY, March 28. The Japanese army is on the march again northward. A tornado destroyed the village of Lewisburg, Minn., injuring several persons, one fatally. The people mostly escaped serious injury by getting into their cellars. Ottawa, Kansas, was damaged by a wind storm and a dozen persons injured. The nobles of Russia fear a reign of terror. The interior of that country is declared to be boiling with revolution. A fire at Hanson, Ky., today, did \$100,000 damage. Twenty-five negro convicts who escaped from a Texas prison, are being trailed by bloodhounds. Three have been captured. WEDNESDAY, March 29. Peace talk report says that Russia has named negative conditions for Japan. Japan wants a war indemnity of \$300,000,000. The demand is a bar to peace negotiations. The fire in the Albany Woolen Mills started in the drying room and spread so rapidly that the employes had barely time to escape. The London share of the Japanese loan is oversubscribed ten times. Two persons died of heat at Pittsburg, Pa. Temperature registered 78 degrees. Secretary Hay arrived at Gibraltar and says that he is better. President Roosevelt has asked for the resignation of the Panama Canal Commissioners. THURSDAY, March 30. About fifty men deserted from the 19th Infantry which is to leave Saturday, for the Philippines, from Portland. The Japanese have seized the steamer Industry, bound for Vladivostok. The Japanese flanking columns have been seen 74 miles north of The Pass. The new cruiser Hasebek, of the German navy, has a speed of 23 knots an hour. King Edward will take a cruise in the Mediterranean. Suptor, Oregon, was visited by a heavy snow fall, bringing joy to the placer miners. The Elks Home at Reno, Nevada, burned down. Loss \$25,000. FRIDAY, March 31. No hope of peace in the Far East, is the cry. Japanese Minister at Paris declares his government has given no hint of terms. Oyama is proceeding northward with his main army, with wide extended wings, with the object of enveloping the Russian position. The terrorists of Russia are active, and thirty more of the nobility, including Grand Duke Alexis and Governor General Trepoft, are marked for destruction. The German Kaiser visited Morocco for a couple of hours. Texarkana, Texas, was visited by a \$75,000 fire. In a collision between fire engines and a street car, in Chicago, five firemen were injured. SATURDAY, April 1. The Portland policemen were the subjects of many practical jokes, and were sent chasing imaginary criminals. The Nineteenth United States Infantry sailed from Portland, today, to serve in the Philippines. Police Commissioner Szabolcz of Lodz, Russia, had his feet blown off and was otherwise wounded by a bomb. The assassin was wounded by the policeman's attendant, and will probably die. Theodore P. Sohns, of Pa., has been appointed head of the Panama Canal Commission. There are some peace reports afloat, but they seem mostly to be the result of guesswork. The battleship Ohio left San Francisco for China to join the Pacific Squadron. MONDAY, April 1. Sixty men are entombed in a coal mine at Zuger, Ill. An explosion closed the entrance to the mine.
