The commencement exercises of the Bandon public schools were held at the opera house last Friday evening and the hall was filled to overflowing with an appreciative audience. The graduating class was a large one, fourteen in number, as follows:

There was also a class of fourteen which successfully finished the eighth grade work and will enter the high school next term. Eighteen students took the examinations and the fact that fourteen of this number passed, shows that the work has been thorough.

The program for the evening was a splendid one. After the invocation by Rev. W. R. F. Browne, the salutatory was given by Frances E. Corson. Her delivery was above criticism. A duet by the Misses W. McNair and L. Bonk was fine and they were heartily cheered. A recitation by Rittie McNair in her usual pleasing manner was enthusiastically received. The valedictory at the hands of Ethel Dyer, was carefully prepared, concise and well delivered.

Pres. B. F. Mulkey of the Southern Oregon State Normal School delivered the address to the class and it was one of the best of the kind ever heard here. W. W. Gage, Democrat.

W. W. Gage, who aspires to the office of sheriff of Coos county and has been named for that position by the democrats, has served three terms in that office. During his incumbency in the shrievalty and while he was receiving pay from the taxpayers for his services, he was on the payroll of the Beaver Hill Coal Co, accepting from that private corporation \$50 per month and in the aggregate about \$1400.

When Mr. Gage accepted this money from the corporation the law of the state provided that "sheriffs of the several counties in the State of Oregon shall receive an annual salary as follows:"

*** Coos, \$2,000. *** And no one of such officials shall be entitled to receive any fees or other compensation for his services than as above provided."

Gage's chief labors for the coal concern, and for which he received this handsome remuneration, was signing the payroll. R. A. Graham was the general manager of the Beaver Hill Coal Co, and did not throw his money at the birds. Did Graham have some ulterior use for Gage? Could he honestly serve two masters—the people and R. A. Graham?

To the Voters of Coos County:

The Law and Order League of Coos county represents a body of more than 850 voters pledged to support men openly favorable to temperance. They are men from all parties, most largely republicans and democrats.

The purpose of the league is to elect county officials who will give an economical, business administration of county affairs, and enforce the law. Nothing more, nothing less.

In mass convention this body endorsed Ed Racleff, J. F. Hall, A. McNair, W. W. Gage, W. F. Disher, W. E. Cleghorn, Dr. E. Mingus and A. N. Gould. For these men we will vote and appeal to all men who believe in temperance, majority rule and fair play to support them also. Endorsing these men, three things guided the convention, namely: character, ability and a record that proved them to possess the first named qualities. They are also pledged to give the local option law a chance to prove its merits.

A few men using the name of the republican central committee, working not in the interest of the party, but the liquor business, have made an attack, as devoid of reason as it is of truth, upon this convention and its action. At that convention were three republicans to one democrat, and the endorsement of three democrats was made because they possessed the above named qualities and their republican opponents did not from a temperance point of view. We in no way desire or intend to interfere with the republican or democratic parties or principals as such.

Every man of us is left free to vote our convictions on all questions and officials that involve such principals, but county affairs is a question of efficient men and economy. Party spirit is well nigh dead here, as it ought to be. And any set of men who try to use a party lash this way will injure vastly more than help their party, as well as all reform and advancement.

More than half the republican central committee had no part in the attack made and do not hesitate to say so, and no thoughtful, consistent temperance man, who thinks more of his home and country than he does of his party, betrayed by such unprincipled men, and prostituted to such destructive business as the liquor traffic, will be influenced by that attack.

It is no fault of the republican

party that the liquor business is trying to use it in this county, nor will it in any way injure it to elect those county officers, who are democratic on national issues, hence we believe the good deliberate judgment of the voters will sustain our action and elect the men endorsed by the league. We are not disposed to make a personal attack on candidates not endorsed by us, but simply say, that the best interests of the majority of the people of this county necessitate a united temperance vote for all the men endorsed by us. "United we stand divided we fall," hence the desperate effort of the liquor men to divide us. Can they fool you? We think not.

We believe that a good majority is more than "the will of a few people in certain precincts," and an officer is not "a sneak" who executes the law, and competent men will not "bring the county into endless litigation."

We appeal to every voter, who believes in the brotherhood of humanity and social obligations, to work and vote with us for the common good.

We believe the law will give us its best results executed by officials favorable to it.

We trust that we will no longer let personal or party politics divide us on this question, which so vitally affects our physical, intellectual and moral welfare.
