The Steamboat Project.

Our esteemed contemporary, the Coquille Sentinel, is out in advocacy of the proposition to build a steamer with local capital for the Bandon-Portland run. Editorially the Sentinel deals exhaustively with the subject, and explains the pecuniary profit of such a venture, as well as the fact that the grasping Southern Pacific has a clutch upon the throats of the up-river people which it is only tightening instead of relinquishing.

The RECORDER has already voiced its approval and support of this move, though we are aware that the matter is one which appeals particularly to our business men and men of means. That such men would find it a profitable undertaking and a wise stroke for the upbuilding of this valley's interests is conceded by all who have expressed themselves in our hearing, and we cannot but feel that the movement will yet be successful.

As for Bandon, she is always ready for any project that promises reasonable returns on the investment and bodes well for the town and its adjacent country. It was Bandon that gave the start to this self-same project a year or so ago, at which time Coquille had not felt the railroad oppression sufficiently to induce her to swing into line. She now feels it, however, and her appeal for deliverance through Coquille bar well illustrates the maxim that experience is oftentimes the very best of teachers.

The RECORDER genuinely deplors that its county seat friends suffer the extortions of the Coos Bay Railroad, for we suffer them, too, if we make use of the road, but we are simultaneously pleased that these friends look this way for ultimate escape, and sincerely in conclusion we voice the hope that the steamer will be built with Portland and lower Coos capital.

In another column today appears a communication about the subject from a prominent citizen of Bandon, and in endorsing the views it contains we invite a careful perusal of it by all who are interested in the steamboat proposition.

M. G. Pohl of Myrtle Point uses the public print to say that inasmuch as the Coquille Valley must raise the potatoes that are required by the proposed denatured alcohol plant on Coos bay that the plant itself should be located in the Coquille Valley. We believe Mr. Pohl to be correct, and are somewhat of the opinion, besides, that the builder of the distillery will find his potatoes dear spuds unless perchance he has a stand-in with the Southern Pacific Railroad which must cart his tubers over to the bay. The gentleman, it is stated, will require 147,000 tons of potatoes every year, which naturally means a great deal for the Coquille Valley.

Now that Senators Fulton and Genrie, Governor Chamberlain and Congressman-elect Hawley are due to reach the Coquille any day, let Bandon do her full share toward entertaining the distinguished party.

The movement to merge the starving churches in the small towns is sane and sensible. One strong church is ten times as useful to a community as ten weak ones. One well-fed preacher is worth a dozen who must spend all their time in keeping the wolf from the door with none left to fight the devil.

The bureau of labor and statistics has just completed an estimate of the hop crop in Oregon, and has computed some interesting comparative statistics of the hop industry for the whole world. These figures place Oregon in a most favorable light, and show that this state grows more than 13 per cent of the entire hop crop.

The Trades Council of Humboldt county, California, in harmony with all the labor unions of that State, have denounced J. N. Gillett of Eureka, the Republican nominee for Governor, and are supporting Theo. A. Bell, the Democratic nominee. Laboring men claim that Gillett is not their friend, and refuse to vote for a corporation tool and the attorney for the Santa Fe Railway. With the Republicans, the Democrats and the Independence League all struggling for supremacy down there it is hard to conjecture the final outcome, and we would not be surprised if California, like Oregon, chose a Democratic Governor this year. Theo. Bell, Democracy's standard bearer, is only 34 years of age.

Grover Talks of Campaign.

Ex President Grover Cleveland, in a recent issue of the New York World, gives an opinion of the political fight now under way in the Empire State. As might be expected, Mr. Cleveland has small use for Wm. R. Hearst and the radical interests he represents. The opinion follows:

"It is difficult for me to overcome my reluctance to express my views of the present political situation in the state of New York, and yet I can never lose the interest in her political welfare there and my active participation in her political movements.

"I confess I was exceedingly surprised by the outcome of the recent Democratic state convention. Though I was not near enough to be in touch with the incidents leading up to this result, being absent on my vacation, and giving little attention to political occurrences, my estimate of the conservative good judgment of the Democrats of the state and my conception of Democratic principles and purposes were such that I was profoundly startled by the selection they made of a candidate to represent them in the pending canvass.

"Of course, every voter in the state must settle with his own conscience in determining his action in this emergency, but I cannot but regard the Democratic situation presented to my old associates in New York as an afflictive one."

Colony of 10,000 Dunkards.

The Southern Pacific Railroad Co. has given out news that 10,000 Dunkards are heading for California from the States of Ohio, Illinois, Kansas and Missouri. A large colony is to be located at Butte Creek Valley, just over the State line in Stekyon county, where the Dunkards have bought 10,000 acres of the extensive Miller tract. They will locate two towns on the projected line of the S. P. R. Co., which is to run to Klamath Falls, Oregon. They also intend, it is said, to increase their colony in size, and to make Butte Creek Valley the largest Dunkard settlement in the world.

R. D. Hume has a crew of men at work on a race track on what is known as the Woodruff place. When completed it will be second to no half-mile track in Oregon. No doubt about next Fourth of July there will be races on this track worth looking at. —Gold Beach Globe.
