## The Primary Election

### GOOD ATTENDANCE

### Ten Candidates Nominated to Run on Ticket for Trustees

The Mass Meeting called in the Town Hall for the purpose of holding the city primaries, last Friday night was well attended, and much interest manifested in the election of the city dads. Geo. P. Topping was elected to act as chairman at this meeting and Chas. Lorenz as secretary. Nominations were in order, and the following were nominated to run on the ticket.

Trustees: John Felner, M. Brener, O. A. Trowbridge, Jas T. Mars, John W. Hoover, E. Lewin, Nels Rasmussen, W. R. Panter, and W. F. Dishor.

Recorder: C. R. Wade and A. Rice. From this ticket five trustees and a recorder will be elected. The prospects for election excitement is very slim this year, the only question now up being that of the license problem.

This ought to be settled once and for all at this election. There has been considerable doubt as to whether a license could be collected from all of the business houses or not, and we are informed that several have flatly refused to pay their license. If there is to be a license, let everyone that is licensed pay his share toward the improvements of the town.

The proposition of having a Fourth of July celebration was brought up and the following committee was elected to go ahead and arrange the celebration: Chris Rasmussen, T. B. Wheeler, Capt Robert Johnson, O. A. Trowbridge and Walter Nelson. They are arranging for one of the good old celebrations that will commence with a roar at day break and close at day break the next morning with the breaking up of a grand ball. An effort will be made to secure something new in the line of fireworks for evening entertainment, and a good game of baseball in the afternoon will also be a feature of the day. ### Trouble on the Wharf.

## Booming the Electric Road

### STOCK IS SUBSCRIBED

### Big Meeting at Roseburg, Mayor Called Half Holiday.

The proposed Coos Bay-Roseburg Electric Railway is the all absorbing topic for discussion; it is in the air; far seeing ones have said it is not the wild cat scheme most new enterprises are that boom for a few short weeks and then fall flat, but this is a reality, and a sure go. The subscription list has not been sent over to the bay yet, but when it is, all will take hold and help push this greatest improvement that we have ever had. An electric line into this county will change everything. Valuable farms will spring up where before it has been impossible to even get the timber off the land. We have an abundance of the finest land there is, but heretofore haven't been able to develop it on account of inadequate transportation facilities. Following is from the Umpqua Valley News:

There is today a feeling of confidence on the part of the public that Southern Oregon is at last to take her place in the commercial world to which by reason of her vast resources she is entitled. It has long been an acknowledged fact that in Douglas and Coos counties are the finest bodies of standing timber in the state, but simply because we have no adequate transportation for our lumber products this industry has laid dormant. At the present, however, the people see in the road to be built a way to deep water with their lumber, and already much activity is seen in the effort being put forth by very many to secure timber lands. In Roseburg and not alone here, but in other localities, the people have formed combinations and are hot on the trail of the S. P. Company lands and those of the Southern Oregon Company, which by the terms of the original grant from the government are supposed to be sold at a price not exceeding \$2.50 an acre.

Farmers from all parts of the two counties are daily inquiring as to the proposed route, and are very anxious to have the road go their way. To aid the project they express themselves ready to put up the hard cash. These people know that with the road in operation their land will be worth two to four times what they are bringing at the present time.

Farm and timber lands are the best property that can be invested in along the right of way, or within a number of miles of it, and investors are beginning to put in an appearance.

There is an increased confidence in Roseburg's future. Property owners, from the man of large holding to the one who only has his little home, feel secure in the same, and values are on the increase.

These conditions are exactly the same as was experienced in other sections at the time electric road building was proposed and inaugurated. There is not to our knowledge a single exception to this experience. The road from Spokane, Washington, to Coeur d'Alene, Idaho, a distance of 30 miles, the first interurban line in that section, put the latter city on its feet and built it up from 1500 to 4000 in two years time. This line parallels the Northern Pacific tracks every foot of the way. The electric road runs eleven trains each way every day between the two cities, and pays dividends twice a year, and has done so since the first six months the road was in operation.

Every citizen of the country should contribute something toward the building of this road. When it is completed and extended into South Douglas, we will grow and flourish like the proverbial Green Bay Tree. "Coos Bay or bust," should be the slogan.

## Marshfield Excursion.

The excursion due here from Marshfield last Sunday was called off on account of the disagreeable weather. They will come over this coming Sunday, weather permitting. A large number were down to the depot ready to leave before it was generally known that it had been postponed.

This being the first excursion of the summer, it would have been a large one. All of the river boats were ready to bring down the excursionists.

## Will Sue the City.
