THE COOS-BAY-ROSEBURG Electric Line is an assured certainty and the newspapers of Roseburg are booming it higher than a kite. Last Friday night the whole town turned out to the called mass meeting and much enthusiasm was manifested. The Roseburg Review has the following to say regarding same:

Roseburg went on record last Friday as being willing to do their whole share towards building the railroad to Coos Bay.

A large and earnest, as well as enthusiastic mass meeting was held in the opera house and many representative citizens in formal speeches pledged themselves to do all in their power to bring about the early con-

struction of the road. No individual pledges of money were asked or accepted, as the ways and means are to be considered by the general conference between Roseburg and Coos county delegations to be held soon. A half holiday was proclaimed by the mayor and every place of business in the city was closed and the attendance of representative citizens was large. The spirit that prevailed at the meeting showed that this city is in earnest and fully realizes the importance of constructing this road and sees the gravity of the situation. Every remark was greeted with applause and the statement that Coos county had already pledged large sums made a deep impression. Resolution adopted in mass meeting:

Whereas, the time seems propitious for the construction and operating of a line railway to connect Roseburg with a deep water harbor in Coos county, and,

Whereas, resolutions strongly favoring the building of such a line of railway have been passed by the citizens of Marshfield, North Bend, Coquille, Myrtle Point and Bandon in Coos county, and,

Whereas, we believe that such a line would be a paying investment for all investors therein, and,

Whereas, we believe that Roseburg and Douglas county should and must have independent connection with ocean traffic.

Therefore, we, the people of Roseburg, Oregon, in mass meeting assembled, hereby pledge all and every support that lies in our power for the construction and operation of an electric or steam railroad to connect Roseburg with a deep water harbor in Coos county.

Force of Public Opinion.

In San Francisco there is anarchy. In the conduct of a labor dispute between the street car companies and their employes, law and order have been thrust aside. The public is assailed with murderous violence. There is no police protection—at least inadequate police protection—against red-handed riot. The people of San Francisco are suffering from a deplorable condition of affairs—more deplorable than has ever obtained in the history of that city, or possibly in the history of any other American city.

Is there a remedy? This is the question for the San Francisco public to determine and determine speedily. The solution of the problem affects indirectly the interests of every American municipality where similar disputes are likely to arise. There appears to be unanimity of sentiment of the Bay City press, which utters in effect: "A plague on both your houses." There is no doubt in the world that this newspaper sentiment is but the reflection of public opinion in the premises; yet it has not crystallized into anything like public action. It is high time that such result followed.

There is still reason for the American people to have faith in the efficacy of clearly announced public opinion. The corporation and their striking employes both rely upon it. Each has the hope of its favor. It has proven so in other cities during times of trouble between labor and capital. It should prove so in San Francisco though evil conditions have developed beyond the usual magnitude. The time and occasion is presented in the Bay City for the people to get together and begin at the bottom; for them to give the dispartants to understand that a settlement must be reached; that violence which imperils the lives of peaceable and law-abiding men women and innocent children will no longer be tolerated; that unless there is speedy settlement, the public itself will see to it that drastic measures are taken which will insure its protection. There never was such opportunity to test the force of strongly expressed public opinion.—Telegram.

Keystone State, \$75,000.

The Pennsylvania legislature has passed a bill appropriating \$75,000 for the Alaska-Yukon-Pacific Exposition which will be held in Seattle in 1909.
