### Proceeds to go in Fund for a Reading Room for Bandon.

The Trades Carnival to be held in the Bank Hall next Saturday evening, June 29, bids fair to become a big success. The carnival is given under the auspices of the Ladies Art Club, who have spared nothing that this may be a success. The principal feature is the Nebraska Drill of over 40 of Bandon's beautiful young ladies. In this drill the individual members represent various up-to-date business firms of Bandon. The drill takes something over a half an hour to present and is well worth the price of admission. There will be a grand ball immediately following the carnival doings. The music is by the Seaside Orchestra who have become very popular as dance musicians. General admission is 25 cents and the dance is 50 cents extra.

The proceeds of the carnival will be turned into a fund to provide for a reading room in Bandon. This is a very worthy project and should receive the hearty support of all. The ladies have been doing a good work in this line. Tony the Convict, which was staged under their auspices, was financially a success and the proceeds are now on deposit for the reading room. The ladies expect to give other entertainments later on in the season, and by fall will have enough to furnish a reading room.

This should by all means keep them off the street corners and be an incentive to keep better hours and habits. There is no place in town that one can get periodicals and magazines, and these will come regularly to the reading room.

### Drainage Meeting.

A meeting of the subscribers to the Fat Elk Drainage District was held at the Court House in Coquille City last Friday. The principal objects of the meeting were to provide rights of way, determine extent and depth of canals, and for the securing of data to assist the County Court in making assessment for the construction of said canals. The services of Engineer Gould were secured to make surveys and estimates on excavation. The system embraces a main 33 feet wide, bottom measurement, and 1 1/2 miles in length, along the route of the old Bear ditch, tapping the lake just North of the Dish-er place from which six laterals extend in various directions touching every plat of land within the district. The laterals range in width from six to twenty four feet on the bottom. All ditches, mains and laterals, are to be sunk to extreme low water level. This will facilitate a daily inward and outward flow of the water which will be of great value in keeping the ditches free of silt and sediment. The officers of the organization are C. R. Gabler, Pres., Ed. Johnson, Vice-Pres., and J. W. West Secretary. These officers are also the acting board of Directors.

The directors will advertise for bids immediately after the commissioners have made assignments. A complete system of by-laws for the government of the district were adopted at the meeting.

It is hoped that contracts will be secured and the work gotten well under way before the rainy season sets in.

The project carried to its ultimate conclusion will be of inestimable value to the Coquille valley and the County at large.

### Paper Mill Meeting.

There will be a meeting of the stockholders in the Pulp and Paper Mill Corporation, tonight at the Opera House. Everybody is invited. F. J. Marshall will address the meeting, and the better interests of the institution will be discussed. R. E. L. Bedillion will preside, and O. A. Trowbridge is secretary of this meeting.

### Lights for Bandon.

The oil lamp and the gas lamp are a thing of the past for Bandon. We are going to have electric lights and in a very short time. Messrs. Hollopeter and Drinker now have the construction work on the power house merrily under way, and the east enders are lulled to sleep by the pile driver, which, on account of the tides, is forced to drive the piling at night for the foundation.

The power house is just east of the shingle mill, and will be covered with corrugated sheet iron. ## New Addition to Hotel Gallier

### OLD PART IS MOVED

### Will Build Two Wings - Present Building being Renovated.

At last the new hotel question has been settled once and for all. Gallier Bros. are now getting the ground ready for a new wing to their present building that will measure 32 by 100 feet and will be three stories high. The present building has been moved back 26 feet and an addition will be built at this time on the East end. The other end is in such shape that the west addition can be built at any time that trade demands.

This will make every room in the house outside rooms and give them enough to accommodate the rapidly growing transient trade. A balcony around the second floor and a wide porch all around the front of the building will greatly add to the looks of the building. The court in the center, between the two courts, will be fixed up in fine shape to accommodate the band, which will give its concerts there in the future.

The front of this new structure will lack six or eight feet of reaching the street, which will be filled in with chairs and will not obstruct the sidewalk as heretofore.

The old building will be thoroughly renovated. The rooms will be repapered and painted, and many repairs made. A large ladies' parlor has been provided for in the new structure, which is a very necessary item.

J. T. Mars has been moved to the rear of the present building, but will occupy half of the new front in the addition. There will be another store front to be rented, but at present writing nothing definite has been done about its rental.

### Notice of Street Improvement

Notice is hereby given that the Board of Trustees of the Town of Bandon, Coos Co., Oregon, by order duly passed on the 24th day of June, 1907, and entered in the Journal of its record for that day, proposed and hereby gives notice of such proposal, to improve, grade, repair, repave, and curbe sidewalks to be built upon the following named streets, within the limits of the Town of Bandon, to-wit: Fourth, Bluff, Coquille, Pine, Spruce, Pioneer, The Extension of Pioneer, The County Road, known as the Plank Road, and in the Woodland Addition known as Abernathy Avenue, Columbia Avenue, Little Street, known as Pacific Avenue and First Street, said improvements being more specifically described as follows:

1. To build a sidewalk upon the West side of Fourth Street, beginning at the west line of intersection with Spruce Street, westward to the termination thereof, being the west line of intersection with the County road running North East and South West, and continuing on the West side of said County road to the South line of the Ochs-Kasmanussen property.

2. Also to build a sidewalk on the East and the West side of Bluff Street, beginning at its South line of intersection with Fourth Street continuing Southward to the point where Bluff Street diverges East, and from said point of diversion, said sidewalk to continue upon the West side of said Street to the South line of intersection with Coquille Street.

3. Also to build a sidewalk on the South side of Coquille Street, in South Bandon Addition to said Town, beginning at the West line of intersection with Bluff Street (prolonged), continuing thence Eastward to Spruce Street.

4. To build a sidewalk upon the East and the West side of Pine Street, beginning at the South line of intersection with Fourth Street, continuing Southward to the intersection and merger thereof with Spruce Street.

5. To build sidewalks upon Spruce Street as follows: On the East side thereof, beginning at the North line of intersection with Fourth Street continuing Northward to the North line of the Upper property, also on the West side of said Street, beginning at the South line of intersection with Fourth Street, continuing Southward to and even with the Presbyterian parsonage; also on the East side of said street, beginning at the south end of the present sidewalk, continuing southward to the Horsfall property, thence continuing on the South side of said Street, to its intersection and merger with Pine, and diversion Southward, and from such point, to build a sidewalk upon the East and the West side of said Street, to and even with the South line of said Horsfall property.

continuing Southward to the terminal thereof.

8. To build a sidewalk on the West side of the Street commonly known as the County plank road, known in Woodland Addition also as Abernathy Avenue, beginning at the South line of intersection with Third Street in the original Townsite, continuing Southward on said side of said Street or road to the North line of intersection with Sixth Street, in said Woodland Addition.

9. The said Board proposes to survey and establish a regular and uniform grade for that portion of Columbia Avenue, between the North line of its intersection with Iris or Trio Street and the South line of intersection with Sixth Street, and to grade the said Avenue for the whole width thereof in accordance with the grade so established.

10. To survey and establish a regular and uniform grade for that portion of Little Street, otherwise known as Pacific Avenue, between the South line of intersection with Wharf Street, continuing Southward to the North line of intersection with Spruce Street, and to grade the said portion of said street or avenue for the whole width thereof in accordance with the grade so established.

11. Also to establish a regular and official grade upon First Street for that portion between the East line of intersection with Wharf Street, continuing Eastward to the East line of intersection with Homer Street, and upon such portion to reconstruct the bridge work, and to replank the same, for the whole width thereof, where the same is not in accordance with regulation, with 4 inch plank.

12. Also upon First Street between the West line of intersection of said First Street, and Pacific Street, continuing Westward to the East line of intersection with Spruce Street, to survey and establish a sidewalk grade.

It is furthermore proposed that all sidewalks so built, shall conform to the following specifications: Three stringers, 2x4 or 6 inches, that all planking shall be 1 1/2 inch in thickness, and that all walks shall be at least 6 feet wide.
