The light house tender Heather was in the bay Wednesday, landing 160 cases of coal oil for the Cape Blanco light.

Mrs. O. Leneve, who has been at Bandon for some time, came down to Port Orford Monday to join her husband, but they may not remain long as they are thinking of locating in Nevada.

It is reported that the tug Katie Cook has been sold to Marshfield to be used as a fire boat, which would be a wise move by the city authorities.

B. W. Dean took the wife of Engineer Brown and Mrs. Hansen of New York, up to Bandon last week. Mr. Dean returned Friday, going on down the coast to join the surveyors for whom he is teaming.

Miss Anna and her brother Will Colebrook were in town Sunday night, where they met Dr. Mann, whom they wished to treat a bad arm for the former. The Doctor treated the arm and pronounced it not dangerous, and the young people returned home next day.

The fine Cotswold ram lately brought into Curry county by F. M. Langlois, came to Wisconsin from England and was then shipped here with two ewes—the freight on the three being \$104.75.

Picking huckleberries is the fashion just now at Port Orford, where they are unusually abundant and of unlimited quantity. Occasionally one finds a bush which has been visited by a bear, but that doesn't frighten a Port Orford lady.

Franz Nortberg and Allie and Court Guerin, who have been working for some time past for the Gold Bar Mining Company at Big Bend on Rogue River say that the work of putting on extra water has been postponed until next spring, but that the giants will be at work with the first rains.

The Philippines.

Concerning the proposition to dispose of the Philippines, Mr. Taft said: "It has been suggested that we might relieve ourselves of this burden by the sale of the islands to Japan or some other country. The suggestion is absurd. Japan does not wish for the Philippine islands; she has problems of a similar nature nearer home. More than this, the United States could not sell the islands to another power without the grossest violation of its obligations to the Philippine people.

Under these circumstances, then, could there be anything more wicked, more infamous than the suggestion of war between two nations who have enjoyed such time honored friendship and with nothing to fight for? Some ask, why such reports and rumors of war? The capacity of certain members of the modern press for sensational dispatches to give rise to unfounded reports has grown with improvement of communication between distant parts of the world. The desire to sell papers, the desire for political reasons to embarrass the existing government, or other, and even less justifiable motives have led to misstatements, misconstructions and unfounded guesses, all worked into terrifying head lines which have no foundation whatever. In each country, doubtless there are irresponsible persons, that a war would or might make prominent who try to give seriousness to such discussions. But one who considers the real feelings of the two people as a whole; when one considers the situation from the standpoint of the sanity and real patriotism of each country, it is difficult to characterize in polite, moderate language the conduct of those who are attempting to promote misunderstandings and ill feelings between the two countries.

Oregon Apples Are Far In The Lead.

"Choice apples will command high prices the coming winter," said a commission merchant today. "Oregon is fortunate in having a fair crop of the fruit this year, though the output is, of course, under the normal. It is the eastern demand that will this year make a firm market here for all varieties of winter apples.

"In the Atlantic coast states for the most part in the middle western states and even in the Rocky mountain country, the apple crop is short, and consumers in those states will have to look to the Pacific coast for a good part of their needs in the apple line.

"Good Kings, which are about the best apples in the local market at this time, are worth \$1.65 a box, and it is no trouble to sell them at that figure. I believe it is safe to predict that they will sell for \$2 a box within two weeks. The market is now short of good apples, and the chances are that there will be a scarcity for several weeks, and when the regular winter shipping sorts are ready for the market there will be so great a demand for them in the east that they cannot be expected to sell cheap here.

"Spitzenbergs and Spys will hardly sell here for less than \$2 a box, and it is altogether possible that they will command a better price than that when the market for the winter sort opens and the fruit begins to move. There are now some apples on the local market that sell for less than \$1.25 a box, but they are hardly a factor in the market. The demand for even such as these is such that they do not stand long unsold." Oct. 10.

What Next?

A number of administration organs pinched by the exactions of the tariff paper trust have finally joined in the demand that the tariff on paper and wood pulp be repealed. Certainly it should be, for it has no other effect than to put a premium on the destruction of our own forests and enrich a few pampered tariff barons. But when these administration organs have succeeded in ridding themselves of a tax that the foreigner does not pay, will they kindly come to the assistance of several millions of us who are compelled to pay, the tariff tax, that the foreigner also does not pay, on shoes, clothing, hats, thread, nails, wire, sugar, lumber, coal, oil and its by-products, leather, cordage and numerous other things? If the tariff on paper and wood pulp pinches the newspaper proprietors, how can they deny that the tariff on other things also pinches the people who must purchase those things?
