

Roosevelt and Taft.

The whole realm of public life contains no two men of the same convictions who are so opposite in method and temperament as are Roosevelt and Taft. Roosevelt is intuitive and combative; Taft is judicial and persuasive. Roosevelt assaults obstacles with all the vehemence of his nature; Taft would order the engineer crew to remove the obstacles. Roosevelt excommunicates and obliterates his enemies; Taft would make them see the reasonableness of doing the right thing, and ask them to do it. Yet both men work to the same ends. It must not be supposed that behind Roosevelt's passion there is no sufficient foundation; neither must it be supposed that behind Taft's smile there is no determination. One is a piece of dynamite under the stump, the other is the stump-raising machine that works easily and makes no noise—but either will raise the stump. In carrying out the Roosevelt policies by the Taft method there will be fewer explosions in the White House, fewer epithets used, and a dearth of high-keyed sensations, but the work will be done just as effectively. Roosevelt has the machinery mostly in good running order and Taft is too good a workman to allow it to get rusty.

But best of all qualifications, assuming ability to be present, are the transparent motives of the man, his innate candor, his open life, his absolute separation from the tricky or merely political, his rare appreciation of public duty, his sound sense of the difference between essential right and wrong, his sincere passion for seeing the people benefit from his work, his wholesome belief in the good judgement of the whole people, and his own clean, upright manly view of things.

Here is a statesman—"the state's man"—in truth. It is a fortune the people hardly stop to appreciate in this day, when politics has degenerated to a trade and professions of patriotism to one of its tricks, to find a man who seeks neither wealth nor power, but who cherishes an exalted ambition to enroll his name indelibly in the honorable company of those who thought it was fame enough to have served their fellow-men.—Detroit News.

"Manslaughter," the Verdict

A verdict of guilty of manslaughter was returned by the jury in the case of Holland, or "Mazook" Anderson, who was tried on the charge of murder in the first degree for having shot and killed Mrs. E. S. Gordon of North Bend at Marshfield, May 9th. The jury was out seventeen hours, the case having been submitted to them at 5 o'clock Thursday and the verdict being reported at 10 o'clock Friday morning, and at 4 p. m. the same afternoon, Judge Hamilton sentenced Anderson to five year's imprisonment.

Attorneys Hammond, McKnight and Sherwood who represented Anderson, announce that they will appeal for a new trial, and declare that they are confident that Anderson will be acquitted on a second trial.

Attorneys Brown and Liljeqvist who prosecuted the case, are satisfied with the verdict although they had confidently hoped to secure conviction on the charge in the indictment, murder in the first degree.

In case, there should be a second trial, E. S. Gordon, the par amour or husband of the dead woman, will be undoubtedly called in as a witness.

Direct Election of Senators

It is regrettable that the Chicago convention rejected direct election of senators. Inasmuch, the platform fails to voice the sentiment of the masses of the Republican party. Every time any part of those masses get a chance to express an opinion on the subject, they declare overwhelmingly for it.

In the late balloting in Oregon nearly 70,000 voted for and only about 21,000 against Statement No. 1, a measure in line with direct election of senators by the people. The result, as well as when other opportunities for expression have been offered, leave no doubt of an overwhelming sentiment for the plan. The national house of representatives has five times declared for it, three times when it was Republican. The legislatures of many of the states have repeatedly pronounced for the plan. If left to a vote of the American people, it is absolutely certain that the verdict for it would be 10 or 20 to 1.

It is a proposition without a single argument against it, and in support of which, a multitude of sufficient reasons can be advanced. It is opposed only by United States senators themselves, by such others as hope to sneak or buy their way into the senate without running the gauntlet of the people's ballot by representatives of predatory wealth who want the rich man's club maintained as at present, and by politicians who profit out of legislative elections of senator.

In this respect, the Chicago platform is disappointing, for it was hoped that both great conventions might declare for it, and thereby hasten adoption of a plan that would drive Hopkins, Platt, Scott, Elkins, Aldrich and the other money changers from the temple. It emphasizes the need of clinging more steadfastly to the Oregon plan as offering the only escape from the present arrogant and imperial senate.—Journal.

Grover Cleveland Dead.

Grover Cleveland "who was the only surviving ex-president died at Princeton, N. J. Wednesday of last week and was buried Friday. Mr. Cleveland was born in 1837, making him 71 years old at the time of his death.

In many respects he was a unique character, and was a man of marked ability in more ways than one. He was the only democrat who has held the office of president since James Buchanan and was alone in the distinction of having been once elected, once defeated, and again elected to the office of president.

Mr. Cleveland was a man of strong personality and was a profound scholar and diplomat.

He was a democrat of the old school and was not at all in sympathy with the Bryan movement.

Mr. Cleveland will be remembered in the world, more for his honesty of purpose than for his great statesmanship.

The funeral was held Friday at his late residence in Princeton, N. J. and was a quiet but impressive affair. President Roosevelt and wife were in attendance at the funeral, as was also Secretary Loeb, Chief Justice Fuller, Secretary Cortelyou, Hilary A. Herbert, secretary of the navy under Cleveland; Judson Harmon, of Ohio, attorney-general under Cleveland; Governor Hoke Smith, of Georgia, secretary of the interior under Cleveland, David R. Francis, of Missouri, also secretary of the interior under Cleveland, Governor Franklin Fort, of New Jersey, Governor Chas. E. Hughes of New York, John Hays Hammond, the mining engineer who was a close friend of Mr. Cleveland, and many other distinguished men of the country.

REAL SEAMANSHIP.

A Thrilling Story of Maritime Adventure and Coolness.
