



COOS COUNTY LEAGUE DEFEATS BANDON

Disgraceful Scene on Part of Marshfield's Policeman Spoils Days Sport

GAME RESULTS IN A SCORE OF 3 TO 2

Several hundred enthusiastic Bandon fans journeyed to Marshfield Sunday when our ball tossers were beaten by the score of 3 to 2. Much Bandon money was offered at even and a few bets were made at odds of 2 to 1 on Bandon, but it is estimated that more than \$2,000.00 of offered Bandon money was turned down by the Marshfield sports, who, seemingly lacked confidence to support their team with cash.

The game was a good one and well played. Bandon played better ball up to the 8th inning, when a streak of bad luck filled the bases and with two strikes called, Kelly, the North Bend wonder, brought over to help Marshfield in this crucial game, batted a two bagger bringing in two runs, making the score 3 to 2. Up to the 8th inning the score stood 2 to 1. Peralta, imported from the Coquille team to aid the Slough City's faltering veterans, made the first run for Marshfield in the second inning after Ralph Myers had brought in the first score for Bandon. Bandon made one in the 8th inning on Causley's 3rd base hit. In the 8th inning a very regrettable exhibition of general rottenness on the part of the Marshfield management occurred when they attempted to coerce their umpire, a regular member of the Marshfield team, named Goldie, to allow two extra runs clearly not earned. Goldie, however sent the men back, thus partially redeeming a record filled with errors and showing that his mistakes had been of judgment rather than of intention. Page of Bandon, who umpired jointly with Goldie, gave entire satisfaction to both sides. During the chewing match that ensued upon Manager McKeown's insistence that he be allowed to dictate the decisions of his own umpire, the Marshfield police force in the person of a very contemptible individual named Condon, appeared and proceeded to shoot things up generally. The scene that took place there was regretted by Marshfield and Bandon people alike; with expressions of maniacal rage, the officer who appeared to have gone insane struggled up and down the field flourishing an automatic Colt in the attempt to shoot somebody, and no doubt would have succeeded, had he not been forcibly restrained by dozens of his townsmen who knew of his insane disposition under conditions of excitement, and in desperation forced his gun hand into the air and rushed him off the field. The grand stand filled with screaming women and crying children was with difficulty restrained from a mad stampede that might have cost lives but for the cooler heads of others.

Both teams played well and with the exception of third baseman McCutcheon's holding Causley down when the latter slid to 3rd, spoiling a home run, there was a good exhibition of sportsmanlike ball.

WILL CONTINUE STANDARD CASE

Attorney General Orders Further Prosecution of Standard Oil Monopoly

WILL FIGHT TO THE BITTER END

Although the United States Circuit Court at Chicago set aside the \$29,000,000 fine imposed against the Standard Oil Co. by Judge Landis, the fight against the big corporation will be continued and President Roosevelt will put forth his best efforts to bring the monopoly to time. He stated that there was no question of the company's guilt and directed his Attorney General, Mr. Bonaparte to proceed against them with all vigor, and United States District Attorney Sims is doing everything in his power to bring the big concern to time and has recently given out the following statement:

"The government will file a petition for a rehearing in the Standard Oil case before the circuit court of appeals within 30 days. If that petition is denied, the government will push the prosecution of all the cases against the Standard Oil company. The fight has just begun."

It is supposed that Sims received his instruction from Attorney General Bonaparte, as he announced recently that he could make no statement until he had conferred with Bonaparte.

The first new cases to be taken up will be those in Tennessee. The trials will be held at Jackson, in that state November 8. These cases involve 1,500 counts and will be prosecuted by Special Counsel James H. Wilkerson. The action will be pushed forward as rapidly as possible.

Attorney-General Bonaparte has wired District Sims as follows: "I feel that you and your assistants have done everything possible to protect the interests of the government and promote justice. I will write to you fully on the subject as soon as the opinion comes to hand."

Wilhelmina Makes First Trip

Charles Thom's new gasoline boat the Wilhelmina arrived in Bandon Wednesday on its initial trip from Coos Bay. As was announced in a former issue of the Recorder this ship is to run between here and Coos Bay in connection with the Alliance which makes regular trips to Portland, thus giving Bandon direct freight rates with Portland and making a big saving amounting to \$1.50 per ton. The Wilhelmina carried about a hundred ton on its first trip and her capacity is nearly double that amount. She left this morning for Port Orford, however, she will not make regular trips to that Point, but goes this time because the Enterprise is laying up for repairs.

The new boat is a beauty in every respect and will be welcomed on this run by business men who are interested in cheaper freight rates.

The boat is solidly built and is propelled by two powerful gasoline engines, each of which is 75 horse power engine, but tested 85 horse power. The boat is strong and is so built as to draw but little more water when loaded as when empty. She draws about five feet of water fore, and seven feet aft when empty, and with 100 tons she drew only a little over five feet fore and seven feet-eight inches aft.

An Economic Virtue.

We hear much at colleges and universities of the so-called science of economics and the student of agriculture must, he is told, study well abstract as well as concrete economics in agriculture. In several senses this is true. If there be a science of economics it should shed its light on agriculture as well as on commerce and manufacturing. But there is one principle which is of the highest economic value and but little is said about it even in books or by teachers; we refer to honesty, says the Dairyman.

The farmer must be honest with his soil, play it no tricks, give it no neglect, be absolutely honest in rendering it an equivalent for what it does for him. In like manner he must be honest with his animals, honest with the trust they repose in him as a friend, guardian and protector.

He must be honest with the crops he raises, that they shall be given the chance to be the best of their kind.

He must be honest with his wife and children, his hired help, that they be accorded the fairest treatment possible on his part.

He must be honest with his word, even to the extent that he swear to his own hurt.

He must be honest in his dealings. In short to be a dishonest man in any of the foregoing particulars is to violate the central idea of economics.—Pacific Homestead.
