Coos Bay's "Oregon and Idaho Development League," which was organized as a side-show of the late lamented "Fair," endorses federal appropriations for Coos bay, Tillamook and the Siuslaw, but the Coquille river and bar are conveniently overlooked. Bah! Specs are not needed to see the jealousy of Marshfield these days.—Sentinel.

Yes Brother Dodge, we quite agree with you, Coos Bay is extremely jealous of The Coquille River Valley, and yet they well know that if the support they get from this valley were taken away, it would be all up with them. The jealousy, however, comes from the fact that Bandon, Coquille and Myrtle Point are all growing so rapidly and are becoming such important business centers, that they realize that it is only a matter of a few short years until they will have to look for new pasture. The towns of the Coquille valley can support themselves while the Coos Bay towns cannot, and we will find that when the federal appropriations are made, the government will look well to the Coquille river. All it needs is a united effort on the part of people and towns along the river.

The State Fair at Salem will be in session all next week and promises to be the biggest show of its kind ever given in the Northwest. There will be exhibits from all over the state and people from every corner will flock to that city to see what can be produced in Oregon, the coming El Dorado of the United States.

Mr. Harriman says he will build a railroad into this country if it can show him that it will pay 4 per cent dividend on \$5,000,000 for ten years. That would be \$200,000 a year over and above running expenses. Well we can show him that it will pay twice that amount if it comes to the proper places. Of course if he would build a line from Drain to Coos Bay only, and go no further it would not pay him, but if he comes on down and taps Coquille, Myrtle Point and Bandon, where the business for a railroad is to be had, then he would make 20 per cent on the money invested, but to stop at Coos Bay would be the mistake of his life. A road through this country should not stop short of Eureka, Calif., and if it were to go on to San Francisco, it would be all the more of a dividend paper, but what is the use in talking. Harriman is too wise a man to build a railroad with its terminus at Coos Bay, if he builds at all he will come down into the country where the business is to be had and not stop at a little old one horse place.

Orville Dodge, so well known in Coos county, is again at the helm on the Coquille Valley Sentinel, and his paper last week was certainly a credit to his ability as a newspaper man. The news columns were well filled with good live matter, and an increased advertising patronage was evident. Mr. Dodge says he will give the people of Coquille a good paper if they will give him proper support, and from last week's issue

it is evident that success will crown his efforts, as he had the advertising and the news.

Even though there was a money stringency in the country elsewhere, yet there is a great demand for Coquille river products as is evidenced from the number of boats that have been loaded during the past week along the river. The Fifield and Elizabeth have both gone to sea with full cargoes, and the schooners, Advance, Ruby and C. T. Hill have done likewise. Mr. Harriman does not know what he is missing by not getting his railroad here so as to get part of the business that is to be had from the Coquille Valley.

The Oregon State Fair opens next Monday, September 14th, and continues through the week. The showing of all kinds of products, as well as the livestock and industrial display and a great race program without pool selling, insures one of the best fairs Oregon has ever held.

Points d'Angleterre Lace.

Louis XIV., by the advice of his minister, Colbert, encouraged lace-making in France. The origin of the name "points d'Angleterre" is curious. Poison Rings.

The custom was adopted by the early Christians, and thus it has reached us in the present day, when the ring is placed upon the bride's finger with the words, "With all my worldly goods I thee endow."

Rings, however, have had other associations besides those of marrying and giving in marriage. Some Roman rings were hollow and filled with poison, obviously for the purpose of suicide, a crime then considered a virtue. A modern instance of this carrying death upon the finger is that of Condorcet, who when arrested by the notorious convention tore the jewel from his ring and drank the poison which lay in the hollow.
