Veterans Ask \$2 a Day

Indian war veterans of both Oregon and Washington will use their influence again this winter in an effort to secure the passage of a bill through the Washington legislature, allowing the gray haired survivors of early frontier battles \$2 per day for past services. At the present time all the remuneration received by the remaining handful of men who risked their lives 50 years ago for advancing civilization, is the \$8 per month federal pension. Congress, however, did not pass the pension bill till 1902, and it was a year later before any benefits were received from it. Now the Washington legislators will be asked to reward the few veterans still living a wage of \$2 per diem for the time they were in actual service on the frontier.
