New Captain For Alliance

Captain Edward D. Parsons, for years connected with the Pacific Coast Steamship Company, has been selected to succeed Captain B. W. Olson as master of the steamship *Alta ce* on the Portland-Coos Bay run. Captain Parsons will join the Alliance tomorrow and will relieve Captain Olson about December 11, when Captain Olson will succeed Captain Nelson on the *Nann Smith*. The selection of Captain Parsons to succeed Captain Olson came as a great surprise to local people. The intelligence was conveyed in a telegram received by agent H. W. Skinner this afternoon.

Captain Parsons has been identified with shipping on the Pacific coast for many years and is considered one of the ablest mariners on the northwest coast. For three years he was master of the *Pomona* on the San Francisco-Eureka run, for four years of the *State of California* plying between San Francisco and the Columbia river and was master of the *Geo. W. Elder* when it was plying between San Francisco and the Philippines as a government transport.

Recently Captain Parsons has been port captain and representative of the Alaska Cannery Association at Nome Alaska.—Times.

Poison Rings.

The custom was adopted by the early Christians, and thus it has reached us in the present day, when the ring is placed upon the bride's finger with the words, "With all my worldly goods I thee endow."
 Rings, however, have had other associations besides those of marrying and giving in marriage. Some Roman rings were hollow and filled with poison, obviously for the purpose of suicide, a crime then considered a virtue. A modern instance of this carrying death upon the finger is that of Condorcet, who when arrested by the notorious convention tore the jewel from his ring and drank the poison which lay in the hollow.
