### Roseburg Bonds Sold

Roseburg, Ore., May 10--The \$35,000 issue for street paving and for the construction of a new bridge over Deer Creek was awarded to The Douglas County Bank, of this city, by a committee of the council composed of Sam S. Josephson, Joseph Micelli, B. W. Strong and E. R. Hanan. That evening the council met and by a unanimous vote ratified the sale. The bank agrees to charge no interest until the bonds are delivered and also to bear the expense of printing the lithographed blanks. Following is a full text of--

### Art Exhibit Insured

Seattle, Washington, May 11--The art exhibit of the Alaska-Yukon-Pacific Exposition is now covered by insurance to the amount of \$1,500,000. This first policy was negotiated through the Lloyds of London and covers the principal part of the collection secured from European galleries.

The adjustment of insurance rates is satisfactorily determined, and insures the appearance of a number of rare and valuable art specimens which have not previously been exhibited in the United States. The Oriental art displays which are to appear in the Art Exhibit Hall of the exposition, will require the placing of other policies nearly equaling the European amount, and those will be taken out as fast as the exhibits are installed.

The Fine Arts Exhibit building of the exposition is a building of brick and steel construction, and is as near fire proof as is possible to erect. It is one of the permanent structures, and at the close of the exposition will be used as the chemistry school of the State University of Washington.

### Haskell Fraud Cases Not Ended

Muskogee, Okla., May 8--Federal Judge Campbell here today overruled the demurrers of the defendants in the so-called Mot Creek Indian land suits, brought by the Government against Governor Charles N. Haskell and other prominent Oklahomans.

The decision, involving, as it does the legality of millions of dollars worth of lots, created great consternation here. Not only are Governor Haskell and associates involved in the charge of fraud, but about 1500 subsequent purchasers of lots are vitally interested. Judge Campbell announced, however, that all innocent purchasers would be protected.

These suits were brought by the United States for the Creek Indian Nation, to recover for the tribe Muskogee town lots aggregating 3000 acres of land, and alleged to have been obtained by Governor Haskell and the other defendants by the fraudulent scheduling of "dummies."

Judge Campbell overruled the demurrers of the defendants to the petition for the Government, deciding the cases on their merits against the defendants, on the allegation that they obtained the lots by fraud.

Out of these civil suits grew the criminal prosecution against the Governor and six others, for which they were once indicted. These indictments were quashed at Tulsa recently, but a second grand jury has been called to meet in that city next Monday to reinvestigate the charges.

### Men Just to "Lend Tone"

Spokane, Wash.,--A meeting managed entirely by women, with women speakers, women's orchestra and women ushers, was held at the South Central High School tonight, and Mrs. Edith DeLong Jarmuth and Mrs. Cora Mellott, of Seattle, were the principal speakers. The meeting is held by the local branch of the Equal Suffragist Association, and the head officers occupied seats on the stage.

While men were welcome at the meeting they played no part in the evening's program, except to "lend tone" to the gathering. The two visitors from Seattle have been prominent in this line of work on the coast and were in the lobby at Olympia with Mrs. May Arkwright Hutton, of Spokane, at the time the Legislature was in session.

### Hains Guilty of Manslaughter

Flushing, N. Y., May 11--The jury in the case of Captain Peter C. Hains, Jr., U. S. A., charged with the murder of William E. Annis, August 15, 1908, brought in a verdict of guilty of manslaughter in the first degree this afternoon. The jury had been out four hours and the defendant was remanded to the custody of the sheriff for sentence Monday morning. It is expected that counsel for Hains will make the usual motion for stay of sentence and will take an appeal. The maximum penalty is twenty years imprisonment.

### Parrot Reported Burglary

Stafford, N. J., May 11--Investigating a burglary at the home of George Lukens, Detective Smith was told that, when a member of the family returned home on the day following the visit of the burglars a pet parrot said: "Get busy, robbers in the house."

In an interview with the bird, the detective declares, he was given such an accurate description of the burglars that he could recognize them at once, should they be fortunate enough to run across them.

### "Cig" Papers Saved Him

Harrisburg, May 11--Harry Brown a brakeman, was saved from death after a fall from a train by means of a tiny torch made of cigarette paper. Brown fell from his train near this city early in the morning and broke his leg. While lying on the track benumbed by cold and pain he twisted cigarette papers into torches, lighted several and attracted the attention of trainmen.

A few minutes later he was rescued from the track just before the train came.

### Weston Behind Schedule

Topeka, Kan., May 7--Edward Payton Weston, who is walking from New York to the Pacific coast, reached Lawrence at 5:30 this afternoon, making only a brief stay and continuing his westward journey to Perry, 16 miles east of here, where he prepared to pass the night.

He will leave Perry tomorrow morning and expects to reach Wamego tomorrow night. Weston expected to reach Topeka this evening, but could not, because of his late start from Kansas City.

Notice is hereby given, that the common council of the city at a regular meeting thereof upon the 30th day of April, 1909, did pass an ordinance, declaring and establishing Tuesday, June 1st, 1909, as a Special Election Day to vote upon the extension of the boundaries of the City of Bandon, for which election the following election board was named: Judges, M. Brenner, A. D. Morse and Charles Lorenz, Clerks, Ed B. Henry and George Manciet, which election will be held at the City Hall in Bandon, Oregon, and the polls thereat will be opened at 8 o'clock A. M. said day and remain open until 1 o'clock P. M., when the same will be closed until 2 o'clock P. M., when they will be opened again and so remain until 6 o'clock P. M., and then be permanently closed, and that at said election the question of boundary extension will be submitted separately to the electors of the city of Bandon, and to the electors of the territory so proposed to be annexed, and the question to be submitted at said election, is whether or not the present limits of the city of Bandon, as established by the Legislature of Oregon in 1891, shall or shall not be extended to conform to the following description, to-wit:

Beginning at the quarter section corner on the section line between Sections thirty-one (31) and thirty-two (32) in Township twenty-eight (28) south of range fourteen (14) west of the Willamette Meridian in Coos county, Oregon, running thence west on the quarter section line to the ship channel of the Pacific Ocean, thence in a northerly course along said ship channel of the Pacific ocean to a point due west of the north line of section Twenty-five (25) Township Twenty-eight (28), south of range Fifteen (15) west of the Willamette Meridian in Coos county, Oregon; thence east along the north line of said section twenty-five (25) and the north line of section thirty (30) to the northeast corner of said section thirty (30), in township twenty-eight (28) south of range fourteen (14) west of the Willamette Meridian in Coos county, Oregon, thence south along the east line of section thirty (30) and thirty-one (31) township and range aforesaid to the place of beginning.

That the qualified voters residing within the bounds of the above described territory, are hereby invited to attend the polls upon the said first day of June, 1909, during the hours above named and vote upon the measure above set forth.
