The Myrtle Point Enterprise says: "Fin Hartley, who is farming the Bender place just south of town, brought in a bunch of oats this week that would astonish the natives of some of the eastern oat growing states. The bunch was as large as an ordinary sheaf and measured seven feet in height. The heads were well developed and most of them were fully a foot in length. Mr. Hartley has about eight acres of which the sheaf is a fair sample. He is cutting it for hay and expects to get about five tons to the acre, which at the present price of \$12 per ton will bring \$60 an acre or \$480 for the crop. If threshed it is believed the grain would go 100 bushels to the acre."

Oregon Delegation Not Satisfied

Washington, July 30—Representatives Hawley and Ellis were both for the adoption of the conference report on tariff bill. In their judgment it is less satisfactory than the bill which they might draw if given authority, but all things considered, they are fairly well satisfied. They believe that it this bill should be defeated it would be followed by another bill which would pass, which would make even greater reductions on Oregon products than are made by this measure. In view of the strong sentiment in the House favoring free lumber, they consider themselves fortunate, to get as much as \$1.25 duty.

The statement given publicity this morning that Senators Bourne, Borah, Heyburn, Jones and Pike had acquiesced in the cut of lumber from \$1.50 to \$1.25 is said by Senator Bourne to be incorrect. A meeting of these Senators yesterday demanded by the President resulted in no definite action, the members desiring to hear from their constituents before reporting to the conference committee their final views. It was without considering the wishes of lumber states that the Senate conference accorded to the wishes of the President and reported the \$1.25 rate.

Senator Bourne said today that this rate was not satisfactory and if the lumber interests of Oregon informed him that the lowering of the rate would vitally injure the lumber business of the state he would vote against the adoption of the conference report.

Pioneer is Dead

The Coquille Sentinel says: "The funeral of Washington L. Hayter was held at the Upper Fishtrap cemetery last Friday at 2 p. m., he having passed away on Wednesday July 21, at the age of 84 years, 4 months and 9 days. He came to Oregon in 1854, first locating in Polk county. He came to Coos in 1865, first settling on Fishtrap, afterward living at different places in the county, his wife having passed on before some 24 years ago in Coquille.
