Telegraphic.

LONDON, 5.—Special correspondent telegraphs from Bouillon that battle of Sedan and capitulation of French army leaving road to Paris open, an advance in force has again been made.

BERLIN, 5.—The rejoicings in this city Sunday were on an immense scale, being the greatest the city ever saw.

STUTTGART, 5.—A large meeting of citizens held in this city, adopted resolutions in favor of North and South Germany being made a single Federal State, with one army, one Parliament and one system.

NEW YORK, 5.—Dispatches from Paris say that people are no longer seen in the streets. Dispatches from London say: Republic soon proclaimed in France.

PARIS, 5.—McMahon not wounded, though fatigued; is in good health. Chambers will now discuss.

LONDON, 6.—World's cable special says: Besmark telegraphed from Venders on 5th Sept. I have spoken to Napoleon about peace, but he answered "as a prisoner; he had no power—all depends on the Regency at Paris."

PARIS, 6.—Prussians have appeared in detached bodies at several points within arrondissement of the Garde Nationale. Volunteers are hastening to meet them, and a collision is inevitable.

LONDON, 6.—French army ordered to retire on Paris. Prussians entered Rhemes; bombardment of Metz began on Monday. Prussian's advance said to be at Soissons, marching rapidly on Paris.

PARIS, 7.—Evening.—No one knows what is to be done—there is no fire; no spirit in the people; the cry is that the Prussians are approaching, and the government is busy distributing places to-day.

WASHINGTON, 8.—Under instructions from the U. S. Government, Minister Washburne recognized the new government yesterday, and tendered congratulations of the President on the formation of a Republic.

LONDON, 8.—Bazaine still negotiating for the surrender of Metz. French prisoners in Germany enthusiastic at the Emperor's deposition. Emperor at Wilhelmsole treated with attention and courtesy.

BERLIN, 8.—All thoughts of admitting mediation or interception abandoned, for the present at least.

PARIS, 8.—Evening.—French armory open, making and repairing arms. Prussians are expected before the walls Friday—to-morrow.

PARIS, 8.—The enemy advancing on Paris in three corps De Armees, one of which has arrived at Soissons. Advance guard of this corps summoned Laon to surrender.

LONDON, 8.—Dispatches from vicinity of Metz announce capitulation imminent; travelers arrived at Brussels from Luxembourg, say surrender already effected.

PARIS, 8.—Papers say America merits praise of the civilized world for recognition. She is for us a living lesson and constant instructor.
