FACTS AND FIGURES.

In Germany's public schools stuttering boys are over twice as numerous as stuttering girls.

During the past twenty years 328,000 divorces have been granted by the courts of the United States, 90 per cent. of them to women.

Artificial pearls, of which strings of pearl beads are made, are manufactured from the scales of the fish called bleak. The fish are so small that it takes 4000 of them to produce a pound of scales, and fishermen in parts of France devote their entire time catching the little fish. From the scales is obtained the so-called essence of pearls, which gives the luster resembling a real pearl.

When very delicate and accurate wire is required to be made, the metal is drawn through holes drilled in jewels, which are harder than the metals. A piece of silver has been drawn through a hole in a ruby .0033 of an inch in diameter into a wire 170 miles long. Had the same wire been drawn through a hole in any soft metal the constant rubbing would have enlarged the hole, and thus made the wire thicker and shorter.

A piece of gold of the finest standard can be beaten into a leaf that will cover a space 651,590 times greater than its primary surface, its average thickness being 1-582,000 of an inch. This is an acknowledged fact, but if any one doubts it all he has to do is to take some pure gold and try it. After he has beaten it until it has expanded the above number of times the best way is to divide an inch into 282,000 parts and measure the thickness of the leaf.

Among the many remarkable inventions at the late paper exhibit at Berlin was a set of paper teeth, which were made in 1878 by a Lubeck dentist. They have been in constant use for over fourteen years and are in first-class condition.
