Separate Ballot Taken in Both Houses. Corbett Lacks Ten Votes.

Both houses balloted separately for U S senator Tuesday. The result showed that nobody had a majority in either house. In the senate the vote was as follows:

This gives Corbett a total of 36 while 46 are required for an election. The first joint vote will be taken tomorrow.

Both of Lane county senators and Representatives Brattain and McQueen voted for M C George while Representative Gray voted for Bennett.

TO EXTEND THE FISHING SEASON.

Senator Reed has introduced a bill into the legislature extending the open season for fishing on coast streams and it will probably be passed at the present session. The provisions of the bill are as follows:

Section 1. That section 2 of an act to amend sections 3 and 6 of an act entitled an act to protect salmon and other food fishes in the state of Oregon, and upon all waters which the state has concurrent jurisdiction, and to repeal sections 3489, 3490, 3491, 3492, 3493, 3494, 3495, 3496, 3497, and 3498 of Hill's annotated laws of Oregon, filed in the office of the secretary of state February 22, 1893, be amended to read as follows:

Section 2. It shall not be lawful for any person or persons to take or fish for salmon in the waters of the Nehalem, Tillamook, Nestucca, Salmon, Siletz, Yaquina, Alsea, Siuslaw, Umpqua, Coos bay, Coquille, Sixes, Elk, Clifton, Rogue river, Windchuck, or any of their tributaries, from the twentieth day of November until the twentieth day of December, or between the fifteenth day of April and the first day of June.

Section 3. In as much as the present law is ineffective for the purposes for which it was intended, this act shall take effect from and after its approval by the governor.

DRIVER'S REPORT.

Considerable has been said about Senator I D Driver's remark on the floor of the senate the other day, when some member facetiously introduced a resolution that copies of the session laws of 1897 be furnished for the use of the senate. Rev Mr Driver said they would have to go to hell to get the session laws of that year. There is a fine bit of repartee connected with the incident, which has not heretofore been published. One of Mr Corbett's supporters approached Rev Driver and said they had decided to send him and Senator Reed after the session laws referred to. Mr Driver retorted, "That it was a wise suggestion, for if any member from your side should be sent, he would never return."
