The Good Templar Celebration at Dallas, for similar reasons to those above stated, was not so largely attended as was anticipated. Delegations from each of the lodges in the county were present, and altogether there were about 120 members in regalia in the procession, each delegation being recognized by a banner bearing the name, number and motto of their respective lodges.

The car was admirably arranged and the young ladies who represented "Liberty," "Justice," and the 37 States reflected much credit on the judgment and good taste of the committee who selected them.

A dispatch from Jacksonville, dated July 4th, says: On Monday last W. A. Gibson, of Jump Off Joe, in this county, sustained a fracture of both bones of the right leg by being dragged by a colt which he had lassoed. Amputation was resorted to and he died under the operation yesterday.

OREGON NEWS.

According to the Farmer, a difficulty occurred on Marion Square, Salem, last Saturday afternoon, between two men, Perry Herren and Leonard, in the course of which three pistol shots were fired by Leonard, one of which struck Herren in the calf of the leg, inflicting a flesh wound. Herren thereupon seized a stone, and struck Leonard a severe blow upon the head, knocking him down.

We learn that two men were injured at Albany last Friday by the premature discharge of a cannon. Their faces and eyes were badly burned, but hopes are entertained that they will recover without the loss of sight.

Quite a sharp frost prevailed in several portions of Marion, Linn and Benton counties on Thursday night of last week.

In the Multnomah Circuit Court, the jury in the case of George Oakes, indicted for rape, could not agree, and were discharged. They stood seven for conviction and five for acquittal.

The Roseburg Ensign of last Saturday says: On Tuesday a young man named George Bausby, of Green Valley in this county, was left in charge of a four horse team attached to a reaper, when the team became restive and started, throwing the young man upon the sickle, by which a portion of one hand was cut off, and one of his legs so badly lacerated that amputation will be necessary.

Two citizens of that place could not agree upon some point, when one of them in a gentle manner tapped the other over. After being informed of the fact several times the vanquished gentleman was satisfied that he had been hit.

The San Francisco Pacific says that common wine, in the wine growing region of California, is cheaper than milk and more freely used. In some places the wine is thirty cents a gallon, and milk fifty. One large wine raiser offered his lot (between four and five thousand gallons) at twenty-five cents a gallon, if any one would take it. In the best grape growing region of the State, grapes to be used in making wine, sell at the mill in loads, for one and a quarter cent per pound.

California are sending "lots" of watermelons to New York by the Pacific railroad. Says the San Francisco Bulletin: California merchants and manufacturers who are alive to the situation will find, whatever their practice has hitherto been, that they must employ commercial travelers to represent them and solicit orders for their wares throughout California, Oregon, Nevada, Idaho, Montana and Utah, if they want to extend their trade in these fields, or even to retain what they already have.

The Olympia Transcript understands that the price of lumber has fallen so much lately in California, as to affect some of the Sound lumbermen, and in consequence some of the mills are running only one set of hands, and stopping at night. The same paper says a man by the name of Wm. Wright, residing in Puyallup valley, committed suicide a few nights since. He first attempted to cut his throat, but failing in doing so, he procured a rope and hung himself. No cause is assigned for the act.

Larger crops will be raised in Poise valley this season than ever before, but in Payette valley they are almost wholly destroyed by the grasshoppers. A correspondent writing from Delta, W. T., to one of the Portland dailies, closes by saying: I think now that we will not raise more than half a crop of anything, unless it shall be of corn, which looks well so far. Very dry, smoky and warm weather.
