The school has been a success in every particular, and the children are so endeared to the teacher that the town bids fair to become depopulated of urehins if they can obtain boarding places at Sumner, where Miss L. commenced a three month's term yesterday. On a motion by Master George Bunch that Miss L. be our teacher for the public school next spring, every child jumped to his feet.

The Mormon Conspiracy.
Salt Lake, Nov. 23.—The case of Deputy Marshal Vandercook, charged by the police with lewdness, was taken before the Third district court to-day on habeas corpus, claiming the ordinance is invalid. The hearing is set for Friday. Evidence accumulates that the church agents for months have been employing harlots, spies and procurers to entrap sinful Gentiles. A copy of a contract with one San Francisco harlot has been procured, whereby she was to come to Salt Lake and engage in certain transactions, "the nature of which she knows and fully understands," and for which she received \$700 in cash and \$1000 for every prominent Gentile or Federal official entrapped. Women of the town came from other places, as is supposed, on similar contracts, and on arrival took private houses and flooded the mails with notes to men whose names were furnished to them, asking them to call. Two more arrests were made to-day but proceedings were stayed, and no further arrests will be made until the district court decides the habeas corpus case.

A Trip to Bandon.

Ed. HERALD:—We boarded the steamer Annie on the 22nd inst. for Bandon for a stroll on the lower Coquille. All went merry till we got to Parkesburg, which is quite a burg, too. Passing that place and the deserted fisheries, we soon arrived at Randolph which is on a slough, and to reach which you have to round up right-about face some few hundred yards. In looking down the river from this point we could see the breakers and we supposed a halt would be made for the night, as it is an unusual thing for the river to be so rough. The Captain's idea was different, and as soon as all was ready started again. All went well till we met the foaming billows of an unusually heavy southwest wind, and for the next two miles the nervous system of passengers would have been terribly shocked only for the mirth-provoking Rattling Jack, who happened to be on board. At Bandon we were taken charge of by Mr. Mahaffey, proprietor of the Lewisport hotel, and we must say we fell in good hands. Everything looks lively around Bandon, many new buildings being under way. The new proprietors of the town are not selfish, but give encouragement for the settlement of that part. Inducement are held out to strangers that I have not seen at other points. The roughness of the sea was immense, the old Pacific being seemingly badly troubled. A boat was seen outside with five men on board. She lowered her sails, and commenced pulling from the shore. By some means she was lost sight of and seen no more. What the fate of the men is, is not known. The Ocean House is a splendid place to get a fine view of the ocean. On the whole we are not sorry that we visited Bandon; it was worth the trip.

The secretary of state has received by wire and otherwise a statement of the census of 1885. Following is the report of the secretary of state on which Cox's bill for a reapportionment of the state into legislative districts is based: Baker, 7000; Benton, 6008; Clackamas, 10,035; Clatsop, 10,240; Columbia, 3013; Coos, 5795; Crook, 2522; Curry, 1168; Douglas, 8053; Gilliam, 3555; Grant, 4882; Jackson, 8738; Josephine, 2727; Klamath, 1578; Lake, 1536; Lane, 10,068; Linn, 11,431; Marion, 15,453; Morrow, 2716; Multnomah, 35,732; Polk, 6316; Tillamook, 1589; Umatilla, 10,920; Union, 9588; Wasco, 7820; Washington, 8243; Yamhill, 8164—total population, 198,692. In 1880 the total population of the state was 174,768. The increase, therefore, since 1880, has been but 21,000 persons in Oregon.
