A new steamship line is to be started up between San Francisco. The line will be in running order in October, with seven good steamers.

A move is on foot among the colored people of the United States to erect monuments to their benefactors, to cost \$100,000. The site chosen is Washington, D. C.

The Union Pacific railroad company are going to have a list of the saw-mills with the output of each printed in pamphlet form together with their charges for freight. These are to be sent to all the barren districts from Texas to Iowa with a view to getting a market for our lumber. This is commendable and other roads should follow suit.

Up in Wisconsin whisky farmers are common. A recent dispatch from that state says: The internal revenue officers are out to make a raid on a large number of illicit whisky stills that are reported to exist in the woods in Manitowoc county. They have raised their own grain for whisky distilling purposes, and readily disposed of their manufacture to the saloon keepers. One of the principal secret distilleries is run by an old woman. She is said to have made a fortune out of it. A. Kauffman, of Manitowoc county, has been arrested, and his still has been demolished by the revenue officers. Other arrests will follow. It is said that the business has been carried on by a large number of so-called farmers.
