

TRIAL OF GILMAN.

Guilty of Murder in First Degree.

To be Hanged December 13, 1890.

The trial of John F. Gilman for the murder of Mrs. Eatonhover and five-year-old son was commenced last Tuesday morning before the circuit court. Forty-seven persons were examined before a jury was had. These consisted of B. A. Adams, B. F. Ross, T. A. Armfield, N. U. Martinson, George M. Sealy, C. E. Houser, H. W. Holverstott, G. W. Skaggs, Wm. Barkis, E. W. Guptill, S. J. Hulbert, James Masters.

On Friday, before, defendant had tried to get a continuance for reasons embodied in affidavits by himself as to his sanity; that he expected to prove at next sitting of the court by Dr. Vance, Wm. P. Skelly and Laura Lawrence that his mind was unsound. The judge overruled the motion. There were a large number of witnesses examined, but as the testimony was so nearly alike, we give only that of some of the principal ones.

Testimony of Mr. Eatonhover.

I am husband of the woman killed and father of the little boy. I came down the river from where I worked on foot, and got to river opposite Gilman's about 10 o'clock. I called out thinking wife would bring boat over, but Gilman answered and came over in boat. Gilman complained of being sick. I offered to row the boat, but Gilman said he would paddle. He had a club in the boat and I asked him what it was for; he said to help him along. I fastened the boat when we landed and we went up the bank together. When we got in the corral Gilman struck me on one side of the head and almost knocked me down, and then another on the other side of the head, and then clinched, and both fell down and rolled over and I managed to get away. I ran through the bars and he caught me. I broke away and went to house to get tool to defend myself, and he caught me and began stabbing. He tried to cut my throat. Pretty soon Mrs. Gilman came up. I broke loose and tried to run down the road, I stumbled and fell and he caught me again. We were down rolling round, and I got the knife away from him, and I finally got up and ran to the river. I made two licks and got into Gilman's boat and got across the river to Mr. Tucker's. Mr. Tucker helped me out and I was sick. When I was first struck on the head I cried "help, murder. The first I saw of my wife and child I found them, wife and child, buried near a tree, Sunday forenoon. Gilman was up where I was working on Thursday. I asked him how the folks were getting along, and told to tell them I would be home Saturday night. We had some little disputes with Gilman in regard to the berries and fruit on the farm. Gilman did not object to my staying on the place, but Mrs. Gilman did. My wife went with me when I left for work—part of the way—and took back the boat. I took the knife. I wrenched it out of his hand. My boy was five years old and could talk.

Cross Examination.

I was about four rods from Gilman's barn when first attacked. I had just got through the bars and he caught my clothes. I pulled away and he came through and caught me; I was reaching down under the house to get tools; he had hold of me and pulled me down. I was first attacked in the corral. I ran through the gate—he after me. We were walking side by side when he first struck. I could not tell what with. I clinched him and hallooed "murder." He pursued me up near the house and had the knife and cut me. Along the last of the fight Mrs. Gilman came; I saw her have hold of Gilman's hand. I do not remember of telling Dr. Sponogle "that if Mrs. Milman had not helped me I would have been killed." I have no financial interest in convicting Gilman. I have sued him for damages for the killing. Never had any particular trouble with him. He was always friendly after these quarrels. He had some petty quarrels with my wife; they always made up after them. I don't know any motive for killing Heuckendorff's, where I worked, was five or six miles from Gilman's. He is a son-in-law of Gilman's. He had a club in the boat. I don't know why I asked him why he had the club. He threw that away before the difficulty commenced. It was about 30 yards from his house and a short distance from my house. It is a fact that prior to this time my family were poisoned. I don't know if I had any other quarrels about the place. I had leased the

place for four years. Mrs. Gilman once said she would see that we did leave. I received two blows; the first sounded as if it was a bottle. I thought it was a bottle but could not find any. It dazed me.

Testimony of H. B. Tucker.

I reside on the Coquille. I know John Gilman and Eatonhover have known them about 18 months I live just across the river from them. On the night of the 13th of July, a neighbor said some one was crying "murder and help." I put on my boots and went out, I could hear talking. After I got to the river I could hear old lady Gilman talking loud; I could not hear what Gilman said. I saw wounded man in a boat. Mrs. Gilman said: "He's over;" and after a little she said, "John, you know you did it." Eatonhover was cut in the throat and was bleeding and vomiting; he could not stand up; I had to pull him out of the boat. It was about 9 o'clock. It was not a very dark night. I sent a runner down to Mr. Roy to ask for a doctor and officers. The light was burning, and as soon as the Gilman's got to the house they lowered the light. I saw Eatonhover's boat on the other side of the river on Friday. There were no tracks leading to the boat. I saw Mrs. Eatonhover and the boy on the Monday evening before; they were at my house. My house is about 600 yards from the Gilman house.

Testimony of Mrs. M. Willard.

I reside on the Coquille river; have lived there 16 years. I live on the opposite side of the river from the Gilman house. On Saturday, July 13th, me and boy started out to milk and heard cries, "Oh, Oh, help." I thought first that it was on the landing. I ran up to Mr. Tucker's place and called them out; we could hear noise and cries, but could not make them out; then heard cow bells and trouble with the cattle, and then Mr. Tucker put boots on and I went home. I went back and found Eatonhover prostrate on the ground, and I thought he was gasping his last. As if they were searching in the garden—and I heard Mrs. Gilman say: "I'll not tell unless I have to; but John, you know you did it." Eatonhover was bleeding and could not stand without help. It was about 9 o'clock and was not very dark.

Cross Examination.

Mr. Tucker was with me all the time when I was on the bank of the river. I heard something splash in the water. Miss Mitchell and I thought it was cooling over. It would be considerable satisfaction to see him hung. My feelings would not cause me to deviate from the truth.

Testimony of Mrs. J. Morgan.

Have lived on the Coquille about two years; have known John Gilman about nine years; know Eatonhover and family; reside about 1 1/2 miles from Eatonhover place; I remember the trouble. Saw Mrs. Eatonhover and boy on Thursday, 11th of July, they left about 4 o'clock p. m. Mrs. Eatonhover and boy left to go home. She said it was her intention to go up Saturday evening and bring Eatonhover home. She said she was going up the river in a row-boat.

Testimony of Joseph Johnson.

I have lived in Coquille City four years; am acquainted with parties to this case. I remember the trouble. I went up to the house of the defendant the night of the difficulty, with others, and found him at his house in bed with his clothes on. I asked Gilman what had become of Mrs. Eatonhover and child, and he said he did not know unless they had gone up the river after Eatonhover, as they had said they were going. He said he saw them Friday morning and they told him this. I took this defendant to Coquille that night. San Johnson, Deval, and Boyrie were in the boat with me. Mrs. Eatonhover and child were discovered Sunday morning about 9:30 o'clock. I saw the woman and child in one grave about 100 yards of Eatonhover's house.

Testimony of S. P. C. Johnson.

I live in Coquille City, and remember this difficulty. I went to Gilman's house on Saturday evening. I took my brother and others with me and found him in the house; he was lying in bed with his pants on. I opened the front door; they were lying on bed. I told them what I had come for, and asked him about Mrs. Eatonhover and boy. He said the last he knew she was going up the river for her husband, and that she might be at Mrs. Smith's. I think he said he saw her last on Thursday.

Testimony of John Baker.

Remember the difficulty; went up and helped arrest defendant. Evidence same as preceding witness as regards what defendant said about Mrs. Eatonhover.

Testimony of David Hutchison.

Reside in Marshfield; remember the circumstance of this trouble; went over to Coquille City and came back with Gilman, Sheriff Harlock and Dr. Cook. Gilman said he did not think there was any danger after passing China Camp creek. There were no threats to make him confess. Noticed his

pants were stained, and asked him if it was blood on his pants; he said yes. Asked about blood in house. He said he killed them at the spring; he said he knocked her down and the boy ran away and he ran after him and choked him; he said he was a smart little fellow and might tell; he could talk and tell what he saw.

Cross Examination.

Saw Gilman the first time in jail; heard him make another confession. He was in jail and a crowd outside wanted him to own up; they said they had no objection to his coming over if he would tell all about it. Several told him to tell the whole thing. If he did not tell it all; he was liable to be hung. There were about 100 men outside of the jail. He did not appear to be worried. I told him he had better tell. The old woman spoke up and said: "Yes, John, tell it all, you know you done it; and clear me." I went out and when I came back he was telling it again. Did not hear anybody tell him they would hang him. I said I was satisfied that you did the killing, and you killed Morris, and he said: "Will admit I killed Morris, but will not admit this killing." Bill Copley came in with a rope. Gilman was taken out of Coquille City in a wagon; we hurried out as fast as we could. Was not much afraid and don't think he was. The confession was made three or four miles out or Coquille City.

Joseph Johnson Recalled.

Gilman made a statement to me about the killing. Four of us were present. Asked him if he carried the woman away alone? He said "Yes, I did it, killed her in the gulch and killed the child to prevent its telling. The child ran toward the house and I caught it and choked it and broke its neck." He said he intended to murder Eatonhover. Never intended he should reach the house. I did not hear any threats; did not see any rope until we were going out. It was not a rope to hang anyone, but was a little rope five or six feet long. Was friendly with Gilman until this happened. Tried to defend him.

H. B. Tucker Recalled.

Saw the defendant at Eatonhover's house Friday evening before the trouble. Had been out to my chicken corral. Looked to see if the woman had come home, and saw him walking round the house with a tin bucket on his arm. I had seen him there frequently.

San Johnson Recalled.

There was a rope in jail when Gilman was there. It has been there a year, and is there yet. The wharf threatened to give way and I got it to tie up the wharf in high water. I bought it and put it there, and it is there now. Heard no threats, and saw no rope then.

Testimony of Andrew Jackson.

Have lived on the bay 21 or 22 years; know Gilman; had a talk with him about this killing on Wednesday after he was put in jail. There was no threat of any kind. I went in there and said to him: "Old man you are in a pretty bad scrape." He started by saying that they were trying to get his property. I asked him if he was not sorry he killed the boy. He said he was sorry at first, but if he had it to do over again he would kill him. He said he strangled him with a string, and then put his head across his knee and broke his neck, and he showed me how he did it. Asked him if he killed George Morris, and he said "no." He asked me if I thought they would mob him? I told him I did not know.

Testimony of Capt. James Hill.

Reside on Coos bay; saw defendant in jail for first time. Had a conversation then with him. Samuel Davis and I went to see him. The old gentleman was looking through the wicket. He said he was feeling pretty sore; said that he had a fight with Eatonhover; said he killed the woman, but wouldn't tell why but it would come out at the trial; said he attacked Eaton because he said he would pitch into him. I said, "They will hang you as sure as God," and asked him if he had no remorse? He said it was hard to kill the boy; he was a pretty boy. Samuel Davis was there and heard it all. It was about a week after he was put in.

J. J. BAKER RE-CALLED.

I had a talk with Gilman the night he was arrested. He said, "I hurt Eatonhover; all that saved him was that I got hold of the wrong knife." I told him the people thought they both did the killing. He said: "I did the killing. They can stretch my neck, but if they hang the old woman they will hang an innocent party."

SAM JOHNSON RE-CALLED.

Had a talk with Gilman on Monday after his arrest; took him up to the court, and he wanted Siglin for attorney, so the examination was put off. We went into the jail and his son said, "you had better have your preliminary examination and have it over." He said: "I actually killed the woman and child. I don't care about the woman, but

the poor little child." On Sunday night my brother asked him if he slept soundly after killing that poor little boy, and he said, "Yes, why not? I never saw anybody else in the jail with a rope, and never heard any threats in the jail against Gilman. The old man did not tell me at any time "for God's sake don't leave the door open."

TESTIMONY OF R. HOUGHTON.

Live at Norway; know the defendant, Gilman, 15 years. My place is about 3 1/2 miles from his. Saw Gilman on the Friday preceding the trouble; he came out of the brush in the gulch and started up to the house. I was close to him; spoke to him and he nodded and passed on. I usually talked with him, but he did not want to talk. Saw the place of the grave, and told Cathcart when I saw him hunting, where I saw Gilman come out of the brush, and they went up there and found the bodies. Was there when the bodies were lifted out of the grave. Heard charges against Gilman a year ago that he killed George Morris.

TESTIMONY OF J. M. SIGLIN.

I had Eatonhover's gun. Found it on the place. There is a log right by the county road; found the gun lying by the road by the log. I did not find it by chance. I had been informed that a gun had been hid, and the reason it had been hid, I had been informed that it had been hid about that place. The gun is in Anderson's stable. Received no information from Gilman. Albert Gilman and W. A. Luse were with me.

TESTIMONY OF MRS. COPLEY.

I helped to shroud Mrs. Eatonhover. There was a bad cut on the back of head and near left temple; should judge her nose was broken; her arms were bruised; her left hip bruised; her right arm had finger prints on it; on the lower side of the right limb, near the body was a bad bruise.

After the witnesses were examined the charge was given and the jury retired. In twenty minutes they brought in a verdict as charged in the indictment—murder in the first degree—which is punishable by death by hanging. The judge read the verdict aloud and asked the jury if that was their verdict at which all bowed their heads and answered in the affirmative. His Honor then said that sentence would be passed at 4 p. m. the following day.

THE SENTENCE.

Promptly at 4 p. m. on Thursday the prisoner was brought into court, the room being packed to its utmost capacity by citizens of the county. Addressing the doomed man, the judge rehearsed the case; how he had been accused, proven guilty, and condemned by twelve of his fellow citizens, etc. The prisoner being asked to stand up, the judge asked him if he knew any reason why sentence should not be passed, to which he answered in a voice audible only to those very near him and not at all so to this reporter. The judge stopped him and said, in substance: I have no patience with one who would commit such a dastardly crime, that scarcely has a parallel in the annals of criminal courts. It is beyond human conception how one, possessed with even the commonest instincts, could commit so fiendish an act. You are condemned and despised by all good people, but it is useless to waste words on you. If the cries of that poor little innocent boy to spare his mother could not arouse your sympathy, it isn't likely that any thing I might say could excite remorse.

Then the sentence of hanging, on Dec. 13th—"Till you're dead and may God have mercy on your soul," at which the whole house save Gilman was deeply moved. He showed his accustomed stoicism.

Mrs. Gilman will have hearing at next term, it appearing from the testimony that she was cognizant of the facts. She is out on bail.
