A POPULIST ADDRESS.

The Members of Senate and House to the People of the Country.

Washington, Feb. 14.—The Populist members of the senate and house, whose names are attached, besides the others whose signatures are given, have issued the following address to the members of the People's party:

"As early as 1865-66 a conspiracy was entered into between the gold gamblers of Europe and America to accomplish the following purposes:

"To fasten upon the United States the burden of a perpetual debt; to destroy the greenbacks which brought us safely through the perils of the war; to strike down silver as a money metal, and to deny to the people the use of federal paper, the two independent sources of money supply guaranteed by the constitution; to fasten upon the country the single standard of Great Britain, and to delegate to the thousands of banking corporations, organized for private gain, the sovereign control for all time over the issue and volume of all supplemental paper currency. Thus they doubled the demands for gold, forced upon the country an appreciating money standard, entailing an indefinite period of falling prices; robbed enterprise of its just profits; condemned labor to idleness and confiscated the property of debtors.

"For nearly thirty years these conspirators have kept the masses quarreling over the most important matters, while they have pursued with unrelenting zeal their own purpose. At the present moment every device of treachery, every resource of statecraft, and every artifice known to the secret cabals of the international gold ring are being made use of to deal a final death-blow to the prosperity of the country. They seek to accomplish their purpose before the blow can be averted through the ballot. Their plans have long matured, and their line is fully chosen. They address themselves to one subject—the money question—in all of its breadth and magnitude. This brings the country face to face with a perilous issue which calls for immediate and united action on the part of the people. Every behest of patriotism requires that we shall at once meet the issue and accept the challenge so defiantly offered. To falter now is to invite disastrous failure.

"We earnestly urge the Populists throughout the country to concentrate their entire force and energy upon the tremendous contention presented, and thus meet the enemy upon his chosen line of battle. Invite the aid and co-operation of all persons who favor the immediate free coinage of silver at the ratio of 16 to 1; the issue of all paper money by the general government without the intervention of banks of issue, and who are opposed to the issue of interest-bearing government bonds in time of peace. In a word, to extend the hand of fellowship to all who agree with you upon the money question, which is certainly the mightiest and most fundamental controversy involved during the present century."

BROTHER AND SISTER MEET.

After a Separation of 42 Years a Dream Unites Them—Strange Story Told By One of Them.

[The following most singular occurrence, first, but very imperfectly, related in the San Francisco Examiner, is given through the HERALD correctly by the principal actor in the affair, and through the kindness of Uncle Tom Willard of this place.—ED. HERALD.]

SAN FRANCISCO, CAL., Feb. 12, 1895.

T. R. WILLARD, ESQ., COQUILLE, OREGON.—Dear Sir: Yours of the 8th came to hand and contents noted, yet I was surprised to see and to receive a letter from so far away to enquire as to the truth of that report in the Examiner, which, however, I must say the reporter of said paper got it badly mixed up. A reporter on the Morning Call got on to it from a friend of mine. The reporter called on me and kindly asked me to relate the circumstances, and would like to write it up for the Call if I had no objection; I therefore gave him the facts as they were. I learned last eve that the reporter did not write it up for the Call, but a reporter on the Examiner, as an acquaintance of his, was very anxious to write it up, and the Call man gave it to him in such a way that he got it badly mixed.

Now, as you have taken the pains to write, as I suppose to see if there is anything to be relied upon in a dream, I must say there is, under certain conditions. As you desire to know more of it, I will relate the circumstances, as they are, and facts also. I will have to, to commence with, carry you back to 1845, so that you may fully understand. At that time I was a boy, at the age of 10 or 11. I was living with a sister, who had adopted me, as my mother died when an infant of a few weeks old, so of course she is the only mother I know of. In November '48 my brother-in-law embarked on a ship as a passenger for California and left his family behind in Boston, Mass. We managed to get along very well. In 1852 while I was in the country at work, along in December of that year, I received a letter from my sister Elizabeth that she and Mary E., her daughter of 2 years, were to start for California the next day. We corresponded and every steamer brought me good news, and in 1861 the war broke out. I enlisted in the sharpshooters, as a free rover, go where I liked, and after a year's service in this branch, I found that I could have no claim on the government if I was wounded, or even killed, so I joined a battery in the field, in the 3d Rhode Island regiment. In 1863 I wrote to my sister here in California; never received any reply and that was my last letter to her. In 1864, May 16th, I was at the battle of Bermuda Hundred. Here I was badly wounded, was taken up as dead and was laid along side of the other dead. The papers had given a full account of the battle, and of the killed and wounded, and my name was in the list of killed. I then had two sisters living in Boston, both widows. They wrote to Elizabeth, as near as I can find out, that I was killed in the army and had never recited the mistake, and she had always believed that I was dead. I came home from the war discharged in June, 1865.

In October '65 I left Boston and went to Yankton, D. T. Here I fell in with officers of the army and I drifted off on to the frontier. Meantime I had never wrote home or heard a word from home for over 30 years until I met my sister here in California. I came to San Francisco 8 years ago. I commenced then to find them. I looked in the city directories, and traced up in the years 1872 and 1875, and then was lost. I wrote and inquired in the neighborhood of where they had lived. No one knew them. After 5 years of anxiety I gave it up, and thought and reckoned up her age. It seemed reasonable to me that she could not be living, as she would be near the eighties, but if I could only find her daughter it would be some consolation. My wife would try and impress me that she was living, and that I would yet see her. I often said that's impossible, and gave it up. For the past 3 years I had not given it a thought. Not quite a year ago I had a dream. I met my sister; I thought I went to the house and would take her by surprise and asked her all sorts of questions about her brother Frank. I tried hard to make her recognize me. "No," she said, "my brother was killed in the war, and it's no use—you cannot make me believe that he is living." I says to myself, I will go away and write her a letter, and in it I'll explain its plain that she will not doubt me. I then woke up and told my wife of my dream. I gave a full description how she looked and the room I was in. I thought nothing more of it

the mind and at the same time one must make a study to interpret it. Although I am no interpreter of dreams, and hope you will, after reading, write me your opinion, and why you have taken the trouble to ascertain the truth of a dream, or the truth of the press. As I have often said, the press is not to be relied upon. As I saw your name on the envelope, T. R. Willard, it reminded me that I used to be acquainted with Willards in Indiana, Knightstown. I remain yours, etc.

Honorably discharged soldiers and sailors who served ninety days, or over, in the late war are entitled, if now partially or wholly disabled for ordinary manual labor, whether disability was caused by service or not, and regardless of their pecuniary circumstances, to receive a pension. Widows of such soldiers and sailors are entitled, if not remarried, whether soldier's death was due to army service or not, if now dependent upon their own labor for support. Widows not dependent upon their own labor are entitled if the soldier's death was due to service. CHILDREN are entitled (if under 16 years) in almost all cases where there was no widow, or she has since died or remarried. PARENTS are entitled if soldier left neither widow nor child, provided soldier died in service, or from effects of service, and they are now dependent upon their own labor for support. It makes no difference whether soldier served or died in late war or in regular army or navy. Soldiers of the late war, pensioned under one law, may apply for higher rates under other laws, without losing any rights. Thousands of soldiers drawing from \$2 to \$10 per month under the old law are entitled to higher rates under new law, not only on account of disabilities for which now pensioned, but also for others, whether due to service or not. Soldiers and sailors disabled in line of duty in regular army or navy since the war are also entitled, whether discharged for disability or not. Survivors, and their widows, of the Black Hawk, Creek, Cherokee, and Seminole or Florida Indian wars of 1812 to 1842, are entitled under a recent act. MEXICAN WAR SOLDIERS and their widows also entitled, if 63 years of age or disabled or dependent. Old claims completed and settlement obtained, whether pension has been granted under later laws or not. Rejected claims responded and settlement secured, if rejection improper or illegal. Certificates of service and discharge obtained for soldiers and sailors of the late war who have lost their original papers. Send for laws and information. No charge for advice.
