A New Enterprise. Further information regarding the aims and objects of the newly chartered Coos Bay Transportation Co. reaches us through the Oregonian's Salem correspondent, who copies that document as on file in the office of secretary of state. It gives the matter thus: "The Coos Bay Transportation Company today filed articles of incorporation, to construct and equip a railroad from Isthmus slough, Coos county, to Cateching slough; also from the mouth of Big creek, in the same county, north to a point west of Willamette meridian, in the same county; also from a point on the South Fork of Coquille river. Place of business, Marshfield; capital, \$50,000; incorporators, E. B. Dean, E. W. Dean and L. P. Phelan."
