SHALL WE HAVE A CANNERY?

A Prompt and Friendly Action Will Bring a First-Class One.

For a few days past considerable interest has been aroused among our citizens by the discussion of a proposition to establish a first-class cannery plant at this place. The Herald has, for some years past, broached and advocated the subject, and our citizens generally have been convinced, though inexperienced in that line, that it is one of the great necessities of our section, and believe it would not only be a great and profitable investment, but go far to develop our fruit and vegetable interests as nothing else would, and as we know our climate and soil specially favor. Of course we know we have the salmon, during that season, and now to occupy a cannery the balance of the year is the next question—and yet there is no question about it.

Titus Hale, esq., of Oakland, Cal., has been visiting his old friend Mr. Tattle, in this place, and as he is one of the directors of the Sacramento River Packers' Association, a very wealthy firm, of San Francisco, he came to this section with a view of removing one of that company's canneries to this river. But he found the field already partly occupied—that of fish canning—a small plant being about to be built at Bandon. He has returned to San Francisco via Empire and a bay steamer.

We think Mr. Hale has overlooked the advantages of this locality. The people here could well afford to furnish a site, while there is next thing to free fuel, which would make a daily saving of \$3 to \$5. The fish are caught at all points between here and Bandon and can be delivered at the lowest possible rates, while a further supply, if needed, could be had from Coos bay. The plant can be placed on the river and railroad track at the same time, thus having the advantage of both routes of transportation, via the river or the bay, at the lowest cost and without re-handling.

Then as for fruits and vegetables, this is the centre of this grand, superb valley. An unlimited supply of blackberries, gooseberries, currants, etc., can be supplied, of the former running from July till November; and there are plums, pears, peaches, green corn, asparagus, rhubarb, squash, etc., no end, and of which, if a market is found or a manufactory established, would give profitable employment to many people, including the boys and girls.

Now, let our citizens push this matter. A splendid opportunity is afforded, which will be readily seized by other communities if we fail to extend an encouraging hand.

Jail Break and Recapture.

Wednesday of last week a telegram was sent out from Roseburg stating that "Sam Brown, who is under sentence of death for the murder of Alfred Kincaid at Oakland last August, walked out of the county jail last night. The jailer had carelessly left the door unlocked. He has several hours the start of the officers, and has no doubt struck for the mountains."

Many opinions were expressed here regarding the affair, and it was generally concluded he had been assisted from the outside and would hardly be overtaken, but last Friday's papers brought the intelligence that Sam had reached old Mr. Sutherland's, near Wilbur, where he formerly worked, about 9 miles from Roseburg. He was afraid he would meet Deputy Sheriff Shambrook there, so he started back to John R. Sutherland's for supper. While eating, Sutherland covered him with a Winchester, after which he was delivered at the jail in Roseburg without a shot being fired.

Louis Canning, of Fort Wayne, Ind., came in last Wednesday. He is a younger brother of our G. W. Canning, superintendent of the county infirmary, who had not seen each other for a number of years. The younger Mr. Canning may conclude to locate with us and also become a Coos county-ite.

GENERAL NEWS.

LITIGATION WILL FOLLOW.

Washington, May 22.—The officials of the internal revenue office have been looking into the subject of a return of the money collected under the operations of the income tax law before it was repealed in 1872. The act remained on the statute books for nearly twelve years, the total collections under the law aggregating \$346,980,000. The exemption was \$600 per annum. The greatest amount collected in any year was in 1866, when the collectors of internal revenue returned \$73,000,000.

It is admitted that the prospects are bright for a series of litigations, which may become as celebrated as the French spoliation claims. While those who paid the tax under the law of 1862 will have no standing in court if they attempt to recover moneys illegally collected from them, they clearly have an equitable right to a return of the money, and it is expected that a move will be made on congress as soon as it meets looking to the necessary legislation to authorize the treasury to pay the amounts collected.

THE MICHIGAN MILITIA

Ironwood, Mich., May 22.—Since the railroad strike last summer the iron miners here have been incensed against the state troops. A number of the miners' unions here are members of the militia, but they remained in the latter until recently. Fully one-third to one-half of the state troops in the peninsula are miners or men dependent upon mines for a livelihood, and last week through some action of the unions, these men

COMMITTED SUICIDE.

Corvallis, Or., May 21.—William Uhlman, superintendent of the Coast Carriage and Wagon Co., who six months ago arrived from Moline, Illinois, followed two weeks ago by his family, committed suicide today by strangling. When found he was lying on the floor with a cord made of cloth twice about his neck and tied to a water pipe four feet above. This held his head and shoulders suspended. He had been dead three hours. Broken cords were scattered about which indicated that several attempts at self-destruction had been made. Despondency is assigned as the cause.

HE KNEW IT WAS LOADED.

McMinnville, Or., May 22.—George Herg, 30 years old, shot himself, supposedly with suicidal intent, this afternoon by placing a loaded shotgun to his mouth and blowing away the whole left side of his face. He is still alive, with small chance of recovery.

Growers expect to pay 1 1/2 cents per pound, and good pickers can make \$2 per day.

A "hitherto peaceable citizen" of Dufur, whose name The Dallas papers do not give, got drunk last Sunday and knocked his wife down. Another woman, who interfered, suffered the same treatment. He was placed under arrest by Sheriff Driver.

D. J. Cooper, of The Dalles, received from Hon. Binger Hermann last week a record of his great-grandfather's services during the Revolutionary war. This ancestor enlisted in 1770, and served until peace was declared.

A 37 1/2-inch reflector for photographic work has been ordered for the Mount Lowe observatory in California, which is to be 2000 feet higher than the Lick Observatory.

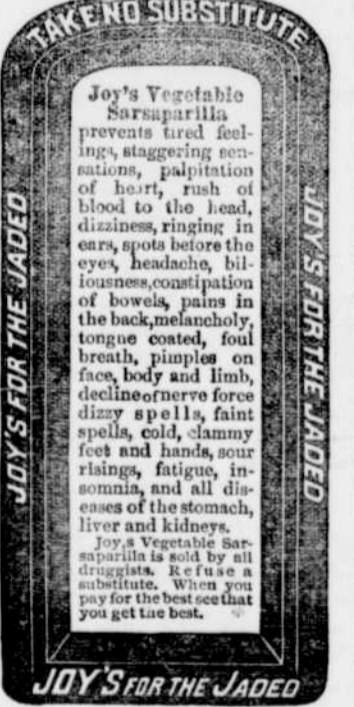
