Last week the movement to run the shingle-mill in co-operative interests was consummated, and now the business hums. Mr. Dickson, the proprietor, was cramped, and beset on all sides with obstacles and onerous duties which hindered him from managing it to advantage, hence his employes proposed to co-operate with him and share the expenses and profits. To this end, Wednesday of last week Mr. Dickson, as party of the first part, agreed with E. E. Dickson, T. C. Norris, E. Mongrain, Frank Wilson, R. Henney and — Terrell, parties of the second part, to let his mill or plant for the manufacture of shingles upon certain terms and conditions, which were accepted and entered into at once, and so the mill is running strictly on business principles. The boys had to hustle when starting in, for orders had piled in during the suspension and continue to be received that even at turning out 24,000 to 26,000 per day will give them no opportunity to get a stock ahead for some time to come.
