Keep Away From California. To men looking for work, to men with small means, we would say, "keep away from California."

Never since the first settlement of the state have conditions been so desperate as at present.

Even during the summer season, the busiest time of the year, there were at the lowest computation no less than 10,000 unemployed in the city of San Francisco alone, while the rest of the state was in equally as bad a condition. Suicides occur almost daily; the starvation and misery of large numbers of people is frightful, and the condition the coming winter will be horrible in the extreme. White women, to save themselves from starvation, are working in Chinese factories at rates refused by Chinese workers; and in the face of such horrible state of affairs, employers have systematically violated the laws prohibiting the importation of alien laborers under contract and have flooded the state with Japanese laborers who have monopolized a large amount of the fruit picking, gardening and farm work.

Numbers of productive plants that have been running for years have been shut down and the employes turned adrift.

Farms are foreclosed by the hundreds, and crops are piling up without a market in sight.

To enter into all the details of the situation would disclose such a state of misery, depravity and crime that would affright the stoutest heart.

We can only warn people to stay away from California because the outlook is gloomy and desperate in the extreme.

Eugene V. Debs.

When Eugene V. Debs is released from Woodstock jail, on the 11th inst, he will be given an ovation such as the proudest in the land might envy. He will be greeted by tens of thousands of his countrymen in the city where he was convicted of no crime, and sentenced to six months' imprisonment. He will be lionized as a martyr to principle, which he is, while the judicial tyrants who sat in judgment upon him will be execrated and held up to the scorn, and contempt, and abhorrence of the world. This "disgraced labor leader," this "noisy agitator," this "anarchist," will be welcomed from his prison-home like a conquering hero, and, undaunted by the "law of injunction"—the last resort of tyrants—he will at once go forth again battling for the divine law of service—the only hope of slaves—and we know that, if life and strength be spared him, he will always be found in the vanguard until the last vestige of privilege shall be destroyed.—S. F. Star.

Speaking of the demonization of silver, the present secretary of the treasury, in 1878, declared in the halls of congress, that it was "the most gigantic crime of this or any other age." Today he is one of the chief advocates of demonization, and goes further by declaring the greenbacks should be retired and the government cease issuing paper money. John G. The "upper ten" has dictated all the laws which govern the toiling millions. Isn't it time for a change?

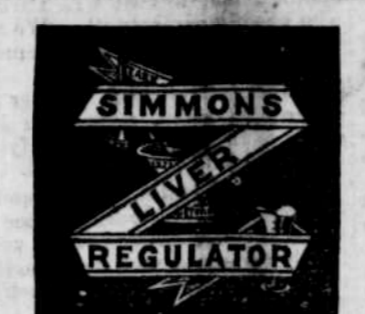

Some Things to Be Exposed and Think About.

EDITOR HERALD: "There is nothing the matter with human selfishness; the trouble is in perversion of its use. The law of self-preservation really demands the bearing of one another's burdens, the looking out for the better welfare of our neighbors. Human selfishness is abused when it is applied by some parts of society with the object in view of their exclusive advancement." A portion of society in this section of Oregon is manipulating matters in such a manner that the balance of our citizens have become disgusted. Their self-assertion of superiority needs puncturing. The moral poverty of their surroundings is evident, and the external glitter, dazzling in its fierceness, upon our vision as a hollow mockery and a shallow sham. This select coteria who affect a superior function while being tainted with the prejudices of caste are sunk—low that it is a physical impossibility to extricate them from the depths of degradation. Honesty, integrity and the principles which adorn and go towards making a true American citizen are as foreign to their nature as the attributes of an angel differ from those of a devil. To assemble and plot to rob some unsuspecting citizen of his birthright is a choice and savory morsel with these things. To have a workman discharged because he reads a newspaper to which they are opposed or votes a ticket antagonistic to their ideas is an action so commendable with them that their discretion is lost in the hurry to accomplish the cowardly act. To add additional infamy to the transaction, they will then proceed further and deny it. Their names are not legion, but their one-sidedness is grossly apparent, and the lack of any honorable instinct as transparent as glass. Any means necessary to accomplish the end in view are not to be neglected, nor the despotic role of subordination and the tricks of buccanism omitted. The county, while suffering from an introduction of laborers who are deceived by false promises, is not alone. Adjacent counties are also smitten with the consequences of this affliction. From the extraordinary number of men who are compelled to travel without means, through being subjected, as the Israelites were subjected to Pharaoh, at one place in Coos county, the people of southwest Oregon have to adopt extra measures for the protection of their property, and women, in the rural portions of the land, are afraid to go outside the door of a dwelling.

Laborers cannot be expected to work where their earnings are taken to pay the debts of others who preceded them.

The Gold Beach Gazette, an insignificant sheet published at the mouth of Rogue river, takes our citizens to task, and after enumerating some industries and the unfortunate position of some of our people, says: "Perhaps the residents there are apt scholars and are practicing the anarchistic doctrines taught by some of their local papers." Did it never occur to this evaporating scribbler that it is judicious, most all the time, to attend to his own business. The citizens of Coos county seek no advice from his kind, because it is evident from his pragmatism that he is a crawling, creeping sneaker. If he is eager to join that portion of society to which I have alluded above, and to share in the plenitude of prosperity and abundance of money, let him abandon the scene of his meanderings, the clam-

flais of Rogue river, and enter the fold where dishonesty is prevalent, and where the beech show of two-legged dogs may find encouragement in his association. Should his anxiety to teach the intelligent voters of Coos county keep him awake of nights, he might devote a few of those valuable moments to a study of the lesson I now present him. Let him hurry up and be on time, as the society mentioned "is on the hog train, last car." The train and its freight are synonymous and not separately distinguishable.

Honorably discharged soldiers and sailors who served ninety days, or over, in the late war are entitled, if now partially or wholly disabled for ordinary manual labor, whether disability was caused by service or not, and regardless of their pecuniary circumstances, WIDOWS of such soldiers and sailors are entitled (if not remarried) whether soldiers' death was due to army service or not, if now dependent upon their own labor for support. Widows not dependent upon their own labor are entitled if the soldier's death was due to service.

CHILDREN are entitled (if under 16 years) in almost all cases where there was no widow, or she has since died or remarried.

PARENTS are entitled if soldier left neither widow nor child, provided soldier died in service, or from effects of service, and they are now dependent upon their own labor for support. It makes no difference whether soldier served or died in late war or in regular army or navy.

Soldiers of the late war, pensioned under one law, may apply for higher rates under other laws, without losing any rights.

Thousands of soldiers drawing from \$2 to \$10 per month under the old law are entitled to higher rates under new law, not only on account of disabilities for which now pensioned, but also for others, whether due to service or not.

Soldiers and sailors disabled in line of duty in regular army or navy since the war are also entitled, whether discharged for disability or not.

Survivors, and the widows, of the Black Hawk, Creek Cherokee, and Seminole or Florida Indian wars of 1812 to 1842, are entitled under a recent act.

MEXICAN WAR SOLDIERS and their widows also entitled, if 62 years of age or disabled or dependent.

Old claims completed and settlement obtained, whether pension has been granted under later laws or not.

Rejected claims reopened and settlement secured, if rejection improper or illegal.

Certificates of service and discharge obtained for soldiers and sailors of the late war who have lost their original papers.
