**Upper Coquille Farms.**  
As an addendum to our last week's notice of some of the attractive farms of the upper Coquille, we wish this week to make mention of some others that caught our eye during our ramblings.  
Among the first that drew our especial attention this side of W. L. Hood's stock ranch was that of Mrs. Carmon at the Etelka post-office. This is a beautiful place, lying on a sloping plateau a little above the river, and is the center of quite a number of smaller ranches. This farm contains near a hundred acres of land in cultivation, a good orchard and good farm buildings. It is a valuable property and a credit to its owner.  
Coming down the river and crossing over we emerge upon Rowland prairie, where a group of lovely ranches greet the eye. The first is that of A. Warner and is a superb country seat. It lies all on the open prairie and is therefore nearly all in cultivation. The buildings are excellent, the fencing good and withal it is a typical country home.  
Joining this to the north, on the prairie, is a good farm the name of the owner of which we failed to learn. The place indicated thrift and good management.  
Next comes the fine ranch of W. O. Phillips, one of Coquille's thrifty farmers. Mr. Phillips' place also lies mostly on the prairie, and is in a high state of cultivation. We stopped here and fed and had dinner, enjoying the hospitality of the host and hostess.  
The Flanagan stock ranch embraces the western portion of Rowland prairie, and extends away to the summits of the lofty hills to the westward. It is supposed to be one of the best, if not the very best, stock farms in Coos county. It has been in charge of our friend Ed Sherwood, who has, however, now moved to Myrtle Point to live. Mr. Flanagan is one of Coos bay's prominent business men.  
The next point of interest is the farm of Father Johnson, father of Edward Johnson, who was drowned at Bandon this summer, and of Prof. Sam Johnson, well known to most of our citizens. This is a pleasant country home, and a good farm. The fencing is up to date and the buildings excellent. Mr. Johnson keeps a nice lot of milk cows and makes butter for the market.  
We can only mention the names of other owners of splendid ranches, for want of space. Capt. Harris, Manuel Hermann, Wash Hermann, Mrs. Schroeder, and Mr. Strong all have excellent farms lying along the route of travel, beside many others which are not directly on the road. The cheese factory of Mr. Mosier is situated on the old Schroeder place, and is turning out an extra article of cheese, as the HERALD can testify. We hope at some future time to be able to give a more complete write-up of the upper Coquille valley, which is one of the richest portions of Coos county.

**Cremery Accident.**  
On last Monday morning Engineer Romander of the Coquille cremery met with a serious accident by which both his hands were severely burned. From some cause it became necessary to hastily draw the fire from the furnace to prevent an explosion, and Mr. Romander went heroically to work and succeeded in preventing the impending disaster, but received severe burns as a result. 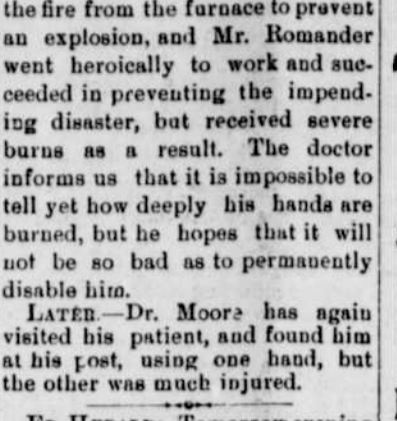
