**The Coquille Creamery.**  
The Coquille Creamery Co. has rented the creamery to the Coquille Dairymen's Union for the coming year. The union pays \$500 per year rent, and taxes and insurance. The union has also employed C. Romander again as their superintendent and butter-maker. The creamery expects to run eleven months this year. These creameries have done more in this section to put money in circulation than all other kinds of business put together. Not much short of \$100,000 has been brought to Coos county by these institutions. What we now need is the cash and dairy factory, the cannery, and a beet-sugar factory.

**Losses by the Late Fire.**  
In Coquille's late conflagration we find the losses sustained as follows:  
Coos County Mercantile & Shipping Association's building was valued at \$550, with \$300 insurance in the North America Co. of Philadelphia, with T. A. Walker as home agent. The association loses \$200.  
G. W. Wimer's building was valued at \$1000, with \$600 insurance. Hickox & Stone lost in saloon stock about \$900, with \$500 insurance on fixtures.  
The Bulletin office was entirely consumed, and was without insurance. The plant was nominally owned by Ben Lawrence and Anderson Lamb, but was purchased on time, and was held as security for the purchase price. Five hundred dollars of the amount was borrowed through A. J. Sherwood from a Mr. Weaver of Catching slough. The loss was really sustained by those who stood security for the original cost of the plant.

Honorable discharged soldiers and sailors who served ninety days, or over, in the late war are entitled, if now partially or wholly disabled for ordinary manual labor, whether disability was caused by service or not, and regardless of their pecuniary circumstances, WIDOWS of such soldiers and sailors are entitled (if not remarried) whether soldiers, death was due to army service or not, if now dependent upon their own labor for support. Widows not dependent upon their own labor are entitled if the soldier's death was due to service.  
CHILDREN are entitled (if under 16 years) in almost all cases where there was no widow, or she has since died or remarried.  
PARENTS are entitled if soldier left neither widow nor child, provided soldier died in service, or from effects of service, and they are now dependent upon their own labor for support. It makes no difference whether soldier served or died in late war or in regular army or navy.  
Soldiers of the late war, pensioned under one law, may apply for higher rates under other laws, without losing any rights.  
Thousands of soldiers drawing from \$2 to \$10 per month under the old law are entitled to higher rates under new law, not only on account of disabilities for which now pensioned, but also for others, whether due to service or not.  
Soldiers and sailors disabled in line of duty in regular army or navy since the war are also entitled, whether discharged for disability or not.  
Survivors, and their widows, of the Black Hawk, Creek, Cherokee, and Seminole or Florida Indian wars of 1832 to 1842, are entitled under a recent act to \$100 per month, if 62 years of age or disabled or dependent.  
Old claims completed and settlement obtained, whether pension has been granted under later laws or not.  
Rejected claims reopened and settlement secured, if rejection improper or illegal.  
Certificates of service and discharge obtained for soldiers and sailors of the late war who have lost their original papers.
