Another Steamer Ashore. On last Sunday evening about dark the schooner Lizzie Prian undertook to sail into the mouth of the Coquille, at Bandon, and just as she was crossing the bar the wind failed and she went on the beach, almost in the exact spot where the Lila and Mattie struck a few weeks ago. The Prian is owned by parties in San Francisco, and was in command of Capt. Dick Nelson. She is one of the Coquille lumber vessels and has been running on this route for several years. No lives were lost, and it is thought that she will be gotten off before any material damage is done.

Deveraux vs. Luttrell.

An exciting law suit occupied Justice Cecil's court for three days last week. The principal parties to the suit were Thos. Deveraux and H. C. Luttrell, but associated with Mr. Luttrell as sureties were Wm. Abernethy, J. P. Stemler, M. J. Krantz and J. H. Minard. Mr. Deveraux had rented his dairy farm to Mr. Luttrell for a year, for the consideration of \$750. The business did not prove a success, and Mr. Luttrell found it hard to pay the rent. After paying \$563 he went to Mr. Deveraux and proposed a compromise by him paying \$80 more and Mr. Deveraux to throw off the balance. This Mr. Deveraux refused, and hence the suit. Luttrell refused to pay the balance of the \$750 and Deveraux began suit. Luttrell set up a claim for damages on the plea that Deveraux had not complied with the contract. He was represented in the suit by Judge Watson and son of Marshfield, and Walter Sinclair of Coquille, and Mr. Deveraux employed A. J. Sherwood to manage his side of the case. The following persons were empaneled as jurymen to try the case: L. Harlocker, Green Self, J. A. Collier, J. V. Foster and Wm. Hull. Nine or ten witnesses were called, and the trial lasted three days. The case was given to the jury at 5 o'clock Friday evening, and at about 9 o'clock a verdict was rendered. The verdict gave the plaintiff \$109.22, and threw the costs upon the defendant, Mr. Luttrell. This trial was one of the most interesting of any held in Coquille for a long time, and the courtroom was full of spectators most of the time. We have not learned whether this will end the trial or not.

Honorably discharged soldiers and sailors who served ninety days, or over, in the late war are entitled, if now partially or wholly disabled for ordinary manual labor, whether disability was caused by service or not, and regardless of their pecuniary circumstances, WIDOWS of such soldiers and sailors are entitled (if not remarried) whether soldiers, death was due to army service or not, if now dependent upon their own labor for support. Widows not dependent upon their own labor are entitled if the soldier's death was due to service.

CHILDREN are entitled (if under 16 years) in almost all cases where there was no widow, or she has since died or remarried. PARENTS are entitled if sold or left neither widow nor child, provided soldier died in service, or from effects of service, and they are now dependent upon their own labor for support. It makes no difference whether soldier served or died in late war or in regular army or navy.

Soldiers of the late war, pensioned under one law, may apply for higher rates under other laws, without losing any rights. Thousands of soldiers drawing from \$2 to \$10 per month under the old law are entitled to higher rates under new law, not only on account of disabilities for which now pensioned, but also for others, whether due to service or not.

Soldiers and sailors disabled in line of duty in regular army or navy since the war are also entitled, whether discharged for disability or not. Survivors, and their widows, of the Black Hawk, Creek, Cheroke, and Seminole or Florida Indian wars of 1822 to 1842, are entitled under a recent act. MEXICAN WAR SOLDIERS and their widows also entitled, if 62 years of age or disabled or dependent.
