**BRABSTER WEST'S LETTER.**

The Political Situation to Date—Teller or Sibley for President—Grover Cleveland Alarmed—Advice to Democrats.

WASHINGTON, D. C., July 3, 1896.

William McKinley, of Ohio, has been nominated for certain defeat, and Henry M. Teller or Joseph C. Sibley will be the next president. Such seems to be the opinion of nearly all the old politicians in Washington. Men like Senator Teller to Abraham Lincoln, and even eastern Republicans say: "What a pity he is not our candidate instead of a professional office-seeker and moral coward like McKinley." The Jewish and pseudo-Christian usurers have succeeded in corrupting the Republican party, it now remains to be seen if they can corrupt the whole country.

The brave defection of Senators Teller, Cannon, Debois, Pettigrew, and the many others, and the enthusiastic way in which it was received by the people has alarmed the gold conspirators. Their plan was to allow the Democratic national convention to nominate an old Democrat on a free silver platform, and thus divide the silver forces. Now they see that they have overreached themselves. The outburst of public applause of the bolting Republicans has shown them that McKinley cannot be elected. As ex-Senator John J. Ingals, of Kansas, telegraphed the New York Journal: "McKinley goes to certain defeat, and the Republican party to its death."

They realize that the game is in the hands of the reform forces, who have only to unite upon Senator Teller or ex-Congressman Sibley to put a sincere friend of silver and a man of unimpeachable integrity in the White House. The whole enormous Republican silver vote will go to either Teller or Sibley, if nominated. Congressman Skinner, of North Carolina, says that the Populists will gladly support Teller or Sibley. J. M. Devine, of Nebraska, who made a gallant and nearly successful race for congress on the Populist ticket in 1891, says the same thing, as does J. H. Turner, secretary of the national executive committee of the People's Party.

If the silver Democrats will rise to the occasion, take the initiative and nominate either Teller or Sibley, the silver Republicans and Populists will help to elect the candidate. This condition of affairs has aroused consternation in the conspirators' camp and has caused them to change their plans. Grover Cleveland has issued a manifesto calling upon his cuckoos to fight for control of the Chicago convention. Whitney has abandoned his trip to Europe, and will be at Chicago with his Standard Oil barrel. Brice will be there with his boodle. Gorman, who has carried the Democrats of Maryland into the gold camp, is slated for president on a gold Democratic ticket. That is a bitter pill for Grover to swallow, but he must do as he is told. Rothschild dictates the program, and the cable is kept hot between London and Washington.

Will the silver Democrats do their duty? They must, or the Democratic party will perish in the general upheaval. A Democratic metallist could, under favorable circumstances, hope to carry only

these states: Alabama, 11; Arkansas, 8; Florida, 4; Georgia, 13; Kentucky, 13; Louisiana, 8; Mississippi, 3; North Carolina, 11; South Carolina, 9; Tennessee, 12; Texas, 15; Virginia, 12; Montana, 3; Idaho, 3; Colorado, 4; Nevada, 3; Utah, 3; Indiana, 15; Missouri, 17; and Illinois, 24. Total, 197.

Now, Teller or Sibley would carry all those states, and these in addition: California, 9; Kansas, 10; Nebraska, 8; North Dakota, 3; South Dakota, 4; Oregon, 4; Washington, 3; Wyoming, 3; Michigan, 11; and Minnesota, 9. Total, 68. Total Teller or Sibley strength in electoral college, 255. In the face of these figures—and I think they'll stand the most thorough examination—I cannot for my life see how the silver men in the Democratic party, who will undoubtedly control the Chicago convention, can fail to give us Teller or Sibley as the silver candidate, for without the support of the Populists and silver Republicans in a three-cornered contest, the Democrats would lose Alabama, Georgia, North Carolina, Texas and Virginia, and its name would become but a memory, a tale that is told.

From visitors to Washington, I learn that western New York is ablaze for silver and reform. The operatives of New England are beginning to see the light. Maryland is aroused. The toilers of Massachusetts are arming for the fray. Even the old dominion is ripe for a revolt. The die is cast. The battle is on. War is afoot. Truth, crushed to earth by conspirators and venal and traitorous public servants, is rising again. Let every man with a spark of independence take heart and do his utmost for his land and home. We have got the rascals on the run, and it is our own fault if we do not draw their fangs next November, and restore a government of the people, by the people, and for the people.

## WANT THE 200-CENT DOLLAR.

Workingmen Adopt the Gold Standard and Create a Panic.  
The following press dispatch cannot fail to be of interest to believers in the gold standard. If the gold dollar is good for the banker why not for the laborer? If the silver dollar is really only worth 50 cents, what decency is there in paying it to the working man for a full dollar? If it is really worth a dollar for the laborer it is certainly worth a dollar for the usurer. If so, what sense is there in calling it a 50-cent dollar? But the case given below is the best object lesson on the working of the gold standard we have yet met with. It shows one of two things: either that working people are being robbed, or else all this twaddle about 50-cent dollars is the merest political rot. Read the dispatch, brother, and ponder:  
"Hazleton, Pa., June 22.—The monthly paydays of many of the contractors of this region were in the past week, and considerable trouble was experienced in paying off the foreign element. They refuse to take paper or silver money."  
"For the last week or two Anthony Reitz, a well-educated Austrian who speaks several languages, has been among the foreigners and put it into their heads that the silver dollar was not worth more than 50 cents, and when any foreigner expressed a doubt regarding his statement he read extracts from a gold standard newspaper to substantiate his argument."  
"Jacob Hogan, a contractor, who is building the reservoir at Buck Mountain, employs 300 men who had listened to Reitz's arguments, and the result was that the men held a meeting and decided they would all be gold men, not only politically, but commercially, and that their labor should be traded on a sound-money basis only."  
"Reitz, who is an under-boss, communicated this fact to Contractor Hogan Thursday. The men were to be paid their month's wages on Saturday. It did not strike Hogan at that time that there would be any difficulty in paying the men in gold. He called at his bank and demanded \$1900 in the teller told him he could not get that sum in the entire county. Out of \$11,000,000 on deposit in the several banks of the county it is estimated that scarcely half the required amount of gold is in circulation. The laborers, however, have refused to go beyond the

## GENERAL NEWS.

**THE DROWNING TOO MUCH.**  
New York, June 23.—A special to the World from Batavia, N. Y., says:

Jerome Rowan, a rich banker, the father of Lansing Rowan, the California actress who has challenged Champion Corbett to meet her in a scientific sparring contest, committed suicide by shooting himself through the heart. By his side lay a copy of Saturday's edition of the Batavia Daily News containing a dispatch announcing that his daughter had challenged Corbett.  
Mr. Rowan left a letter addressed to his wife, the contents of which she declines to make public. Mr. Rowan was 65 years old.

**YACHTING PARTY DROWNED.**  
Shawnee, Wis., June 28.—Word has reached here of the drowning of six persons, at Shawnee lake, during a gale this evening. A party consisting of O. A. Risua and wife, Hermann Dracker and wife, Louis Coker, wife and child, of Pulver; Miss Emma Garbrecht, of Shawnee, and Miss Margaret Cowe, of St. Nazian, Manitowish county, started from Cecil about 5 o'clock in O. A. Risua's yacht for a few days' outing on the north shore of the lake. When about three miles from shore, the boat was capsize by a sudden squall and the party precipitated into the water. Mr. Risua and Dr. Dracker clung to the capsize yacht for several hours, the latter holding the child in his arms, when they were rescued by parties from Cecil who were attracted by their cries for help. The bodies of the other six have not been recovered.

**FENDAL ADAMS DROWNED.**  
On Friday, June 26th, while three young men of Roseburg were bathing in the river, Fendal Adams undertook to swim out to a rock in the midst of the stream, but from some cause became exhausted and sank and was drowned. Every effort was made to rescue the young man without avail. Cash Trask, who had rescued four other persons from drowning at the same place last year, tried to rescue the body by repeated diving, but failed. Several days later, however, he found the body of young Adams

on a raffle below where the drowning occurred.

**A GREAT FINANCIER.**  
Portland, June 27.—Clarence F. Jewitt, secretary of the Pacific Investment Co., who has for several years occupied a high business and social standing, is wanted here to account for financial shortages amounting to \$20,000.  
For the past eight months Jewitt has been swindling five banks in this city. So successfully did he conduct his operations that nothing was suspected until about a week ago, when he suddenly left the city.

**ALTFELD REPLES.**  
Springfield, Ill., June 28.—Governor Altgeld was asked tonight what he thought of the interview given by William C. Whitney. He replied:

"The American people are not yet ready to become the vassals of the English money-lender, and his American agent. The policy which the government has pursued for more than 20 years, at the instance of those eastern speculators, compels the producers and consumers of this country, who bear all its burdens, to give those English money-lenders \$2 worth of labor, \$2 worth of property and \$2 worth of their life's blood for each dollar they get from those Englishmen. This is destroying our country, and the Democratic party intends to condemn this policy in most emphatic terms, and no matter how much those eastern capitalists and speculators may be willing to spend, they are going to have a very difficult time in trying to prevent the party from expressing its honest convictions on this subject.
