Co-operative Fishing and Canning.

"A Bandon Fisherman" furnishes the Bandon Recorder a good and suggestive article relative to this river for salmon fishing, except that he does the HERALD the injustice of misrepresentation—we are willing to presume unintentionally. He says: "The HERALD a short time ago contained an article which tried to lay the blame on our wooden mill here." Now, the HERALD did nothing of the kind, but only stated that it was a question of possible cause being discussed by the fishermen, "A Bandon Fisherman" possibly being one of them. But suppose the HERALD had not referred to the matter, it is altogether probable the subject would have been dropped and our river destroyed of that valuable industry by the cause now existing, whatever it may be. The HERALD is the sincere friend of both the fishermen and the wooden mill, and legitimate enterprises. It hopes the opening up of the question will result in doing all for the river and promotion of the fishing industry that the Bandon Woolen Mill Co. and "A Bandon Fisherman's" communications have portrayed to the extreme of their desires.

And the HERALD hopes furthermore that "A Bandon Fisherman's" proposition for the fishermen to incorporate and do the fishing and canning themselves may crystallize—it is just in the line of the HERALD's teachings under the former editor, who was a charter member of the "Coquille Fishermen's Union," and of the present editor who has been a member of one of the leading craftsmen's unions for 27 years and of the Federated Trades since its organization, and an organizer, advocate and friend of the K. of L. and labor unions. Moreover, the last named had prepared a measure four years ago to provide for a hatchery on the Coquille, but was persuaded out of pressing it by one whom he supposed was more familiar with the needs of the river in that line, under the belief that the fishing law then adopted would prove efficient without the expense of a hatchery.

So now go ahead and organize your co-operative fishing and canning enterprise, and the HERALD is with you. But why not make it a Labor Exchange, and then you will not be dependent on bulling and bearing the market in competition with trusts and combines which manipulate them, or crush you if you don't do their bidding? We already have headquarters in San Francisco and Portland to handle them and despite the other fellows, and a large and increasing membership all over the land who will purchase them in preference to those manipulated through the general market, the related through the general market, Start in and receive the benefits of your labor instead of others getting it; you receive the reward instead of putting it into the hands of middlemen and wealthy manipulators, robbing both the producers and the consumers.

Obituary.

Our worthy and highly respected fellow-citizen, James Alexander Metlin, died at the residence of his daughter, Mrs. M. Augusta Hastings, on Cunningham, near this city, last Friday—Nov. 27, 1896, at 5 minutes past 1 o'clock p. m.

Mr. Metlin was born in Union county, Pennsylvania, Oct. 12, 1815, and was therefore 81 years, 1 month and 15 days old at date of his death. He slept his last few hours; peacefully, quietly, calmly in the presence of his youngest daughter.

At the age of six months he was taken with his father's family, consisting of father, mother, two sisters, four brothers, a family friend and one cousin—a happy company of emigrants—to fix their home in the then new country of Ohio. Two and a half miles from the new city of Akron, in Springfield township, Summit county, they established themselves in a pleasant home, and there the family grew up and married and built homes of their own. It was a prosperous family. James (the subject of this sketch) was the youngest and married at about 22 years of age to Miss Julia Ann Wise of near Wadsworth, Medina county, Ohio. She was an energetic lady, of good family, and the union was blessed with nine children—seven boys and two girls—four of whom now survive the parents, the mother dying when Charles A. Metlin, now a resident of Empire City, in this county, was 11 years old. The children surviving are Thomas T., now of Tallmage, Summit county, Ohio, for about one year a resident near Myrtle Point, in this county; Mrs. Jennie M. Reed, widow of the late Wm. Reed, M. D., of near Kansopolis, Kansas; Charles A. of Empire, and Mrs. M. Augusta Hastings, on Cunningham, with whom for over 20 years Father Metlin had made his home and passed away at the date above mentioned. Father Metlin joined the Presbyterian church in his early manhood and was a consistent member throughout his life. He had a large acquaintance and was loved and esteemed by all who knew him. He had been partially paralyzed some months since, which with his weight of years brought his decease, which was peaceful and calm.
