Durrant Again Sentenced. San Francisco, April 10.—For the second time William Henry Theodore Durrant has been sentenced to be hanged for the murder of Blanche Lamont at Emanuel church two years ago this month. The sentence of death was today pronounced by Superior Judge Bahrs in the presence of a crowd of spectators, who packed the largest courtroom at the city hall, many people being unable to obtain admission. The court sentenced Durrant to be hanged at San Quentin prison, June 11. He was taken at once to San Quentin.
