

Art Display.

Last Friday afternoon was the time set by Miss Keely, teacher of art and music at our Collegiate Institute, for a free exhibit of the work of her art class at the parlors of President Futrell's residence.

An almost continuous stream of visitors attended and inspected the art work of the class, and many confessed much pleasure at their visit.

The studies were mostly framed and placed on easels, or hung on the walls in groups and singly for advantageous inspection;

some were festooned with flowers and ferns, and pot-plants and vases of flowers filled in at other points about the rooms, art and nature blending charmingly to inspire the visitors with the beautiful.

This reporter takes pleasure in noting the following as worthy of special mention:

The first to greet us was a very handsome landscape, of much larger proportions than generally, by Mrs. G. F. Bontell, whose artistic skill we have mentioned before and which is highly creditable.

The coloring was natural, not brilliant, and the perspective artistic, exhibiting a cottage beyond a skirt of timber, through which a small stream meandered.

Miss Flo Boyrie had three exhibits, one or two of which we had mentioned before. A new one, a water-fall scene, was a very handsome piece.

This young lady is quite an artist. Miss Myrtle Fox had three exhibits, also. Mt. Hood (not finished and yet very pretty in design and coloring), a panel picture of orchids, and another.

Mrs. C. W. Martin, our enterprising merchant, surprised us. We were not aware that she had either time or talent to give, knowing as we do that she is such a business person, but two pieces exhibited by her were exceedingly handsome and meritorious, showing marked talent in designing and progress and skill in blending colors.

One piece was an oblong landscape, including some objects of animated life; another was a flower piece—poppies.

A china set of Miss Keely's own handiwork was next, but we dismiss it with the criticism that she is an artist of much ability, and this decorated ware speaks loudly for her.

Mrs. R. S. Knowlton had two or more pretty pieces, a landscape, and a panel of lilies and morning glories, both of which exhibited marked taste and culture.

The lilies and morning glories filled our eye, for we thought the piece unusually pretty in both design and finish.

About, in niches and more retired places, were other beautiful thoughts by Miss Keely. There was a fruit-piece—a cut melon, very inviting in its naturalness, with the knife still penetrating it, and about it were pears and other fruits; and close beside, on the tray, was a bottle—supposedly the one containing the oil for mixing the artist's paints, though not that shape, exactly—a goblet, etc., making altogether quite a combination for the artist to pencil. Then there was a picture of odd-shaped earth-ware, drawn from nature, and a water-color of vase and flowers.

Altogether the exhibit was a success and a very pleasing affair, creditable alike to teacher and pupils. Miss Keely has organized classes in Myrtle Point and Bandon, and we bespeak for her the patronage of the art-inclined of those places, and are sure they will not be disappointed.

DESTITUTION AMONG MINERS.

Evidence Shows Starvation Wages Are Paid in Pennsylvania.

Wilkesbarre, Pa., May 6.—The legislative committee investigating the condition of the miners of this region is very much in earnest and is evidently determined to get at the root of the cause for the general destitution and suffering growing out of the lack of work.

The first session of the committee was held today. A large number of miners and laborers were examined as to the time they have worked lately, the condition of the mines and the plan of management. All testified there was much less work than there was a few years ago. Many attributed the cause to the influx of a large number of foreigners, who work for less than the English-speaking miner can afford to work. They also attributed many of the accidents to these men, who are careless and inexperienced miners.

Several employes of the Lehigh and Wilkesbarre Coal Company gave such favorable testimony that Major Roberts remarked to the other members of the committee that he did not think the company was furnishing a fair sample of witnesses, as those who testified were fortunate men who are working gangways, and what they earn is not a fair criterion from which to form an estimate of the earnings of the average miner.

Summing up the testimony of the day, it was apparent that even the miners who were making the highest wages were earning barely enough to live upon by exercising the strictest economy.

County Court Proceedings.

Court met at 8 o'clock, a. m., Tuesday, May 4, 1897, pursuant to adjournment of April 16, 1897, and pursuant to call of April 29, 1897. Present, same officers as before.

It is ordered that the Coquille Mill & Tug Co. be allowed \$1.40 for nails furnished road dist. No. 11. In the matter of the fees of S. N. B. Hunt, constable, in conveying J. N. Russell to the county jail, it appearing to the court that the said S. N. B. Hunt claimed the sum of \$20 for fees and expenses in conveying J. N. Russell to the county jail from Bandon, Oregon; that this court not being fully advised at the time of the presentation of his account at January, 1897, term, allowed him \$14 for said services and expenses, leaving a balance due him of \$6. The court, having fully examined into said matter, finds that there is still \$6 due him for said services and expenses. Therefore it is ordered that he be allowed \$6, the balance due him for services rendered in conveying said J. N. Russell to the county jail.

Whereupon court adjourned to a day or days to be appointed by J. Henry Schroeder, county judge.

THE GENERAL SIGLIN'S FATE.

Wreck of the Schooner Is Floating in the North Pacific.

Seattle, May 11.—A dead body is lashed to the iron davits in the stern of the schooner General Siglin, which is being driven aimlessly about in the North Pacific ocean 110 miles west of Queen Charlotte island and directly in the storm track as shown in the pilot chart of the hydrographic office for May. The limp form that hangs on the davits is the only thing about indicating past occupancy of human beings. This was the news brought by the sealing schooner Willard Ainsworth, which arrived here today from a cruise to the north and it places beyond a doubt the fate of the General Siglin and those aboard. The Siglin was sighted on Wednesday morning, May 5th. She was lying on her right side with her masts out and one lying alongside. The Ainsworth passed very close, but could not lower the boat because of a heavy sea.

"There did not seem to be much about the matter," said Captain E. E. Crockett, of the Ainsworth, in recounting his experience, "save that the butwarks were stove in and there was no sight of a boat aboard. The body of a man dressed in oil skins was lashed to the iron davits on the stern. He was in a standing position, with his head and right arm hanging inside the iron, while his left hand was dangling outside.

Absence of boats on the Siglin would indicate that those aboard had made every attempt to get away and hopes are still entertained that some boat managed to survive the storm and was picked up by a passing vessel.
