Church of St. James, the Apostle.

Bishop B. Wistar Morris, of Portland, representing the Protestant Episcopal Church of America, and Rev. W. Horsfall, of Marshfield, missionary of this district, were present in this place last Friday morning and laid the corner stone of an edifice christened with the name above mentioned.

The ceremony was not expected before Saturday following, for which time the appointment was made, but owing to a growing indisposition on the part of the aged bishop, brought on by traveling so far to reach our section and also to fill several appointments in this and Curry counties, the ceremony was set at this early hour to enable him to take the train and get home before a severe sickness had prostrated him.

His other appointments, for services Saturday night, and Sunday morning and night, were also canceled.

The service began about 10 o'clock a. m., Mr. Wrenshall, the contractor, assisted by Judge Nosler, having prepared the corner pillar and depository.

Bishop Morris then headed a procession and moved to the place, offered a prayer, announced a hymn by the choir, and then instructed Rev. W. Horsfall to announce the contents of the box which had been placed in the corner stone.

The reverend gentleman then read from a letter-head of "Hotel Coquille, Coquille City, Oregon," as follows:

"Articles deposited in the corner stone of the Church of St. James, the Apostle, Coquille City: September 7, 1897.

"The Right Reverend B. Wistar Morris, D. D., Bishop; the Reverend William Horsfall, Missionary; Messrs. W. C. & H. Wrenshall, Builders.

"A copy of the Holy Bible; "Book of Common Prayer; "Journal of the Oregon Convention for 1897; "Spirit of Missions for August, 1897; "Oregon Churchman for July, 1897; "Pacific Churchman for August, 1897; "St. Peter's Parish Magazine of Bandon, Ireland, for August, 1897; "Coquille City Bulletin for September 17, 1897; "Coquille City Herald for September 14, 1897; "Marshfield Sun for September 9, 1897; "Marshfield Coast Mail for September 11, 1897; "Bandon Recorder for September 10, 1897; "Quarterly Message of Board of Missions for January and March, 1897; "Myrtle Point Enterprise for September, 1897.

At the conclusion of this reading, the bishop delivered a brief, eloquent which he recited the origin of the effort to establish a church at this place, which came first through a voluntary donation to the church extension work in this diocese from Miss S. M. Wain, of Philadelphia, Pa.

Then followed another hymn by the choir, at the conclusion of which the bishop announced the cancellation of other appointments for services at this place, on account of his illness, and dismissed the audience.

The reverend bishop departed on the train for his home. He is in his 80th year, and the journey was long and arduous, besides the numerous appointments he had made for this and Curry counties.

The choir comprised Mrs. L. H. Hazard and Mrs. Nora A. Good, soprano; Misses Mand Nosler and Maggie Thom, alto; J. S. McEwen and Aaron Wilson, basses.

IN MEMORIAM.

On September 14, 1897, sorrowing friends were called by the Undiscovered Country to its frontier, and the children of Mrs. Thebe Whittington were bidden to draw an affectionate farewell and to draw the pall upon the bier of their affectionate mother. The respected lady had been suffering the ravages of consumption for several years, and as she had been nearly three-quarters of a century fit away, she succumbed to the terrible disease sooner than was expected. And on the 14th inst. she quietly passed to the "other shore" while her two loving sons were present and had done all in their power to relieve the sufferer during her last days on earth, her three daughters being absent. About 25 years ago, M. P. Whittington, the late husband of this sketch, came into this valley and settled on the South Carolina was their native state and the Whittingtons were fully settled there was a large emigration from that state to Coos county, who have ever been ready to testify to the good qualities of M. P. Whittington's family. After building up a fine home on the South Coquille, Melvin P. Whittington passed to that Undiscovered Country about six years ago, leaving a bereaved widow, whom, let us presume has just joined him, and a family of two sons and three daughters. The young men have always remained on the old homestead and bore patiently and willingly the duty of caring for their aged mother, whose age reached to 74 years, 10 months and 11 days at her demise. Mrs. Whittington's maiden name was Thebe Caragan, and on March 25, 1843, she was joined in holy wedlock to M. P. Whittington in the state of North Carolina. Mr. Whittington was entrusted with some important positions in Wau-tauga county, N. C., and was highly respected for his just and honest course in life. The aged pair who buffeted the storms of life together, including the terrible scenes of the civil war, are now laid to rest side by side on a mound on the homestead, where neighbors will point with unbounded respect and sadness to the last home of the noble dead. Rev. Thomas Barklow conducted funeral services on the 15th, at the family residence, and a large concourse of neighbors and friends assembled to pay their farewell tributes to the dead.

A Serious Accident.

A serious and probably fatal accident occurred last evening near Myrtle Point in which Pat Phelan, of Marshfield, son-in-law of our townspeople, Mr. and Mrs. John Nasburg, was the victim. We learn that he and another party got a conveyance at Myrtle Point and were driving out; that during the drive the team became unmanageable and the buggy went over a grade. Mr. Phelan was picked up very badly hurt and suffering from concussion of the brain, while it seems the other man escaped. Phelan was brought to Myrtle Point and medical aid called. A special train went up to that place last night and about midnight or later delivered Mr. Phelan at the hospital at Beaver Hill in a very critical condition. Phelan is an employe of the Beaver Hill Mining & Railroad Co., serving as "scaler" at the Porter sawmill, which is under lease to the above company.

Mr. and Mrs. Nasburg drove down to Beaver Hill this morning, from whom we expected to learn of Phelan's condition as we go to press.

Judge Lynch in Indiana. Louisville, Ky., Sept. 16.—A special from Osquod, Ind., says: Incensed by numerous depredations, repeated burglaries and daylight robberies, the people of Ripley county, Indiana, have taken the law into their own hands and meted out to the perpetrators, punishment greater than that provided by law. Five men who have long been a terror to the citizens of that country met their death at the hands of an enraged population.

When the citizens of Versailles, the county seat, arose they found the bodies of five men dangling from as many limbs of an elm tree in the public square. Stout ropes, not over six feet in length, had served to send the men to their destiny. Their feet were but a few inches from the ground, while their hands and feet had been securely pinioned with strong ropes.

The farmers would come into town with a bunch of cattle or a load of farm products, and next morning would be found along the roadside suffering from wounds and minus the proceeds of their sale. Old German farmers have been visited and both men and women have been subjected to all the tortures that a hardened mind could conceive.

It was 1 o'clock in the morning when the mob seemed to come from all quarters and dismounted on the side of the hill near Versailles. About 400 men marched into the town. The jail was in charge of William Kennan, Sheriff Bushing's brother-in-law. Shortly before 2 o'clock there was a knock at the door and when Kennan and the others opened it they were confronted with pistols by three masked men and asked to turn over the keys. This they did. Then the mob filed into the jail.

Levi Jenkins and Schuller showed fight. Levi was shot through the breast, while the skulls of the two latter were crushed with stools. Ropes were in readiness. A noise was adjusted around the neck of each man, their feet and hands were pinioned and then the march began. With several men at the end of each rope the five prisoners were dragged a distance of 200 feet to the elm tree where the bodies were suspended.
