

THE LABOR EXCHANGE.

The Accountant: Laboring men need as much "protection" from the corporations as they do from "cheap" foreign labor.

Branch 224, of Alliance, Ohio, is operating a coal mine with fifteen men at work. It also employs several more making brooms, baskets and wagon jacks.

The Accountant: The day is coming when a loafer (rich or poor) will be treated with the same contempt that is now accorded a professional tramp. They are a burden and curse to humanity.

Branch 191, of Akron, Ohio, is building fourteen miles of railroad in Wayne county. The farmers along the route are accepting checks for the right of way, labor and material. This branch has built its own depository, and has started a broom factory.

Good times and bad times are the fever and chills of a sinking system. Every chill is more deadly than the last. When the fever flame of prosperity flares up a little the glazed eyes glisten with greed, unconscious that prosperity of the few means plunder of the many.

The Accountant: Nine laboring men out of ten have spent years of hard work under the wage system and by living with the strictest economy and denying their families many necessities, have succeeded in saving up \$800,000. Oh, it is a great system, but if you don't like it—try the Labor Exchange.

The Accountant: Much is being said in the papers about prosperity and the bounteous crops, but each laborer should notice particularly how much it affects his wages—especially employes of large factories. If the change is not appreciable, then give the Labor Exchange a serious thought, and see how nice it would seem to get a share of the profits in addition to the wages paid.

Appeal to Reason: The Declaration of Independence, the platform upon which the campaign of 1776-1783 was fought, is radical. The constitution is conservative. Thus the leaders always get the people's bodies to stop bullets or their votes to boost them into office. A radical battle cry and a conservative interpretation of it when victory is secured. How long, oh Lord, how long must the people remain at the mercy of the leaders, military and political?

The New Dispensation: The murdered miners of Hazleton were SUBJECTS of the Royal Robber of Austria and starved out of his dominions before they came to Pennsylvania to be starved some more and finally shot. To apply back to Austria for relief is like applying to Beelzebub for protection from Satan. We are not yet denied the hope that the grim phantom of death may be kinder than conscienceless human fiends, and that those who were shot may be better off than the living who return to their prisons of endless labor and life without hope.

The New Dispensation: There are over 10,000 murders a year in the United States, and 4000 suicides; and God only knows how many perish from vile conditions of poverty and industrial anarchy. If the United States wants to reform Spain, it should begin by freeing its own slaves, and establishing peace and justice within its own borders. If Uncle Sam would do this, the example would be so illustrious that no force of arms would be needed to inspire other nations to follow it. The attraction of a higher ideal is the only motive of reform. But Uncle Sam is too tough an old sinner to be expected to reform till after he is dead.

The New Dispensation: The Spanish war scare is a flimsy fake, a play to cover a speculation in bonds; but its vibrations show clearly that the present system is based on the shifting sands of ignorance and false pretense, and when the storm of evil passions is finally let loose, it will be utterly destroyed. Consider for a moment the absurdity of a boasted Christian civilization resting on its arms so that at any moment the rulers, by touching a button, can fire the magazine and set the dummies shooting one another to pieces with accompaniment of brass bands and chanting choirs. The safety of the system till the final collapse comes, depends on the incidental uncertainty that the rulers dare not touch the button.
