NOW FOR THE SWISS PLAN.

Initiative and Referendum—An Oregon Man's Opinion.

The People Should Be Called
Upon to Take Direct Charge
of the Law Making and Tax-
ing Power.

[The following interesting resume
on the Initiative and Referendum,
by an Oregon man who studied its
advantages in the land of its adop-
tion and sway, the little, but model
republic of Switzerland, deserves
careful reading and study.—Ed.
HERALD.]

"Having business in England de-
manding personal supervision, and
being deeply interested in that sys-
tem of government known as the
initiative and referendum, I this
year visited Switzerland for the ex-
press purpose of studying this po-
litical prodigy in its home. Having
gone via Holland, Belgium and the
Rhine, my first stop in Switzerland
was at Zurich, a city of 150,000 in-
habitants, situated in the canton of
Zurich. The city of Zurich, like
the canton of Zurich, is governed
by the people through the initia-
tive and referendum. Zurich is out
of debt, owns its street railways,
waterworks, gasworks, etc. Gas in
Zurich sells for 80 cents per M.,
although the coal is imported from
Germany. On the street cars one
is charged by distance and the fare
is relatively cheaper than in any
American city. The city furnishes
the telephones in conjunction with
the federal telephone system, at \$24
per year, for each phone, and one
can telephone from one end of
Switzerland to the other for 12
cents. In Zurich there is no class
of authority, no suggestion of cor-
ruption, and the levy for city pur-
poses is less than one per cent on a
low valuation of property. I could
not help mentally comparing the
city of Zurich, under a democratic
system of government, with that of
Portland under a representative
system. The latter city is but half
the size of Zurich, yet it is millions
of dollars in debt, its government is
notoriously corrupt and its taxes
are excessively high.

At Berne, the capital of Switzer-
land, my letters of introduction
gave me entrance into the political
circles, and I was thus afforded
every opportunity to study the
social and political condition of the
Swiss republic. There I met Dr.
Guillemin, director of the federal
bureau of statistics, and General
Emile Frey, who is one of the
noblest specimens of physical and
mental manhood I ever saw. Gen-
eral Frey came to the United States
in 1860 and in 1861, enlisted as a
private in the twenty-fourth Illinois.
He left the company next year as
first lieutenant and recruited com-
pany H, eighty-second Illinois, by
which he was elected captain. The
next year he was made major
general for gallantry in action, and
after having been a prisoner in Sal-
isbury, and held as hostage for
Captain Gordon, was mustered out
of service. At the close of the war
General Frey returned to Switzer-
land and in 1882 was accredited to
Washington as minister from Swit-
zerland, which position he held until
1888. He then returned to Swit-
zerland and in 1890 was elected
president of the confederation. He
is now at the head of the telegraph
department of Switzerland.

No man is more competent than

General Frey to judge of the merits
of the initiative and referendum as
applied to this country. His love
for Switzerland is no greater than
his affection for the country for
which he so bravely fought, and
when I asked for his opinion upon
this question he gave it candidly.
He said:

"I am profoundly impressed with
the idea that the American republic
must so change its system of gov-
ernment as to give the common
people the right to make and un-
make the laws under which they
are to live. They haven't that de-
gree of liberty which they think
they have, or which they ought to
have, and they will never acquire it
so long as their present system of
representative government exists.
I do not say that our system would
work in your federal affairs, but I
am certain it would prove a grand
success in state affairs. In our
country corruption and extrava-
gance are unknown and the people
are making good progress in all
that makes for better citizenship.
We have proved the system to be a
success, and if the American people,
with their greater intellectual
capacity and untold natural re-
sources, had it they would astonish
the world with material and political
progress."

During the three weeks I stayed
in New York city, previous to sail-
ing for Europe, 18 men and women
committed suicide in that city on
account of "despondency occasioned
by failure to secure employment."

In discussing the compulsory edu-
cational system of Switzerland with
Karl Burkli, the noted writer on
political economy, I inquired:
"What provision is made where a
parent is too poor to provide books
and clothing for his children?"
"Sir," said Mr. Burkli, "I never
in my life heard of a Swiss saying,
'I cannot send my children to school
because I have not shoes, I have not
money to buy books.'"

Switzerland is one-sixth as large
as Oregon, and but 70 per cent of
its total area is habitable; it hasn't
a mine of any kind within its do-
main, and regularly imports more
than it exports. In some cantons
the German language is spoken, in
others the French, and in others
Italian. It is often necessary for a
member of the federal council to
make a speech in three different
languages (with the aid of official
interpreters), yet in face of these
geographical imperfections and
social difficulties General Frey states
that they make better government
than we have, and Karl Burkli says
that no Swiss is too poor to educate
his children. Verily one is tempted
to exclaim: Vox populi, vox Dei.

I haven't time, and you would not
care to spare space for an extended
review of this subject, but I must
say that my trip to Switzerland
deeply impressed me with the im-
portance of placing the law-making
and taxing power of the people of
each state into the hands of those
who are to live under the laws and
pay the taxes. It is idle to expect
reform from superceding the party
in power with some other party, for
experience teaches that any party
long in power will become corrupt.
In this state we have Populist, Re-
publican and Democratic members
of the legislature, and we have
found that while each party has
some honest and intelligent rep-
resentatives, a majority of each party
in joint hands in passing laws which
the people do not want. In fact, a
great proportion of the law-making
has passed out of the hands of the
legislature and exclusively into the

hands of the speaker of the house,
the president of the senate and the
governor. Somehow we are unable
to elect men who will prove mind-
ful of constitutional limitations, and
the most solemn promises of party
platforms are totally ignored by the
successful candidates. The scandalous
conduct of ex-Senator Mitchell, in
his personal interference with the
organization of the last legislature,
and its consequent failure to orga-
nize, together with biennial appro-
priation of public funds for the sup-
port of predatory officials and in-
stitutions not within the purview
of our constitution, have caused our
people to cast a friendly eye upon
this new system of government. And
the question to be decided at the next
election in Oregon is, "Shall we have
a government of the people, by the
people, for the people?"

Debtor vs. Creditor.

ED. HERALD: As a rule it seems
that the people don't understand
the relationship that exists between
debtors and creditors and hence are
inclined to censure the debtor too
severely if he fails to pay at the
time specified, calling him "devoid
of financial ability," "incapable of
attending to his own business," and
various other uncomplimentary ad-
jectives. Now, the fact is that the
man who loans is frequently just as
short-sighted as the one to whom he
makes the loan; i. e., when the prop-
erty taken as security falls in value
to such an extent as to cause a
loss to the lender, as is commonly
the case when anything connected
with it is made public. Is it not
evident that if A borrows \$1000
from B, and gives B a mortgage on
property which is valued at three
times as much as the amount bor-
rowed, and prices so decline that
the property will not sell for \$500,
that B's judgment was as deficient
as A's? And if B refuses to take
the property mortgaged in liquida-
tion of the debt, has he not gone
back on his agreement? While if
A stands ready to deed the property
to B which secures the \$1000, does
he not thereby morally cancel his
obligation? Or, suppose B loans
the money to A, and takes no se-
curity, relying on A's actual wealth
as sufficient security, and adverse
circumstances striking the commu-
nity reduce values so that A cannot
pay, is A any shorter-sighted,
financially, or any more entitled to
censure than B is? And, further,
is A not more entitled to sympathy
and condolence than B, since he has
lost at least three times as much as
B has, the decline not being due to
any act of either party? Notwith-
standing the fact that neither cred-
itor nor debtor is to blame for such
failure, you will hear many shallow-
braided people condemning the
debtor, and yet many of the same
people were ready to vote for a
man for president who failed to do
the amount of \$118,000.

Before dropping this subject, we
will say that he who receives money
from others, squanders it foolishly
or invests it in property and covers
the property up so his creditors
cannot reach it and then fails to
pay, is no better than a thief, and
should be dealt with the same as a
"poor" thief is dealt with.

Communication.

ED. HERALD: I had concluded
some time ago that further argu-
ment on my part, about the tenure
of office and the number of terms
an individual might be permitted
to occupy a position would be un-
necessary.

Where the voters decide to elect
a man to repeated terms of the
same office, they will do so regard-
less of opposition and the evil re-
sulting from that course. Person-
ally, I have quit opposing second
or third terms or any other
amount of terms that a perpetual
office-seeker may have the unblush-
ing gall to solicit. The welfare
of a party rests not with such peo-
ple nor with the unthinking crowd
who perpetuate the process. It
leaves the party open to the accu-
sation of self-interest and influ-
enced by the same greed for office
that has been the bane of both the
Republican and Democratic parties.

There never existed a man whose
qualifications for good or evil could
not be duplicated; and while we
may evince sorrow for the demise
of a noble character, to say that the
world will miss him is an absurdity.
To make an idol out of a fallible
being or to hold him up as an ex-
ample by way of eminence is equally
absurd. In a good character we
may find much that is worthy of
emulation; still, the mysterious is
beyond us, and the mind of an in-
dividual, like the structure of the
universe, too deep an abyss for us
to probe.

In conclusion, I would suggest
that those who claim to have the

welfare of the party at heart should
give some consideration to this
business of office-holding; and,
where a worthy man has received a
second term, to decide if that be a
sufficient recompense. It certainly
ought to be considered sufficient.
Resting perfectly easy in this mat-
ter, and not being an office-seeker
nor an office-holder, and not desir-
ing to create or in any way engen-
der animosity, I remain, etc.,

A JOSEPHINE COUNTY FEUD.

At Cooldige, a Farmer, Shot from Ambush.
A Chetco Boomer's Feud.

Grant's Pass, Or., Nov. 14.—The
remains of "Curry" Cooldige were
today brought in on the stage from
Harbor, (Chetco, Curry county), Or.,
in charge of his brother, Alfred,
and were tonight shipped to his
home at Silverton for interment.
Alfred, who resides in Colfax, Wash.,
started for Harbor about 10 days
ago, arriving there Thursday even-
ing, and only a few minutes after
the news had reached town that Mr.
Cooldige had been shot. Alfred's
intentions were to persuade his
brother to return home.

The shooting was the result of a
long-standing feud, in which Mr.
Cooldige and a family of 12, named
Vampelt, are the principals. About
three years ago Mr. Cooldige sold
to the senior Vampelt and his two
sons a sawmill, taking their note,
which he paid last spring. As it
was not paid, action was brought
for the recovery of the mill, the case
being awarded to Cooldige. The
Vampelts took the law in their own
hands, and by force of arms com-
pelled Mr. Cooldige to vacate. Mr.
Cooldige then sought aid from the
sheriff, who ejected the Vampelts.
As soon as the sheriff departed, the
Vampelts again drove Mr. Cooldige
off. The aid of the sheriff was
again sought, the Vampelts ejected,
and the same was repeated for the
third time, whereupon the sheriff
informed Mr. Cooldige that the law
allowed him to protect his property,
even if he had to do so by force of
arms. This he did, after which the
Vampelts declared a truce, and
everything went along well for
about two weeks. Thursday last
Mr. Cooldige, in company with a
Mr. Smith, went a few miles out of
town to look over some timber.

Upon their return Mr. Cooldige
was shot from ambush, Mr. Smith
dropped off the wagon on the
opposite side, and as he did so he
saw three men rise up from behind
some brush, whom he recognized as
some of the Vampelts.

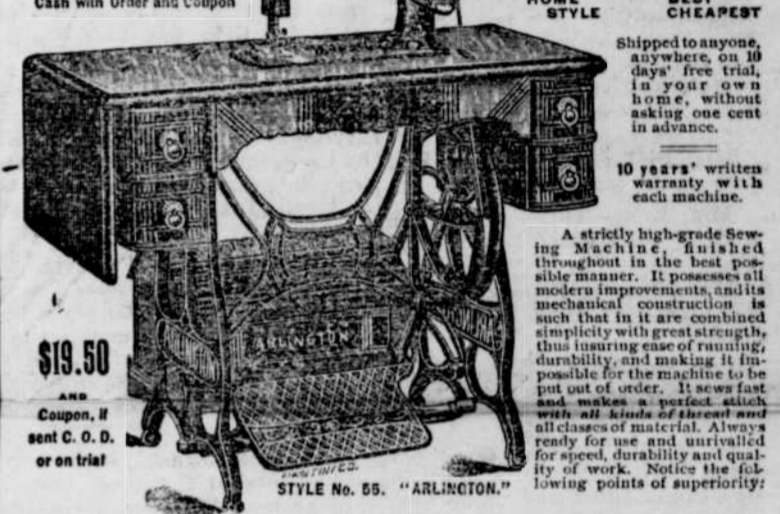
