Just at the dawn of the annual reunion of our Coos county pioneers, the summons was made and another of the veterans of the struggling early settlers of this vicinity laid down to rest.

Thomas Rufus Willard was born in New York state in 1825. At an early day he moved west, living some time in Illinois.

The burial took place Thursday last at the Masonic cemetery, and was participated in by many citizens and prominent Masons, members of the Star and pioneer friends from all parts of the county.

Latest War News.

OFFICIAL STATEMENT OF TERMS. Signatures Attached to Peace Protocol. Document Was Signed by McKinley and Cambon This Afternoon.

Washington, Aug. 12.—The peace protocol was signed at the White House at 4:23 o'clock by President McKinley and Minister Cambon.

OFFICIAL STATEMENT. Washington, Aug. 12.—Secretary Day gave out this statement of the provisions of the protocol:

"Spain will relinquish all claim of sovereignty over and title to Cuba. 'Porto Rico and other Spanish islands in the West Indies and an island in the Ladrones, to be selected by the United States, shall be ceded to the latter.

"The United States shall occupy and hold the city, bay and harbor of Manila, pending the conclusion of the treaty of peace, which shall determine the control, disposition and government of the Philippines.

"Cuba, Porto Rico and other Spanish islands in the West Indies shall be immediately evacuated.

"Commissioners, to be appointed within 10 days, shall within 30 days from the signing of the protocol, meet at Havana and San Juan respectively to arrange and execute the details of the evacuation.

"The United States and Spain shall each appoint not more than five commissioners to negotiate and conclude the treaty of peace. The commissioners are to meet at Paris not later than the 1st of October.

"On the signing of the protocol hostilities will be suspended, and notice to that effect will be given as soon as possible by each government to the commander of its military and naval forces."

ORDERED TO CEASE HOSTILITIES. Washington, Aug. 12.—Secretary Alger has cabled orders to the military commanders to cease hostilities.

Dole Will Be Hawaii's Governor. San Francisco, Aug. 9.—Senator Morgan of the Hawaiian commission, is quoted as saying that ex-President Dole will be the first governor of Hawaii, and not minister Sewall, as recently reported. The senator added that he had the best of reasons for believing that Admiral Miller was carrying Dole's commission to the island.
