AN ILLEGAL CESSION.

Aguinaldo's Representative on the Peace Treaty.

London, Dec. 15.—Aguinaldo, the representative of Aguinaldo in the Philippines, starts for New York on Saturday, to, as he alleges, resume his duties as a representative of the Philippine government at Washington. He said: "The only portion of the Spanish-American treaty which we were concerned in, is the cession of the Philippines, which is illegal, as the Spaniards had lost their sovereignty over the islands, and the Americans cannot dispose of the future of the archipelago without consulting the Filipinos. Their consent, by a popular vote, is necessary. The United States cannot carry out this measure. My countrymen will resist to the bitter end any attempt to sell the Philippines to any foreign power. We are anxious to be united and allied to our good friends, the Americans, but beyond this we are determined, at all hazards, to remain independent."

Another Spanish Quibble. Seneca Must Accept the Peace Treaty Before Spain Will Cede Her Possessions.

Madrid, Dec. 15.—A semi-official note was issued today that says: "As American senate must ratify the treaty of peace before it becomes effective, our governments should wait for this ratification and not hasten to cede territory which the United States senate may not accept."

Congressional Proceedings. Washington, Dec. 15.—Miscellaneous business, including the passage of several minor private bills, was disposed of at the opening session of the lower house of congress today. Debate on the bill to incorporate an international American bank was then resumed. Bell, of Colorado, a Populist, opposed the measure.

Sulzer, New York, also antagonized the bill, claiming it would create a gigantic monopoly. Barrett, of Massachusetts, offered an amendment that the powers granted under the bill should be conferred on any national bank, which filed an application with the controller of currency, in conformity with the general requirements of the bill.

The international bank bill was defeated in the house 103 to 148. Ridgely, of Kansas, Populist, offered substitute providing that the United States establish such a bank as the bill created and that the bank have a branch in every city and town exceeding a population of 2500 and in every Central and South American country where the United States had a consular office, such officer to be the bank's representative.
