Oregon's Legislature at Salem in Regular  
Session.

Salem, Jan. 9.—The legislative  
assembly convened at 10 a. m. today,  
and the senate immediately adjourning  
until 2 p. m.

Helena, Jan. 10.—The legislature  
yesterday appointed a committee to  
investigate alleged attempts at  
bribery of members in the interest  
of senatorial candidates.

Washington, Jan. 9.—At the opening  
of the house after a little paral-  
lysis the regular order was dem-  
anded, and the house proceeded to  
vote upon an amendment to the  
legislative, executive and judicial  
appropriation bill, which strikes out  
of that bill the appropriation for  
maintenance of the civil service  
commission.

Washington, Jan. 9.—In the senate,  
Mitchell reported from the mili-  
tary affairs committee a bill provid-  
ing that all honorably discharged  
soldiers and sailors who served in  
the war of the rebellion, and volun-  
teer sailors of the war of 1812 and  
of the Mexican war, and of the war  
with Spain, who may be disabled in  
any way, shall be admitted into the  
home of volunteer soldiers.

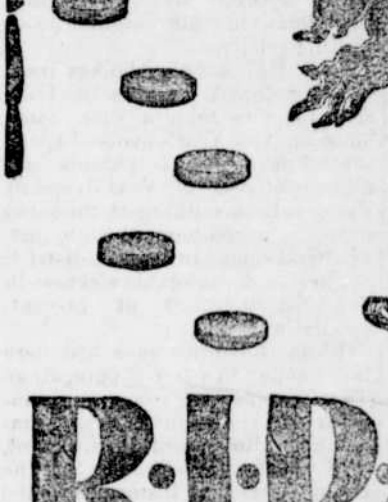
