RUDOLF SCHINZ DROWNED.

A Result of the Flood at Gravel Ford, on the North Fork.

Rudolf Schinz, one of the most progressive, prosperous and highly esteemed farmers and dairymen of the North Fork, was drowned at his Gravel Ford farm last Tuesday morning, in the presence of his wife who was unable to render him any assistance. James Bright, who, with K. H. Hansen, was on the scene only a short time after the drowning occurred and succeeded in recovering the body, gave us the following particulars regarding the sad accident: It appears that the river had overflowed its banks at that place and was still rising very rapidly, when Mr. Schinz, fearing that two of his horses which had been surrounded by water would be drowned, decided to go to their rescue and drive them to higher ground. He accordingly secured another horse, and in attempting to swim it across a deep ravine, the horse became entangled in a wire or post fence and Mr. Schinz was thrown off into the water, the horse then swimming back to shore. Mr. Schinz was said to be an excellent swimmer, but in some way he was disabled, or seized with cramps, and his wife, who was the sole witness of the affair, realizing that her husband was drowning, threw off part of her clothing and being a good swimmer heroically plunged into the cold water and went to his assistance but reached him just as he made his last struggle and sank. She then swam back to shore and gave the alarm. James Bright and K. H. Hansen being the first to arrive on the scene, about a half hour after the drowning.

Mr. Schinz was a sober, industrious young man about 28 or 30 years old and was held in the highest esteem by all. He came to this county about three years ago from Switzerland and entered into partnership with Fred Moser, the Gravel Ford creamery man and cheese manufacturer. About one year later Mr. Schinz was married and soon dissolved partnership with Mr. Moser to engage in farming and dairying. A wife and one small child survive him. Mrs. Schinz and babe have the heartfelt sympathy of all in their sad bereavement.—Enterprise.

The postmaster at Myrtle Point has written, under date March 1st, to the several postmasters explaining the present situation in reference to the mails, etc. He says: "No mails arrived from the east today. The mail carrier arrived this afternoon with no mail. He reports the roads impassable in places for horses, and the big bridge across Rock creek washed out, also others, and high water on the road. Tomorrow, March 2d, they will get the letter mail through by carrying it on their backs. Cannot get the paper mail in for three or four days or more, or until the roads are repaired and some way arranged to get horses across Rock creek. All mails coming here will go right out."

At this place some delayed mail matter was received Saturday, the first in four days.
