Mail Contractor August Halter Drowned.
The sad news of the accidental drowning of August Halter, near Harbor, Curry county, Sunday, March 5th, was received in this neighborhood the latter part of last week - by his brother George, who conducts the place near Arago, and in this city by Uriah Root, his brother-in-law - making known to them the very sad details, though brief, of the drowning. The letter received by Mr. Root was dated at Harbor on the 5th inst., the day of the sad occurrence, but not received here till the 10th. The letter to Mr. Root was written by W. T. White, and said:

"It becomes my sad duty, at Mrs. August Halter's request, to inform you of the death, by drowning, today, of August Halter. He and a friend went boat riding, and the boat capsizing August Halter was drowned. His grief-stricken family are receiving all the attention possible. * * * Monday, 6th. - The body has been recovered. Will be buried at Smith River tomorrow."

Mr. Halter had a mail contract along the coast down to Smith River, the dividing line between California and Oregon, and had only recently greeted his family as residents in that section, his place near Arago being run by his brother George. Mrs. Halter and one of the children were just recovering from a spell of typhoid fever, and could hardly stand the trip yet, but made out to reach Mr. Halter's place as prepared to receive them, when this fearful calamity befell them. August Halter was about 35 years of age. He leaves a wife and little son and daughter as nearest of kin to mourn his loss, as also two brothers and three sisters. He was a good citizen and held in high esteem wherever known.

A Sudden Death.
