In the supreme court, last Tuesday the case of Z. T. Siglin, plaintiff and respondent, vs. Cook Bay, Roseburg & Eastern Railroad & Navigation Co., defendant and appellant, and the case of the Cook Bay, Roseburg & Eastern Railroad & Navigation Co., appellant, vs. Julia M. Endicott and Wm. M. Endicott, respondents, were argued on appeals from Coos county.

County Superintendent Bunch's report of our county schools appears today and makes interesting reading for most of the people, especially the heads of families. What's the matter with Coos county—with 72 school districts, 94 teachers employed, school properties valued at \$46,000 and disbursements for the year of nearly \$17,000—when there are 823 children of school age not attending any school?

Under the new law every teacher is expected to report to the county superintendent as soon as a contract for teaching is made, the following items: The number of the district, date of contract, names of teachers and members of school board who sign contract, salary paid, date of commencing school and length of term in weeks contracted for. Teachers will do well to cut this out for reference, and comply with it. By so doing all parties interested will be accommodated. A postal card would contain the required information.

Death of a Pioneer Citizen.

Gabriel A. Brown, an old citizen of Coquille City, and a pioneer citizen of this valley, died at his home in this place last Friday morning, about 2 o'clock, after an illness of several weeks. Mr. Brown was born in Lyon county, Ky., January 16, 1833. He started for Oregon in 1861; crossed the plains through many hardships and reached Myrtle Point, Coos county, Sept. 14, 1861. He moved to Coquille in 1884. The funeral took place from the family residence on Saturday, at 2 p. m., the services being conducted by the Masonic order. Delegations of that order attended from Myrtle Point, Bandon and other places, as well as several pioneer citizens and personal friends from the county. A widow and one son, James C. Brown of Myrtle Point, survive him. He was 67 years old last January.

The special district school meeting to be held next Saturday afternoon is for the purpose of electing a school director for an unexpired term of nearly two years. It is important that the citizens should show where they stand in this matter, and be for the advancement of our school interests or against them, and elect a director for one side or the other having their support and backing. The conditions of the last few weeks have been greatly against the schools, tending to divide the community and fix upon us the petty quarrels that will destroy their usefulness and the best interests of our town, as has been done elsewhere in many cases. Think of it—for possibly you had not, heretofore—Coquille City, the county seat, in the center of a county without a peer in the state, a grand new schoolhouse advertising as abroad and made the instrument of inducing new citizens of means and enterprise to come and join with us to push the educational and moral interests to the van with our material and social growth, and yet we will have but two and one-half months of public free school in fourteen months to the present time, and possibly not till October next, when it will be twenty-one months! Think of it, we ask, and then decide if that splendid new school building on the hill is to stand idle most of the time each year, or be used for the best interests of the community. It is for you to decide this important question, and several others closely allied to it are depending upon it.

A Good Showing.

That there is a rapid increase in the shipping from this river is clearly shown by the fact that in the month of March a larger number of vessels cleared from this port than in any one previous month. There were 19 cargoes from the river during the month. The tug Triumph towed to sea 16 sailing vessels, and the steamer Townsend made three trips out. This is especially encouraging happening so early in the spring when business in all circles is supposed to be dull. The exports from the Coquille river for the month of March amounted to 4147 tons and consisted of lumber, coal, salmon, apples, potatoes, matchwood, broom-handles, hay, etc. The average depth of water on the bar at mean low tide was 6.48 feet.—Bandon Recorder.
