The Pioneers' Annual Reunion.

The Pioneer and Historical Society of Coos county, Oregon, convened at the Odd Fellows' hall in Marshfield, August 15, 1899.

The meeting was called to order by Judge J. H. Schroeder, who had been selected as president of the day by Mrs. E. M. Lockhart, the president of the society.

Mrs. Jackson, Mrs. Yoakam and Mrs. Lockhart, the first three white ladies who settled in Coos county, were escorted by Judge D. J. Lowe to the platform and seated, being surrounded by many prominent pioneers, among whom were John Hamlock, S. H. Hazard, Judge J. H. Schroeder, W. D. L. F. Smith and many others.

Rev. R. C. Lee offered an earnest prayer, and Mrs. E. M. Lockhart delivered an excellent address of welcome, referring very feelingly to the past, and compared the present improved condition as a wonderful advancement in progress and the social environments. After this, Dr. Toyo performed a beautiful solo upon the flute.

A very eloquent and interesting letter from Hon. B. Hermann was read, at the close of which he expressed great sorrow that he was unable to be present.

Hon. S. H. Hazard, the orator of the day, was then introduced by Judge Schroeder. Mr. Hazard's address was replete with logic and oratory, and deeply interested the large audience. The speaker complimented the pioneers for the heroism that enabled them to settle this beautiful country. He said, in part:

"It is right and proper that we assemble and honor the men and women who first settled in Coos county, for they made it what it is today. All counties in this state have thus endeavored to perpetuate the history of those 'early days,' believing that it will be of great interest to the coming generations, who will enjoy the blessings our country is so able to bestow. The future historian will find that these feeble efforts will furnish material for record that will be prized and numbered with the most interesting events of the great west."

"Particular credit is due to that little band who first settled at Empire City, on the romantic and picturesque banks of that beautiful sheet of water—Coos bay; for they, it was, who planted the first seeds of civilization, and every pioneer present should feel grateful that the three ladies who accompanied those heroes and shared the dangers of that day are with us on this happy occasion. And though their venerable locks are sprinkled with the frost of age, yet they are able to point back nearly a half century and tell us of the hardships and sufferings they endured when they helped to break down the first wild shrubbery that began yield to the white man's progress and give place to the more wholesome vegetation that was useful to civilization and lent comfort to humanity."

"I saw what the pioneers had done 25 years ago, when I first came, and I wondered at the achievements. I conversed with those who had commenced these great enterprises and found that they were great heroes, for they pushed onward, determined that the country of their choice should be made to yield the abundance that it seemed capable of doing. When they came they followed elk trails, but I came just as the Coos bay and Roseburg wagonroad was completed. I had stopped on the way at C. Howe's. He had a peculiar table, invented by himself, I suppose. By turning an upper platform the eatables would come around and the large, luscious strawberries that were brought in from me by that ingenious mechanism fairly astonished me, and I wondered at such products."

"When I arrived at a tributary of Coos bay I took a small boat and found after a long pull that excellent abode of comfort, Mrs. Lockhart's hotel."

Here the speaker referred to the mode of travel at that time; how the pioneers camped out in traveling from one place to the other—hence they took blankets and provisions. He described Marshfield as it appeared in 1873—its plank walks, and a mishap which the speaker had experienced in falling from a plank into the blue mud, finally being rescued; but he was uncharitably accused of being intoxicated, though he thought his reputation for sobriety had been good up to that time.

Judge Schroeder was the next speaker. After entertaining music had been discoursed, the judge held the audience in good humor for a few minutes with very entertaining and pleasing remarks. He referred to the excellent character and benevolence of the first settlers, and related how cordially the Baltimore colony, of which he was one, were received when they arrived under the leadership of Dr. Hermann, in 1859, saying that no one had door locks, but the latch string was always out. Roads were built without consulting the county court. Everyone belonged to the 400; they wore clothing suited to any fashion they wished. Each did as he or she pleased. They were outside of events that usually stir the world. He said: "I shall never forget the many kind acts bestowed upon us when we first arrived by those good people who had preceded us."
