CAUSED BY OFFICIAL NEGLIGENCE.

Woman Starved to Death on the Transport Tartar.

The death of Mrs. Collins, widow of Captain Charles L. Collins of the Twenty-third Infantry, was due directly to starvation and neglect while she was a passenger on the United States troopship Tartar.

"Mrs. Collins was starving, when she was brought to my house," said Mrs. James Brett last night. Mrs. Brett is the wife of Captain Brett, also of the Twenty-third Infantry, and is living in a pretty cottage at the Presidio while her husband, with his regiment, is fighting the Tagals in Luzon.

"Mrs. Collins had been a life-long friend of mine," Mrs. Brett went on, "and when I heard she was on board the Tartar I went to the ship on her arrival here and had her brought to my house. She died here ten days afterwards. I feared when I first saw her that death was upon her, although she rallied a little under proper care and with good nursing. But the mischief had been done long before she reached this country."

It was upon the action of the British authorities in detaining the transport that Secretary Root ordered the first investigation into the Tartar case. It was charged then that the officials interested had concealed the facts, and a second investigation was had, conducted like the first, in secret. The findings in both inquiries, as to the essential facts, have been kept from the public. Secrecy will not be so well served in this third inquiry, now being conducted by Major Gallagher and a board of officers at the Presidio, for the reason that the friends of Mrs. Collins, numerous and influential, propose that the blame for that unfortunate lady's death shall be placed where it belongs.

The Tartar was in command of Captain Pybos, for the owners, and the troops were commanded by Lieutenant-Colonel Wallace of the Twentieth Kansas Volunteers. She had on board, as passengers, General Frederick Funston and his wife, Mrs. Major Winans and the wife of Paymaster McCreery of the army, besides Mrs. Collins, who was ill in her room, and who never reached the deck unless she was carried there by Captain Pybos. The vessel had likewise, as stewardess, Mrs. J. C. Clay, of San Francisco.—Examiner.

Santa Fe Coming North.

San Francisco, Nov. 21.—The Examiner says: The Santa Fe railroad is reaching out for trade for the northern coast of California. It has recently bonded the Klamath railroad, the Belt Line about Eureka harbor and immense tracts of timber land.

Reports of British Victories Are Not Confirmed.

London, Nov. 21.—The latest direct news from Ladysmith, dated Thursday, November 16, and Friday, November 17, strangely conflicts with reiterated reports of tremendous battles and great British victories on Wednesday and Thursday. Neither of the messages above referred to, though dispatched on the days following the date of the alleged fight, mentioned any great fights or Boer defeats.

ASSEMBLYMEN JOIN BOERS. Cape Town, Nov. 21.—The Midland News says Messrs. Vanderbilt and Bober, members of the Cape assembly, have joined the Boers at Colesburg.

Hot on the Trail of Aguinaldo.

Manila, November 22.—General Young reports that Aguinaldo, with a party of 200, including some women and a few carts, passed Aringay, on the coast between San Fabian and San Fernando, in the province of Union, on Friday, November 17. The general adds that Aguinaldo probably intended to strike inland through the Binua mountains towards Bayambang in the province of Nueva Viseaya.

General Young with cavalry and Macabebe is pursuing the Filipino leader, part of the American force taking the direction of San Fernando. In the fight with Aguinaldo's rear guard at Aringay one Macabebe was wounded and the insurgents retreated. Their loss is unknown.

The Ohio Official Vote.

Columbus, Nov. 20.—The canvass of the official vote in Ohio was completed this afternoon. It shows Judge Nash's plurality is 49,023. The total vote cast was 908,105, divided as follows among the six candidates for governor: George K. Nash, Republican, 417,199; John H. McLean, Democrat, 368,176; Seth L. Ellis, Union Reform, 7,779; George M. Hamuel, Prohibition, 5,825; Robert Handlow, Socialist Labor, 2,489; Samuel M. Jones, Nonpartisan, 106,721.

"Coos Bay" Apples.

Quite a trade is being worked up between Portland and southern Oregon ports since the establishment of regular steamer services. The steamer Alliance, due today, brings a consignment of 5000 boxes of apples from Coos bay, indicating that there is something besides sawlogs grown in that section. The steamer also brings from the Oregon port 40 cords of matchwood and 20,000 broomhandles, and from Eureka she is bringing 200,000 feet of redwood. With former steamship lines there was always difficulty in securing northbound cargoes, but since the Alliance and Falton have been on the run they have generally carried full cargoes both ways.—Oregonian.

THE DEWEY HOME.

Transferred to the Admiral's Son by His Father and Stepmother.

Washington, Nov. 21.—George Goodwin Dewey, Admiral Dewey's only son, is now the owner of the residence presented to the admiral by the American people. Papers were signed today, by which Mrs. Dewey transferred all her rights and title to the property to George Goodwin Dewey.

This is the property which yesterday Admiral Dewey transferred to Mrs. Dewey. In explanation of the transfer, a representative of the Dewey family made this statement to the Associated Press:

"Admiral and Mrs. Dewey have transferred to the former's son the title to the home presented to the admiral by the people of this country. It will continue to be the home of the admiral and Mrs. Dewey so long as he may live. It was the wish of both Admiral and Mrs. Dewey, to provide for a proper succession to the property. The transfer of today is carrying out only the original intention of both Admiral and Mrs. Dewey. It was Mrs. Dewey's desire that she should release any claim she might have to the property through her marriage to the admiral, and to do this, the transfer was made through her to the admiral's son as soon as it was practicable. Through the method adopted, no dispute ever can arise over the disposition of the property."

Hon. H. E. Doseh, secretary of the state board of horticulture makes this mention in the Oregonian of the 24th inst. regarding the shipment of eastern fruit trees into this county that were diseased and pest infested, reference to which is made elsewhere in today's HERALD of the action of Inspector Wirth at Myrtle Point last week: "A shipment of young fruit trees was received last week in Coos county, from Ontario county, New York, and the trees on arriving at their destination were found to be infested although a certificate of the United States government inspector accompanied the invoice and guaranteed it 'free in all respects from contagious or infectious plant diseases.' Inspector Wirth, of Coos county, however, declared the apple trees infested with fungous, woolly aphid and green aphid; the peach trees were afflicted with the yellows, a most deadly disease; the quince trees were afflicted with borers, as were the young currant bushes, while the raspberries showed signs of fungus. The peach trees in the shipment were burned, and the rest of the shipment disinfected by dipping and fumigation."

Death of Mrs. Waddington.

The sad news reached us yesterday of the death of Mrs. W. H. Waddington, at her home at Lampey creek, yesterday morning, by suicide. Mrs. W. has been mentally afflicted for some years, but for some while past has been in fairly good health, attending to home duties intelligently, visiting our town and shopping as if all right. Another fit of mental aberration seized her a day or two past, and as her spells partook of a disposition to self injury, we learn that Sunday morning she took carbolic acid, resulting in her death soon after. We have not the particulars at first hands, but gleaned as best we could from reliable lower-river citizens. It is a severe blow to the surviving members of the family, who have the sincere sympathy of many friends in this hour of grief.

S. Wheeler arrived at this place this morning from upper Rogue River, near Grants Pass, with several cases of salmon eggs for Hume's hatchery on lower Rogue River. He came from Grants Pass via San Francisco and Coos bay with his charge.
