Ed. Herald: "Whom the gods would destroy they first make mad." Practical is in an ugly mood. It is annoying, to have sticks poked in ones wheel, I dare say. I might be moved to pity, but his futile efforts to set his "hobby" straight on its feet is so ludicrous! Practical will not take his quietus with becoming resignation.

In justice to "Common Sense" Mr. Editor, I cannot let Practical's seeming intentional misconstructions pass unchallenged. I crave once more your impartial indulgence through these columns to answer Practical's personal aspersions directed to my address which appeared in the Herald's last issue.

First, he ridicules my estimate in his contemplated bridge across the big Cunningham marsh. If he will look at my estimates with eyes not blurred by personal interest, he will see where it reads 180 bents and 90 intermediates, which at 16 feet distance from center to center on a length of 1425 feet would give 3 bents for every 16 feet. Now if he will look at any bridge of this width or more he will see 4 bents where I make only 3, thus I am still one bent under the mark in this favor. Then again he derides the idea of 810 stringers. Stringers are placed 2 feet apart which on a bridge of that width would line up 9 stringers to each set of bents, hence 810 stringers each 16 feet long.

If on this showing, Practical can prove "figures that lie" as he rudely insinuates, I will stake ten dollars to his one on the result. I am not bluffing.

Practical persistently taunts me for having named to parties 12,000, to 20,000 dollars and whatnot, as the probable cost of this new route. If I said thousands, and I think I did unwittingly in one or two instances, I should have said—and meant to say—hundreds, and that, as the cost of material only. But when an error is honorably atoned it should not move a fair minded opponent to make capital out of it. I hold myself responsible for all that I have published in the Herald—save printers' mistakes—and I stand by that—namely, a footing up of a total cost near or to three thousand dollars.

Again, with a sarcastic smile, he alludes to my 10x12 cabin that stands by the road he would have condemned—a far fetched connection to the subject matter—the dimension 10x12 is absolutely correct. Contrarily to his usual bad shots at dimensions he hits it this time right in the bulls' eye. I shall always be pleased to believe that the American eagle spreads his protecting wings over every cabin in the land quite as much as over every mansion. The animus of Practical's petition to the contrary notwithstanding. Practical's plaints anent my fence might disturb my peace of mind. That fence is unsteady on its legs. Practical himself built that fence. I paid him for it. It was from the beginning a flimsy affair much as his bridge would be were he to engineer the job on his estimates.

I will not consume space and time to refute all of Practical's misrepresentations. A few more words will suffice.

Practical would palm himself before a too credulous public as an exemplar of unselfishness. He brings forward the "even dozen families" for whom his bowels yearn with compassion and for whom the new route would be an inestimable boon—making the road to church a way of pleasantness, and to school, a merry go as you please; but he studiously avoids an utterance of good cheer for that other even dozen "for whom his scheme would depreciate their property from 10 to 25 per cent—whilst 50 per cent accrues to his own domain—closing virtually the now established route by reason of the removal of bridges, new in excellent condition, thus turning a public highway into a "Dead man's lane" to the Masonic cemetery, which, they, the disgraced, might keep in repair as best they could and at their own expense.

Now three of the "even dozen" whom this stupendous scheme disastrously affects have bought their homes direct from Practical. Let him, in imagination, I ask, put himself for a moment in their place, then let him tell candidly what he thinks of the other fellow—He, a model of disinterestedness that he is!
