Arid Land Reclaimed.

Helena, Mont., Oct. 11.—What seems to be a good beginning in the solution of the great arid land problem was made yesterday by the state of Montana. The State Arid Land Grant Commission, which was created by the legislature with power to reclaim lands donated to the state by the general government under the Carey act, celebrated the opening of the great canal system in district No. 4. There were present besides members of the commission and other state officials, members of the press, including a representative of the Associated Press, and many representative engineers and business men. The canal, intended to irrigate 33,000 acres of the Carey land, was opened and water sent on its mission of making homes for the small farmer. District No. 4 comprises 33,000 acres of splendid land in the beautiful Dearborn valley, in the northern portion of Lewis and Clark county, of which Helena is the county seat. The state proposes to sell this land in tracts of 160 acres to actual settlers at only the cost of placing water upon the land, giving 10 years for payment in 10 equal annual payments at 6 percent interest. Eleven thousand acres are now ready for settlement, and it is fair to say there is no more delightful spot in the Rocky mountain region. The picturesque main range of the Rockies skirts the western edge of the valley and abounds in grand scenery, fish and all kinds of game and timber, and the land lies in small valleys surrounded by lowlying hills that supply rich grass for stock.

The state is building the canal system and will own and operate it in perpetuity for the sole benefit of the occupants of the land, and without profit to any one, making the enterprise entirely co-operative in nature. This is the first irrigating canal on the American continent to be built and operated by a state government and undoubtedly marks an epoch in the great irrigation problem.

Mexico Wants the Canal.

Phoenix, Ariz., Oct. 10.—Joaquin Ciaz Prieto, who is closely in touch with the affairs of the government of Mexico, and was recently appointed consul at this point, commenting today upon the new phase of the Isthmian canal question, says that the commercial interests of Mexico are particularly anxious for the construction of the canal and the government is gratified over the probable abrogation of the Clayton-Bulwer treaty. Mexico would be pleased to see a neutral commercial canal constructed by this country alone. That republic is planning the rapid development of its western coast by opening sea ports and rich mining, agricultural and coffee lands. The completion of the Isthmian canal would be of tremendous commercial importance.

Government will Pay Ransom for Miss Stone.

Paris, Oct. 8.—A letter received by the Havas Agency from Salonica, dated Oct. 4, says: "The American consul here has just received orders to make the arrangements with the Vali (Governor) for the payment of the ransom of Miss Stone. The United States will advance the money, afterward settling with Turkey. "The Turkish authorities have made numerous arrests among the Bulgarian population, without distinction of religion, and nearly all have been put to torture in the hope of abstracting information. A prisoner named Dimitri said an understanding existed between the Protestants and the Macedonian committee, and that Miss Stone was even acting in concert with them with the view of obtaining funds for a political-religious propaganda. These declarations, wrung from Dimitri under torture, are valueless. What is certain is that the captain of the band designated for the payment of the ransom a place in proximity to the Roumanian frontier, which proves that he hopes to escape the Turkish police, and that the Bulgarian police do not cause him anxiety.

Artificial Wool.

Artificial wool made from turf fibers is now employed at Dusseldorf, Germany, for manufacturing cloth, bandages, hats, rugs and so forth. Ten years have elapsed since the first attempts to make turf wool, and it is averred that recent improvements in the production of a soft fibrous material, which can be spun or readily as sheep's wool, and which, besides possessing excellent absorbent properties, is capable of being bleached and colored for use in various textile industries.—Ex.

General News.

Clifton, Kan., Oct. 10.—At 6:30 tonight a cyclone passed two miles south of this city, doing considerable damage to buildings. The path of the storm was about 80 rods wide and everything was swept before it. Vague reports of casualties are coming in tonight, but owing to the intense darkness very little investigation can be made.

Dayton, O., Oct. 10.—Mrs. J. A. Witmer, a widow, residing in this city, has been arrested by the police at the instigation of the coroner and is held a prisoner at the central station pending an investigation into very serious charges. Mrs. Witmer, the police says, is suspected of 14 murders, the list including four husbands, five children, one sister and four members of different families in which she was employed as housekeeper.

Admiral Winfield S. Schley, who retired yesterday in compliance with law, having reached the age of 62, was appointed to the Naval Academy from Maryland, September 20, 1856. After his graduation from Annapolis he became a Master, August 31, 1861; a Lieutenant, July 16, 1862; Lieutenant Commander, July 25, 1866; Commander, June 10, 1874; Captain, March 31, 1888, and Commodore, February 6, 1898. At the close of the Spanish war, August 10, 1898, he was appointed Rear-Admiral.

Run Down by Freight Train.

Roseburg, Oct. 12.—S. R. Bristow, a railroad bridge carpenter, was struck by a locomotive near Glendale yesterday morning, causing his left leg to be badly crushed and shattered below the knee, and his right leg broken just below the knee. He had started from Glendale on his velocipede to his work, and when near tunnel No. 8 suddenly met an extra freight, in charge of Conductor Wilson. His recovery is deemed doubtful.

A very pretty wedding took place in the presence of about fifty guests at the residence of the bride's parents, Mr. and Mrs. W. H. Walker, in this city, Tuesday evening, Oct. 8, 1901, the contracting parties being Mr. Frank B. Tichenor of San Francisco and Miss Bertha Walker, nee J. S. Moore, of the M. E. church pronouncing the marriage rites. The house was brilliantly illuminated and the parlor was tastefully decorated with evergreens and flowers. The bride was attired in white silk and the groom wore the customary conventional black. Miss Lula Walker acted as bridesmaid and the groom was attended by James Guerin. After congratulations, all partook of elegant wedding lunch delicately served. The bride is the oldest daughter of Mr. and Mrs. W. H. Walker and is well known and has many friends while the groom is a well known young man. Their friends wish them much happiness as they journey through life together.—Enterprise.

Rome, Oct. 10.—Glavinovich, the anarchist arrested recently, a short time after his arrival from Dalmatia, he having been heard to threaten the lives of the Pope and of Cardinal Rampolla, Pontifical Secretary of State, has been sentenced to a fortnight's imprisonment for carrying deadly weapons, and then to be deported to his home in Dalmatia.
