## REPUBLICA CONVENTION.

Large Delegation present. Harmony Prevailed.

FULL TICKET NOMINATED.

Fight Conspicuous by Its Absence. All the Officers Nominated on First Ballot.

The republican county convention met at Marshfield March 26 pursuant to call. The meeting was called to order by County Judge Harlocker, and County Supt. W. H. Bunch was elected temporary chairman. Mr. Bunch's remarks accepting the honor and promising impartial decisions were received with applause. Mr. Ed Farrin was then elected temporary secretary and on motion the following committees were appointed:

On Credentials; Dr. Mings, S. E. Johnson and J. J. Clinkenbeard.

On order of business; Dr. Strange, W. U. Douglas, S. B. Herman, Fred Linegar and Peter Loggie.

After a short recess the committee on credentials reported all delegates present or represented by proxies except two. The report was accepted with an amendment authorizing Geo. Nichols to represent South Slough and C. E. Edwards, Allegany.

Committee on order of business reported by its chairman Dr. Strange, moving that the temporary officers of the convention be made permanent officers, which was seconded and carried. The report of said committee on order of business was then read and adopted.

The chairman declared nominations for sheriff in order and Dr. Kime of Bandon placed Stephen Gallier in nomination. J. W. Bennett, with a neat little speech, nominated Levi Smith, which was received with applause. Dr. Mings then addressed the convention seconding the nomination of Gallier and was greeted with enthusiasm. D. Morgan, of Fish Trap was then placed in nomination, and on motion, the nominations for this office closed. After the ballots were cast a motion was carried that no candidate should be declared elected without receiving a majority of all votes cast. A canvas of the ballot gave Gallier 90 votes, Smith 33 and Morgan 6. On motion of J. W. Bennett, on behalf of Levi Smith, the nomination of Mr. Gallier was declared unanimous by acclamation.

Nominations for County Clerk being declared in order, Judge Nosler placed in nomination A. D. Walcott. No other nominations being made, on motion, Mr. Walcott was declared by acclamation to be the choice of the convention.

Schiller B. Herman, denominated a "chip of the old block" in the nominating address by L. A. Roberts, was placed before the convention for representative. J. W. Bennett announced Col. R. H. Rosa as his choice for that position, and the balloting began, resulting in 82 for Herman and 51 for Rosa, and Hermann was declared the unanimous choice by acclamation.

L. Harlocker, being the only nominee for county judge, was chosen by acclamation, and D. McIntosh for county commissioner, and J. B. Dulle for treasurer, were chosen in a similar way.

For assessor, Geo. W. Beale and J. B. Snedden were named, the ballot giving Beale 105 and Snedden 24.

No one was surprised to hear the name of S. B. Cathcart placed before the convention for surveyor, as he has held this office many years without opposition. The Bandon delegation had a young aspirant who was named as their choice for this position, G. S. McCulloch, and they were loud in his praise. Th ballot, however, gave Cathcart 87 and McCulloch 41.

The nomination for coroner was then thrust upon Dr. Mings, by W. A. Toye, who kept Mings in his seat to prevent his declining until

the convention had made him their nominee.

Nominations for justices of the peace, constables and road supervisors were made by the delegates from the various districts and voting precincts. For the justice of the peace and constable district of Coquille E. G. D. Holden was nominated for justice of the peace and J. E. Perrot for constable. Al Flanders was nominated for road supervisor of Coquille road district.

For delegates to the state convention; Dr. Culin, J. H. Nosler, L. A. Roberts, L. W. Deyoe, L. J. Simpson, J. S. J. J., Dr. Fower, Robert Walker and J. W. Bennett were chosen.

A lively discussion was precipitated by the motion of Dr. Mings to instruct the delegates to the state convention for T. T. Geer for governor, and the motion was lost.

For chairman of the county central committee, J. W. Bennett and Dr. Mings were placed before the convention and a ballot gave Bennett 83 and Mings 38.

Mr. Bennett addressed the convention, thanking them for the honor reposed in him, enjoining the candidates nominated and urging all members of the party to support the nominees.

The central committee was authorized to fill any vacancies that might occur on the ticket.

**Bad Mess in Helena**

Helena, Mont., March 25.—Last night at 5:30 when the day police force were relieved from duty, every man of the force tendered to Chief of Police Travis his resignation, and at 9 this morning the entire night force followed suit, leaving the city without a single regular police officer on duty. The reason assigned by the retiring policemen was that they had been ordered by the Chief to take a leave of absence from the 5th to the 7th of April for the purpose of doing detective work in the interest of Mayor Frank Edwards, who is a candidate for re-election. Mayor Edwards denies that any such instructions were given to the police force. The Mayor promised that he would at once fill the vacancies, but up to 2 P. M. not a single police officer is on duty in Helena.

Edwards is a candidate for re-election and will go before the Republican city convention, to be held Friday night, and ask for the nomination. A strong faction of the party is endeavoring to secure the nomination of Dr. William Treney, and already the fight between the two factions has grown exceedingly bitter.

Hundreds of homeseekers are now rushing into the Pacific Northwest, and from the appearance of the vanguard of this Spring immigration the majority of the newcomers are here to wrest from nature's storehouse the wealth of the forests, mines, farms, fields and fisheries. Countless millions of this natural wealth are lying dormant awaiting only the application of labor and capital to transform it into the coin of the realm.

These latter-day immigrants will encounter no such obstacles as confronted the pioneers who blazed the trail in the '40s and '50s. The old guard enjoyed no homeseekers' rate to this new domain, and hunger, privation and the attacks of savage foes on the westward trip had a strong tendency to discourage a retreat. Isolated from the world's markets, with transportation facilities limited to the waterways provided by nature, and frequently surrounded by savage foes, the original homeseekers fought out the contest with nature and laid the foundation for a commonwealth.
